(Civil) No.202/1995 and as per the guidelines issued by the MoEF&CC vide letters No.5-1/1998-FC (pt-II) dated 18/09/2003 as well as letter No.5-2/2006-FC dated 03/10/2006 and 5-3/2007-FC dated 05/02/2009 and revision of NPV vide Ministry letter no. 5-3/2011-FC(Vol-1) dated 06/01/2022 in this regard.	3	The User Agency has already deposited an amount of Rs.1,12,060/- towards the cost of Net Present Value in the CAMPA fund.
4	All the funds (condition no. 2 & 3) received from the user agency under the project shall be transferred/ deposited in CAMPA fund only through e-portal.	4	Funds from the user agency has been transferred online to the CAMPA fund through e-portal.
