The CA will be maintained for 10 years. The scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years.		
3	The Net Present Value (NPV) for the forest area to be diverted under the proposal shall be deposited by the user agency as per the order of the Hon'ble Supreme Court of India dated 30/10/2002, 01/08/2003, 28/03/2008 and 09/05/2008 in IA-566 in W.P. (Civil) No.202/1995 and as per the guidelines issued by the MoEF&CC vide letters No.5-1/1998-FC (pt-II) dated 18/09/2003 as well as letter No.5-2/2006-FC dated 03/10/2006 and 5-3/2007-FC dated 05/02/2009 and revision of NPV vide Ministry letter no. 5-3/2011-FC(Vol-1) dated 06/01/2022 in this regard.	3	The User Agency has already deposited an amount of Rs. 3,59,551/- towards the cost of Net Present Value in the CAMPA fund.
