The undersigned is pleased to convey the formal approval of the Government under section 2 of the Forest (Conservation) Act, 1980, subject to the following conditions:-

- The permission is granted only for use of the forest land for the purpose specified in the proposal. The legal status of the forest land shall remain unchanged.
- 2. The forest land shall not be used for any purpose other than that specified in the FCA proposal.
- 3. The User Agency will have to obtain permission from this office for carrying out any maintenance works in future.
- 4. The User Agency will have to make good the forest land after use/maintenance work. No tree shall be cut.
- 5. The User Agency will be liable to make good any loss to Forests/Environment caused to use of the said land by the user agency.
- 6. The User Agency will seek permission from the Roads & Buildings Department /Science and Technology Department, Sachivalaya, Gandhinagar.
- 7. The gas pipeline will be laid underground in a trench of depth of 1.65 mtr and width of 0.45 mtr in between rows of road side plantation.
- 8. Any other condition, which the Nodal Officer (FCA) may stipulate from time to time.
