

I am directed to invite a reference to your letter No. FCA-1020/10-09/19/S.F-23/F dated 11/03/2020 on the above mentioned subject seeking prior approval of the Central Government under Section - 2 of the Forest (Conservation) Act, 1980.

The proposal was duly considered and approved by the Central Govt. for issuance of in-principle approval. Therefore, the undersigned, on behalf of the Central Government, conveys **In-Principle Approval (Stage-I)** for diversion of 2.00 ha Reserved Forest and Wildlife Sanctuary land for passing of 11KV line using Underground Cable with office space, RMU space and New transformer space for electrification of Rope way project situated near Ambaji Temple Girnar Hill at Junagadh Taluka Junagadh in District Junagadh in favour of Deputy Engineer (O&M), PGVCL, Gandhigram Sub-Dn, Junagadh subject to the following terms and conditions:-

Specific Conditions:

1. Legal status of the forest land shall remain unchanged.
2. Forest land shall be handed over to the user agency only after required non-forest land for the project is handed over by the user agency.
3. **Compensatory afforestation :**
 - a) Compensatory Afforestation shall be taken up by the Forest Department over **4.00 ha** degraded forest land at Compartment No. 589, Village-Khagesari, Taluka-Kutiyana, Distt-Porbandar, Gujarat at the cost of the User Agency. As far as possible, a mixture of local indigenous species shall be planted and monoculture of any species may be avoided.
 - b) Total No. of sapling to be planted shall be not less than 4,444 nos. (4.00 ha x 1111) in CA land. The composition of saplings (number of species-wise) to be planted in the CA land shall be as per National Forest Policy and as per CA scheme submitted vide Govt. of Gujarat letter No. FCA-1020/10-09/19/SF-23/F dated 11.03.2020 and record shall be kept.

2. Recommendation of the State Board for Wildlife, Gujarat circulated vide this office's letter no. WLP/28/A/1237-41 dated 08-01-2020
3. This Office's letter No: WLP/32/A/1265-66 dated 21-01-2020 submitting proposal to Forest & Environment Department, Government of Gujarat.
4. Forest and Environment Department, Government of Gujarat's letter No. VPS/102020/126/W dated 12-02-2020 to the Secretary MoEF&CC.
6. Recommendation of Standing Committee of National Board for Wildlife, circulated vide MoEF&CC, GoI's letter no. F.No. 6-2/2020 WL dated 20-04-2020
7. Hon'ble Supreme Court of India's Order dated 05-10-2015 in I.As filed in reference to Writ Petition (Civil) 202/95.

1. A proposal was received vide reference no. 1 above for use of 2.00 ha land in Girnar Sanctuary for lying of underground Electric line on Girnar hill by Deputy Executive Engineer, PGVCL, Junagadh
2. The proposal was placed before the State Board for Wildlife (SBWL) in its 18th meeting held on 12-12-2019 for consultation. The SBWL has approved and recommended the proposal in its meeting vide reference no. 2 above with certain conditions.
3. The proposal was sent to Forest and Environment Department, Government of Gujarat vide reference no. 3 above for onward submission to MoEF&CC, GoI. The said proposal was submitted to MoEF&CC, GoI for consideration of Standing Committee of National Board for Wildlife (NBWL) vide reference no. 4 above. The proposal was discussed in 57th meeting of the Standing Committee of NBWL held on 07-04-2020 and the Standing Committee of NBWL recommended the proposal vide reference no. 5 above in its meeting with certain conditions.
4. Hon'ble Supreme Court of India has passed an order dated 05-10-2015 in reference to different I.As in Writ Petition (Civil) 202/95 vide reference no. 6 above. The order of the Hon'ble Supreme Court of India is reproduced as under:



T-14



"All matters for grant of permissions for implementation of projects in areas falling in National parks/sanctuaries, including rationalization of boundaries etc. will be considered by the Standing Committee of the National Board for Wildlife ("NBWL") on its own merits and in conformity with the orders and directions passed by this Court from time to time, i.e. on 14.02.2000, 13.11.2000, 9.5.2002, 16.12.2002,, 25.11.2005 and 14.09.2007 and other subsequent clarificatory orders/judgment(s) passed by this Court including the Goa Foundation Judgment, i.e. Goa Foundation Vs. Union of India & Ors., reported in (2014) 6 SCC 590.

We request the NBWL to furnish a copy of the orders passed by it within 30 days' time to the C.E.C. The C.E.C. is at liberty, if, for any reason, they are aggrieved by the decision of the Standing Committee of NBWL to approach this Court by filing an appropriate petition/application.

In all those matters where there is already decision of the Standing Committee of the NBWL shall abide the parties with all the conditions imposed therein.

If any party is aggrieved by the decision of the Standing Committee of the NBWL, they are at liberty to approach an appropriate forum for appropriate relief(s).

With the aforesaid observations and directions, we dispose of the Interlocutory Applications/matters specified in Annexure-II to the note supplied by Shri Harish Salve, learned amicus curiae."

5. Therefore in view of the references mentioned and explained above, the permission is hereby granted to Deputy Executive Engineer, PGVCL, Junagadh for use 2.00 ha land for lying underground 11 kV Electric line of length 4 KM Bhavnath Taleti to Ambaji Temple falling within Girnar Wildlife Sanctuary subject to following conditions:


Conditions:

1. The User Agency shall not violate any regulatory provisions under Section - 9, 17 A, 27, 29, 30, 31 & 32 of Wildlife (Protection) Act, 1972.
2. The User agency shall not destroy wildlife habitat including fauna and flora of the Girnar Sanctuary.
3. The User Agency shall not use the area for the proposed work other than the area permitted.
4. The User Agency shall not establish any temporary or permanent labour camp in the Girnar Sanctuary.
5. The User Agency or his contractor shall not create any fire places inside the Girnar Sanctuary k.
6. All the material required for the work shall be prepared outside the Girnar Sanctuary.
7. Approval under Forest Conversation Act, 1980, if required, shall be obtained separately for use of forest land.
8. The User Agency shall deposit NPV for the use of land of Protected Area as per the existing rates.
9. The work in the Sanctuary will be allowed only in the day time from 8 AM to 6 PM.
10. The User Agency shall restore the land in its original form after completion of the work.



11. The User Agency shall lay the underground line if technically feasible. If not, User Agency shall lay over-head insulated 11 KV Electric line.
12. The User Agency shall prepare Wildlife Mitigation Plan. The User Agency shall start the work only after the approval of the Wildlife Mitigation Plan by the Chief Wildlife Warden and amount deposited as per approved plan.
13. The annual compliance certificate on the stipulated conditions should be submitted by the project proponent to the State Chief Wildlife Warden and an annual compliance certificate shall be submitted by the State Chief Wildlife Warden to Govt. of India.
