<b>A: Conditions which need to be complied prior to handing over of forest land by the State Forest Department.</b>			
1	The cost of compensatory afforestation at the prevailing wage rates as per compensatory afforestation scheme and the cost of survey, demarcation and erection of permanent pillars, if required on the CA land shall be deposited in advance with the Forest Department by the project authority. The CA will be maintained for 10 years. The scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years.	1	The User Agency has deposited an amount of Rs.87,15,999/- towards the cost of Compensatory Afforestation in the CAMPA fund.
2	The State Government shall charge the Net Present Value (NPV) for the 6.86 ha. forest area to be diverted under this proposal from the User Agency as per the orders of the Hon'ble Supreme Court of India dated 30.10.2002, 01.08.2003, 28.03.2008, 24/04/2008 and 09.05.2008 in IA No. 566 in WP (C) No. 202/1995 and as per the guidelines issued by the Ministry vide letters No. 5-1/1998-FC (Pt.11) dated 18.09.2003, as well as letter No. 5-2/2006-FC dated 03/10/2006 and 5-3/2007-FC dated 05/02/2009 and revision of NPV vide Ministry letter no. 5-3/2011-FC (Vol-1) dated 06/01/2022 in this regard.	2	The User Agency has already deposited an amount of Rs. 84,28,127/- towards the cost of Net Present Value in the CAMPA fund.
3	Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect.	3	The User Agency has already given the undertaking in this regard.
4	The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector.	4	FRA certificate of Collector, Bharuch is attached herewith.
5	The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officer.	5	The User Agency has agreed
6	The KML files of diverted and the CA areas shall be uploaded on the e-Green watch portal with all requisite details, before issuing working permission towards linear projects or submitting compliance report for seeking Stage-II approval, as the case may be.	6	The KML files of diverted and the CA areas are uploaded on the e-Green watch portal.
7	All the funds received from the user agency under the project shall be transferred/ deposited in CAMPA fund only through e-portal	7	Funds from the user agency has been transferred online to the CAMPA fund through e-portal.
