| 1. | The cost of compensatory afforestation at the prevailing wage rates as per compensatory afforestation scheme and the cost of survey, demarcation and erection of permanent pillars if required on the CA land shall be deposited in advance with the Forest Department by the Project Authority. The CA shall be maintained for 10 years. II) dated 18.09.2003, as well as letter No. 5-2/2006-FC dated 03/10/2006 and 5-3/2007-FC dated 05/02/2009 and revision of NPV vide Ministry letter No.5-3/2011-FC(Vol-1) dated 06.01.2022 in this regard. | The User Agency has already deposited an amount of Rs.56,29,176/- towards the cost of Net Present Value in the CAMPA fund. |
