Subject: Diversion of **16.37325 ha.** Protected Forest land for for road widening and strengthening four lane of Rajpipla to Poicha road Km.1/350 to Km.12/840 in Narmada District in favour of Executive Engineer, R&B Division, Rajpipla.

With reference to your letter F.No. 6-GJC022/2020-BHO dated 17.11.2020 on the subject cited above, it is informed that:-

1	Legal status of the diverted forest land shall remain unchanged.	The User Agency has Agreed
2	Forest land will be handed over to the User Agency only after required non-forest land for the project is handed over by the User Agency.	This project is linear diversion therefore Non Forest land is not required for this project.
3	Compensatory afforestation: a) Compensatory afforestation shall be taken up by the Forest Department over 33.00 ha. degraded forest land (Survey no.162, 159 pt., Village-Lambho, Taluka-Khanpur, District-Mahisagar). As far as possible, a mixture of local indigenous species shall be planted and monoculture of any species shall be avoided. FCA/31/A/527-28/2020-21, dated 19/10/2020 and record shall be kept.	Noted
	c) The standard size sapling (minimum height & minimum collar girth species wise) as approved by the State Govt. shall be planted in the selected CA land shall not be less than the specified in the CA scheme submitted by Govt. of Gujarat letter no. 	d) The height and collar girth (specie wise) shall be measured & recorded at the time of plantation and in November of plantation year. Further, data of height, collar girth and survival percentage (species wise) twice a year (April & November month) shall be recorded & records shall be maintained.	Noted
	e) The Sturdiness Quotient of the plants at the time of plantation shall not be more than 7. The Sturdiness Quotient= $\frac{\text{The height of plant (cm)}}{\text{The collar diameter (mm)}}$	Noted
	f) All the live stumps & pollards up to 90 cm Girth shall be dressed from ground level for the purpose of regeneration & record shall be kept in plantation journal.	Noted
	g) The CA Plantation shall be taken up before end of 2021 monsoon.	Noted and planned
4	The cost of compensatory afforestation at the prevailing wage rates as per compensatory afforestation scheme and the cost of survey, demarcation and erection of permanent pillars, if required on the CA land shall be deposited in advance with the Forest Department by the project authority. The CA will be maintained for 10 years. The scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years.
