Subject: Diversion of **1.639 ha.** Protected Forest land for the project of construction of two bridges on Mahuva-Anaval road at Chainage K.M. 20/0 to 20/4 across Ambika River and at Chainage K.M.17/0 to 17/2 across Olan Kahdai, Ta.Mahuva, District Surat in favour of Executive Engineer, Surat R&B Division No.2, Surat.

With reference to your letter F.No. 6-GJB 067/2020-BHO/ dated 26.02.2021 on the subject cited above and it is informed that:-

1	Legal status of the diverted forest land shall remain unchanged.	The User Agency has Agreed
2	Forest land will be handed over to the User Agency only after required non-forest land for the project is handed over by the User Agency.	This project is linear diversion therefore Non Forest land is not required for this project.
3	Compensatory afforestation: a) Compensatory afforestation shall be taken up by the Forest Department over 4.00 ha. degraded forest land Survey no.103 (576), Village-Kevdi Kund, Taluka-Mangrol, Dist-Surat. As far as possible, a mixture of local indigenous species shall be planted and monoculture of any species shall be avoided.	The User Agency has deposited an amount of Rs.23,04,000/- towards the cost of Compensatory Afforestation in the CAMPA fund.

	b) Total No. of saplings to be planted shall not be less than nos. 4,444 nos. (4.00 ha. x 1111) in CA land. The composition of saplings (number of species wise) to be planted in the CA land shall be as per the National Forest Policy and as per CA scheme submitted vide Govt. of Gujarat letter no. FCA-31/A/765-65/2020-21, dated 22/01/2021 and record shall be kept.	Noted
	c) The standard size sapling (minimum height & minimum collar girth species wise) as approved by the State Govt. shall be planted in the selected CA land shall not be less than the specified in the CA scheme submitted by Govt. of Gujarat letter no. FCA-31/A/765-65/2020-21, dated 22/01/2021 and record shall be planted in the selected CA land.	Noted
	d) The height and collar girth (specie wise) shall be measured & recorded at the time of plantation and in November of plantation year. Further, data of height, collar girth and survival percentage (species wise) twice a year (April & November month) shall be recorded & records shall be maintained.	Noted
	e) All the live stumps & pollards up to 90 cm Girth shall be dressed from ground level for the purpose of regeneration & record shall be kept in plantation journal.	Noted
	f) The CA Plantation shall be taken up before end of 2022 monsoon.	Noted and planned
4	The cost of compensatory afforestation at the prevailing wage rates as per compensatory afforestation scheme and the cost of survey, demarcation and erection of permanent pillars, if required on the CA land shall be deposited in advance with the Forest Department by the project authority. The CA will be maintained for 10 years. The scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years.	The User Agency has deposited an amount of Rs.23,04,000/- towards the cost of Compensatory Afforestation in the CAMPA fund.
5.	The User Agency shall deposit the amount Rs. 23,04,000/- for CA in the CAMPA.	The User Agency has deposited an amount of Rs. 23,04,000/- towards the cost of CA at the prevailing daily wage rates and Survey demarcation in the CAMPA fund.


6	NPV : a) The State Government shall charge the Net Present Value (NPV) for the 1.639 ha. forest area to be diverted under this proposal from the User Agency as per the orders of the Hon'ble Supreme Court of India dated 30.10.2002, 01.08.2003, 28.03.2008, 24/04/2008 and 09.05.2008 in IA No. 566 in WP (C) No. 202/1995 and as per the guidelines issued by the Ministry vide letters No. 5-1/1998-FC (Pt.11) dated 18.09.2003, as well as letter No. 5-2/2006-FC dated 03/10/2006 and 5-3/2007-FC dated 05/02/2009 and chapter 3 of FCA Handbook, 2019 in this regard.	The User Agency has already deposited an amount of Rs.7,17,882/- towards the cost of Net Present Value in the CAMPA fund.
	b) Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect.	The User Agency has already given the undertaking in this regard.
7	No trees shall be felled on the proposed forest land.	The User Agency has agreed
8	All the funds received from the user agency under the project shall be transferred/ deposited in CAMPA fund only through e-portal (https://pariveshnic.in).	Funds from the user agency has been transferred online to the CAMPA fund through e-portal.
9	The User Agency shall be eligible for the working permission of one year per the Para 11.2 of FCA Handbook, 2019 and copy of the working permission shall be submitted to this office.	The User Agency has Agreed
10	The State Govt. shall obtain the Stage-II approval in case of User Agency eligible for the working permission of one year as per the Para 11.2 of FCA Handbook 2019. If, the Stage-II approval is not obtained before the end of working permission, then the State shall stop the work and action shall be initiated under Para 1.21 (ii) of FCA Handbook 2019.	The User Agency has agreed

1	User Agency shall raise strip plantation on both sides and central verge of the road as per the IRC norms.	The User Agency has Agreed
2	Speed regulating signage will be erected along the road at regular intervals in the Protected areas/ Forest areas, if applicable.	The User Agency has agreed
3	User Agency shall provide suitable under pass/over pass for free movement of wildlife in and around the forest area in accordance to Eco friendly measures to mitigate impacts of linear infrastructure on wildlife (2016).	The User Agency has agreed
4	User Agency shall obtain Environmental Clearance as per the provisions of the Environmental (Protection) Act, 1986, if applicable.	Environmental Clearance is not required for this project.
5	The layout plan of the proposal shall not be changed without prior approval of Central Government.	The User Agency has agreed
6	No labour camp shall be establishment on the forest land.	The User Agency has agreed
7	Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourer after purchasing the same from the State Forest Department Corporation or any other legal source of alternate fuel.	The User Agency has agreed
