The CA shall be maintained for 10 years. 

| 2. | Compensatory afforestation shall be taken up by the Forest Department over 1.00 ha degraded forest land at Survey No.25 pt, Village-Vijaypur, Taluka-Lalpur, District-Jamnagar at the cost of user agency. As far as possible, a mixture of local native species shall be planted and monoculture of any species, especially non-native species should be avoided. | The User Agency has already deposited an amount of Rs.5,27,749/- towards the cost of Compensatory Afforestation in the CAMPA fund. |
