Kindly refer to your office letter No. 8B/HP/06/30/2018/FC/742 dated 11.07.2018 on the subject cited above.

2. The compliance to the stipulations as imposed in "in-principle" approval is submitted as below:

- i. The user agency has deposited the cost of Compensatory Afforestation scheme including 10 years maintenance for Rs.1342845/-including contingency charges in Adhoc CAMPA.
- ii. The user agency has deposited the cost of Penal CA scheme including 10 years maintenance for Rs.584338/-including contingency charges in Adhoc CAMPA.
- iii. The user agency has also deposited Rs.1843148/- towards NPV.
- iv. User agency has submitted the undertaking to pay the additional amount of NPV, if so determined, which is enclosed herewith.
- v. The user agency has deposited all the funds through online portal in Adhoc CAMPA vide online Application No. 6196800131 i.e. [CA Rs. 1342845/-+ PCA Rs. 584338/- NPV Rs. 1843148/- = Total Rs. 3770331/-] in the Corporation Bank Lodhi Complex Branch through NEFT vide UTR No. PUNBD18228007771 dated 16-08-2018.
- vi. User agency has submitted the undertaking to carryout strip plantation on both side of the road and on central verge of the alignment wherever possible at their own cost under the supervision of Forest Department which is enclosed herewith.
- vii. Necessary Mail has been sent to NIC cell, New Delhi to upload the correct employment details at para E (ii) in online portal.
- viii. Necessary Mail has been sent to NIC cell, New Delhi to correct the area proposed for diversion under each village as per VLC proceeding submitted with FRA certificate in online portal.

It is therefore requested that necessary stage-II approval to the proposal may kindly be accorded in favour of user agency, at the earliest please.
