Degree College, Sihunta within the jurisdiction of Dalhousie Forest Division, District Chamba, Himachal Pradesh (Online proposal no. FP/HP/SCH/21873/2016)- regarding.**

Sir,

Kindly refer to your office letter No 8B/HP/09/30/2017 dated 31.07.2024 on the subject cited above vide which Stage-I approval has been accorded to the subject cited proposal.

2. The point-wise reply to the stipulations as stipulated in Stage-I approval is submitted as below:-

- i. Legal status of the diverted forest land will be remained unchanged. Undertaking from UA duly signed by DFO concerned is attached with the compliance report of Stage-I of User Agency.
- ii. The Compensatory afforestation over degraded forest land, double in extent to the forest land being diverted (3.1 ha. Degraded forest land in Survey No. 52D/3/SW, Khasra No. 119/2, 137 in Mohal Balu, Man Massi DPF, Bhattiyat Forest Range, Dalhousie Forest Division, Distt. Chamba) shall be raised by the at the project cost within two years from the date of grant of Stage- II approval; an undertaking in this regard is attached with the compliance report of Stage-I.
- iii. The cost of compensatory afforestation amount to Rs. 15090750/- at the prevailing wage rates as per compensatory afforestation with 10 year maintainance scheme and the cost of survey, demarcation and erection of permanent pillars, if required on the CA land, has been deposited by the user agency.
- iv. The land identified for the purpose of CA shall be clearly depicted on a Survey of India topo sheet of 1:50,000 scale has been marked and enclosed with the compliance report of Stage-I.
- v. The user agency has given an undertaking with the compliance report of Stage-I that the minimum number of trees will be felled in the project and the blank areas shall be enriched and maintained as green patches.
- vi. Land use plan shall not be changed and no diversion of forest land will be

allowed for any further expansion of this project work; an undertaking in this regard is attached with the compliance report of Stage-I.

- vii.** All measures and required permissions for the safety of the proposed building/infrastructure from seismic activity and any other natural exigencies; an undertaking in this regard is attached with the compliance report of Stage-I.
- viii.** No muck and debris disposal will be allowed in the forest area; an undertaking in this regard is attached with the compliance report of Stage-I.
- ix.** The tree felling shall be done only in built up area and bare minimum felling shall be permitted in other non-built up areas. Felling of trees before the start of construction should be verified by the concerned DFO; an undertaking duly signed by DFO concerned in this regard is attached with the compliance report of Stage-I.
- x.** The KML files of diverted area and the CA areas has been uploaded on the e- Green watch portal with all requisite details prior to Stage II approval; an certificate of DFO concerned is attached with the compliance report of Stage-I.
- xi.** The User Agency has deposited an amount of Rs. 1537800/- towards the cost of Net Present Value (NPV) of the forest land being diverted under this proposal in accordance with the MoEF&CC's guidelines dated 6.01.2022.
- xii.** The user agency has submitted an undertaking that the additional amount of NPV, if so determined, as per the final decision of the Hon'ble Supreme Court of India shall be paid, undertaking in this regard is attached with the compliance report of Stage-I.
- xiii.** The user agency has deposited the CA levies through E-challan.
- xiv.** The user agency has submitted an undertaking that complete settlement of rights, in term of the Scheduled Tribes and Traditional Forest Dwellers (Recognition of Forests (Rights) Act, 2006. The copy of undertaking is attached with the compliance report of Stage-I.
- xv.** The complete compliance report is uploaded on PARIVESH Portal.
- xvi.** Trees shall be felled in phased manner as per the requirement in the approved Plan with prior permission of concerned DFO; an undertaking duly signed by DFO concerned in this regard is attached with the compliance report of Stage-I.
- xvii.** The cost of felling of trees shall be deposited by the User Agency with the State Forest Department; an undertaking duly signed by DFO concerned in this regard is attached with the compliance report of Stage-I.
- xviii.** The user agency has given an undertaking duly signed by DFO that user agency will explore the possibility of translocation of maximum number of trees identified to be felled and shall ensure that any tree felling shall be done only when it is unavoidable and that too under strict supervision of the State Forest Department.
- xix.** The User Agency has given an undertaking with the compliance of Stage-I approval that the they will obtain the Environment Clearance under the Environment Impact Assessment Notification, 2006 issued under the Environmental (Protection) Act, 1986 if required.

- xx.** The User Agency has given an undertaking with the compliance of Stage-I approval that no. labour camp shall be established on the forest land and the User Agency shall provide fuels preferably alternate fuels to the laborers and the staff working at the site so as to avoid any damage and pressure on the nearby forest areas.
- xxi.** No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work; an undertaking in this regard is attached with the compliance report of Stage-I.
- xxii.** The boundary of the diverted forest land shall be demarcated on ground at the project cost, by erecting four feet high wall/RCC-pillars; an undertaking in this regard is attached with the compliance report of Stage-I.
- xxiii.** The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life, whichever is less; an undertaking of user agency in this regard is attached with the compliance report of Stage-I.
- xxiv.** The forest land proposed to be diverted shall under no circumstances be transferred to any other agency, department or person without prior approval of the Central Government; an undertaking of user agency in this regard is attached with the compliance report of Stage-I.
- xxv.** No damage to the flora and fauna of the adjoining area shall be caused; an undertaking of user agency in this regard is attached with the compliance report of Stage-I.
- xxvi.** The Divisional Forest Officer and user agency has given undertaking with the compliance of Stage-I approval that DFO will monitor and take necessary mitigation measures to ensure that there is no adverse impact on the forests in the surrounding area.
- xxvii.** The User Agency has submitted an undertaking with the compliance of Stage-I approval that the shall submit the annual self -compliance report in respect of the above stated conditions to the State Government, Regional Office and to this Ministry by the end of March every year regularly.
- xxviii.** The User Agency has submitted an undertaking with the compliance of Stage-I approval that any other condition that the Ministry of Environment, Forests & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife shall be carried with by the State Government and user agency.
- xxix.** The user agency has submitted an undertaking with the compliance of Stage-I approval that they shall comply all the provisions of the all Acts, Rules, Regulations, Guidelines, Hon'ble Court Order (s) and NGT Order (s) pertaining to this project, if any, for the time being in force, as applicable to the project.
- xxx.** The User Agency has submitted an undertaking with the compliance of Stage-I approval that violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as prescribed in para 1.16 of Chapter 1 of the Handbook of comprehensive guidelines of Forest (Conservation) Act, 1980 as issued by this Ministry's letter No.5-2/2017-FC dated 29.12.2023.

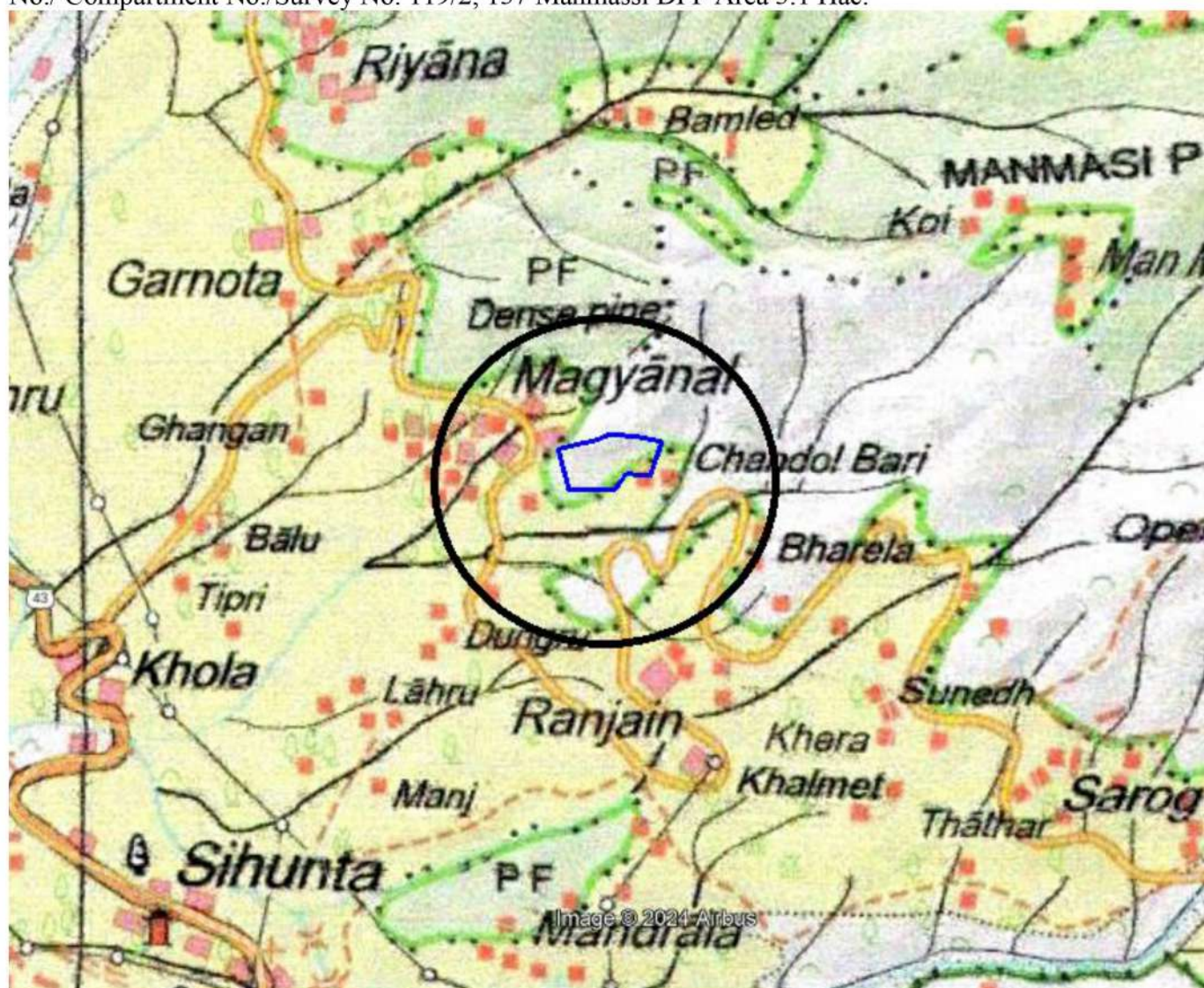
