### UNDERTAKING

I Shashank D Sharma, Authorized Signatory for Bharat Petroleum Corporation Ltd. Ambala hereby undertake that

1. We shall not change the legal status of diverted forest land.
2. We shall pay additional NPV amount if charges are increased in future.
3. We shall again obtain the Environmental Clearance as per the provision of the Environmental (Protection) Act 1986 if required.
4. The boundary of the diverted forest land shall be demarcated on ground at the project cost by erecting four feet high reinforced concrete pillars, each described with its serial number forward and back bearing and distance from pillar to pillar.
5. If required we undertake comprehensive soil conservation measures in the area being diverted at the project cost in consultation with the State Forest Department.
6. We shall not establish any labour camp on the forest land.
7. We shall provide alternate fuels to the labourers and the staff working at site so as to avoid any damage and pressure on the nearby forest area.
8. We shall not use forest land for any purpose other than that specified in the proposal.
9. We shall not make any changes in the layout plan without the permission of Central Government
10. The diverted land shall not be transferred to any agency/ department/ other person without the permission of Central Government.



11. No damage to the flora and fauna of the adjoin area shall be caused.
12. Any tree felling shall be done only when it is unavoidable and that too under strict supervision of the State Forest Department.
13. We shall create and maintain alternate habitat/home for the avifauna , whose nesting trees are to be cleared in this project . Bird's nest artificially made out of eco-friendly material shall be used in the area , including forest area and human settlement adjoining the forest area being diverted for the project.
14. We shall submit six monthly self-compliance report as on 1<sup>st</sup> January and 1<sup>st</sup> July of every year to your office as well as to Nodal office of the State.
15. We have no objection in conditions laid by Regional Office for protection and development of forest life and wild animals.
16. We shall ensure compliance to provision of all Acts, Rules, Regulations and Guidelines for the time being in force as applicable to the project.
17. We shall do plantation in Entry / Exit and Separator Island and Separator Island shall not be used for any commercial use.
18. We shall do plantation on either side of the road and central verge at project cost as per IRC specifications with maintenance of 7-10 years . We shall submit design of providing 2-3 rows of long rotation indigenous trees , as per provision of IRC-SP-21—2009(Guidelines on landscaping & tree plantation) on either side of the road before the final clearance.
19. Overburden shall not be dumped outside the width of the road. The muck generated in the earth cutting will be disposed of at the designated dump site.
20. We shall provide retaining walls, breast walls and drainage as per requirements to provide the suitable slope.
