





2A.

1. That we have deposited the CA and NPV charges amount by generating online challan vide application no. TRANS64142899263 dated 21.12.2023
2. That the no other proposal is pending for compliance of stage-1 conditions.
3. If found violation of any conditions, Forest department will take action under FCA, 1980 as per MoEFCC guideline Chapter1 para 1.21.

B.

1. That Legal status of the forest land will remain unchanged.
2. That the number of trees/plants will be felled not exceed shown in the proposal i.e. 218 trees and 94 Plants.
3. That Compensatory afforestation & ACA will be carried out over 2.368 hectares of forest land at Sareli Bund, Nangal Chaudhary Range in district Mahendergarh. CA & ACA work will be completed by Forest Department within one year from the date of issue of final approval, as per amount received from User Agency.
4. That the forest land shall not be used for any purpose other than that specified in the proposal.
5. That we will not damage to any adjoining Forest and Forest land. All the efforts will be used to save adjoining forest and Forest land.
6. That we shall pay additional amount of NPV as and when increased on the decision of the Hon'ble Supreme Court of India.
7. That we will not transfer the forest land to any Agency, Person and Department in any circumstances without the prior permission of the MoEFCC.
8. That Layout plan of proposal will not be changed without the prior permission of Central Govt.
9. That the Laborer camp will not be organized on Forest Land.
10. That the maximum width "Right of Way" of transmission line will 27M on forest land.
11. That to fix tension stringing device under each conductor 3m wide strip path will be allow but completion of stringing work natural sustenance will be start.
12. That the gap of conductor and trees will be minimum 4.0M. for electric supply as and when need trees lopping and felling take permission from local divisional forest officer.
13. That to protect wild animals from electric current, necessary ground clearance, establish of sufficient circuit breaker will be done by user agency.
14. That save birds from conflict of electric wire user agency will use decent bird deflector on his own cost.



15. That the user agency will prepare detailed plan along with state forest department for planting and maintenance of small size and medicinal plants. User agency will provide money to state forest department.
16. That the User Agency will provide all facilities to laborer to save damage the adjoining forest.
17. Muck disposal should be taken up as per the scheme approved by the Forest Department.
18. That the User Agency will take Environment Clearance if required under EPA 1986.
19. That the transferred land boundary will be landmark by 4 feet high boundary pillars by user agency.
20. That we will abide to compliance/guidelines time to time issued by Regional Office for Protect Forest, Wild animals' conservation and Development.
21. That we ensure compliance to the provisions of all the Acts, Rules, Regulations and Guidelines.
