महाशय,

उपर्युक्त विषयक संबंध में सूचित करना है कि भारत सरकार, पर्यावरण, वन एवं जलवायु परिवर्तन मंत्रालय, नई दिल्ली के प्रासंगिक पत्र-1 द्वारा एन०टी०पी०सी० लिमिटेड के पकरी बरवाडीह उत्तरी पश्चिमी कोल माईनिंग खनन परियोजना हेतु 331.198 हेतु वनभूमि अपयोजन प्रस्ताव में स्टेज-I की स्वीकृति 32 शर्तों के साथ प्रदान की गयी है, जिसका अनुपालन प्रतिवेदन क्षेत्रीय मुख्य वन संरक्षक, हजारीबाग के पत्रांक 120 दिनांक 12.01.2024 द्वारा प्राप्त हुआ था। उक्त स्टेज-I के अनुपालन प्रतिवेदन में कतिपय बिन्दुओं पर कमियाँ रहने के कारण इस कार्यालय के पत्रांक 101 दिनांक 01.02.2024 द्वारा पृच्छा की गयी। इस संबंध में क्षेत्रीय मुख्य वन संरक्षक, हजारीबाग के पत्रांक 587 दिनांक 28.03.2024 द्वारा निराकरण प्रतिवेदन समर्पित किया गया, जिसे अपूर्ण रहने के कारण पुनः इस कार्यालय के पत्रांक 343 दिनांक 12.04.2024 द्वारा पृच्छा की गयी। क्षेत्रीय मुख्य वन संरक्षक, हजारीबाग के पत्रांक 2080 दिनांक 29.11.2024 (छायाप्रति संलग्न) द्वारा विषयगत वनभूमि अपयोजन प्रस्ताव में पृच्छा का निराकरण सहित स्टेज-I के 32 शर्तों का बिन्दुवार संशोधित अनुपालन प्रतिवेदन पाँच प्रतियों में इस कार्यालय को समर्पित किया गया है।




