उपर्युक्त विषयक संदर्भ में सूचित करना है कि भारत सरकार, पर्यावरण, वन एवं जलवायु परिवर्तन मंत्रालय, नई दिल्ली के प्रासंगिक पत्र-1 द्वारा सी0सी0एल0 के के0डी0एच0 खुली खदान परियोजना हेतु 126.72 हे0 वनभूमि अपयोजन प्रस्ताव में स्टेज-I की स्वीकृति कुल 32 शर्तों के साथ प्रदान की गयी है। उक्त स्टेज-I की स्वीकृति में लगाये गये शर्तों का बिन्दुवार अनुपालन प्रतिवेदन क्षेत्रीय मुख्य वन संरक्षक, राँची के पत्रांक 1239 दिनांक 02.08.2024 द्वारा प्राप्त हुआ था। स्टेज-I के कतिपय शर्तों का अनुपालन अपूर्ण रहने के कारण इस कार्यालय के पत्रांक 741 दिनांक 13.08.2024 द्वारा पृच्छा की गयी, जिसका अनुपालन प्रतिवेदन अपर प्रधान मुख्य वन संरक्षक, राँची रीजन, राँची के पत्रांक 208 दिनांक 25.02.2025 एवं 434 दिनांक 27.03.2025 (छायाप्रति संलग्न) द्वारा प्राप्त हुआ है।

अपर प्रधान मुख्य वन संरक्षक, राँची रीजन, राँची से प्राप्त प्रतिवेदनानुसार विषयगत परियोजना के स्टेज-I का अनुपालन की स्थिति निम्नवत् प्रतिवेदित किया जाता है :-
