In compliance with the Ministry of Environment and Forest (MoEF), Govt of India's letter no. 11-9/98-FC (pT) Dt:- 3rd Aug 2009, wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act 2006, (FRA for short) on the Forest Land proposed to be diverted for Non Forest purposes read with MoEF's letter Dt:- 5th Feb 2013, wherein, MoEF issued certain exemption/ relaxation in respect of linear projects. It is certified that Forest land (0.8177 Hactare - details as annexure B) falling in Block Palmar, Dachhan and Marwah under the proposed alignment of fiber path (Bhandarkoot to Qaderna) in favour of Jio Digital Fiber Ltd, required for the development of Tele- communication network by laying of optical Fiber cable in District Kishtwar Kishtwar (Bhandarkoot- Qaderna) to provide seamless 4G connectivity.

It is further certified that:

- (a) The complete process of recognition and vesting of forest rights under the FRA has been carried out for the Block Dachhan and Marwah of forest land proposed for diversion. The proposed area does not cover any part of the FRA-2006, since there is no any claim in this area as on date. 
