4. That the compensatory levies (CA cost, NPV etc.) are deposited through challan generated online on web portal and deposited in appropriate bank only. Amount deposited through other mode will not be accepted as compliance of the Stage-I clearance.
5. The work shall not commence until entire compensatory levies are deposited by the User Agency and confirmed online on Ministry's web portal.
6. That the User Agency will pay the extraction cost of the trees, firewood, marking, enumeration etc. in accordance with rules.
7. That no violation shall be done and any violation of any these conditions will amount to violation of Forest (Conservation) Act, 1980 and action will be taken as prescribed in Para 1.21 of Chapter 1 of the Handbook of Guidelines of Forest (Conservation) Act, 1980 as issued by this Ministry's letter no 5-2/2017- FC dated 28/03/2019.
8. That the work shall commence only after FRA Certificate from competent Authority is to be submitted.
9. That the legal status of the forest land will remain unchanged;
10. That minimum number of trees and in any case, shall be felled as not more than the approved no.s.
11. That no muck will be dumped in the forest land as the muck dumping sites have been identified on non-forest land.
12. That user agency shall not dump muck on forest land;

13. That the forest land will not be used for any other purpose than that mentioned in the proposal;
14. That the forest land proposed to be diverted shall under no circumstances be transferred to any other agency, department, or person without approval of the Ministry of Environment, Forest & Climate Change;
15. That the layout plan of the proposal shall not be changed without the prior approval of the Ministry of Environment, Forest & Climate Change;
16. That the user agency shall raise strip plantation on both sides and central verge of the road at the project cost as per IRC specifications with maintenance of seven to ten years;
17. That no damage will be done to the adjoining forest land;
18. That no labour camp shall be established on the forest land;
19. That the user agency shall pay additional amount of NPV as and when increased on the order of Hon'ble Supreme Court;
20. That the User Agency shall provide firewood preferably alternate fuels to the labourers and the staff working at the site so as to avoid any damage and pressure on the nearby forest areas;
21. That the User Agency shall implement any other condition that IRO/J&K Govt./Forest Department may stipulate, from time to time, in the interest of conservation, protection and development of forests & wildlife;
22. That the User Agency will be the User Agency shall be responsibility to obtain all other prior approvals/clearances under all other relevant Acts/Rules/ Court's Rulings/instructions, etc., including environmental clearance, as applicable to this proposal


