In continuation to this office letter No. referred above, it is submitted that the proposal for diversion of Forest land of 3.2549356 Ha for **CONSTRUCTION AND UPGRADATION OF ROAD FROM DESIGN CHAINAGE 31.449 (KHELLANI, PARIYOT) TO KM 51.700 (PREM NAGAR) (DESIGN LENGTH 20.251 KM.) IN THE UNION TERRITORY OF JAMMU AND KASHMIR PACKAGE-I OF NH-244** has been accorded the Stage-I Approval vide above referred Government file No. dated 10-03-2022. In this regard, vide this office letter No. DFO/Bhad/5915-17 date 15-07-2023 the user agency asked to comply with the terms and conditions laid out in the Stage-I Approval. Compliance by the user agency is as under:

1. The proposal No. (FP/JK/ROAD/146187/2021) in the subject project had been accorded the stage-I approval by RO. MoEF vide referenced letter (i). Accordingly, a demand note of **Rs. 41,01,347.00** for payment towards applicable levies through challan generated from the PARIVESH Portal after acceptance from Nodal officer was deposited through challan by NHIDCL (copy of challan enclosed). The deposited amount has been realized and reflected on the PARIVESH Portal (copy of proof attached).
2. DC Doda vide letter 615/SQ dated 20.06.2022 has submitted the FRA certificate for the subject (copy enclosed). The para wise compliance of the conditions by the user agency as per Para 2 (A) of the RO, MoEF letter dated 10.03.2022 are as follows:


In view of the above facts, it is submitted that the terms and conditions laid down in above referred Govt. Sanction for processing of Stage-II and the requisite documents on part of user agency i.e General Manager NHIDCL PMU Doda has been compiled as mentioned in S.No.1. **The user agency has violated the Forest Conservation Act 1980 by throwing muck/debris on unidentified dumping sites (forest land) and damaged forest land/trees/poles/saplings including fauna/flora.** Accordingly, damage bill was issued to the user agency vide I.R Bill No. 07 of 2022-23 dated. 04-01-2023 under endstt. No. DFO/Bhad/FCA/5026-30 dated. 04-01-2023 to the tune of Rs. 6744563.00 and Bill No. 10 of 2023-24 dated 26-02-2024 under endstt no. 5941-47/DFO/BHD dated 26-02-2024 to the tune of Rs. 1563854.00. However, the I.R Bill No. 07 of 2022-23 dated 04-01-2023 was revised vide instructions given by Ministry of Environment, Forest and Climate Change through DIGF Central, Sub-Office Jammu amounting to Rs. 1,07,65,403/- vide this office letter No. DFO/Bhad/FCA/583-89 dated. 28-04-2025. Thus the total amount to be paid by User Agency was (i) Rs. 1,07,65,403/- + (ii) Rs. 15,63,854/- = Rs. 1,23,29,257/- (Rupees one crore twenty three lakh twenty nine thousand two hundred fifty seven only)

In this regard, it is submitted that the User Agency has intimated this office vide letter No. NHIDCL/PMU-DODA/KK-I-II/2026/8005 dated 06.01.2025 that damage amount to the tune of **Rs.1,23,29,257/-** has been deposited into the CAMPA fund vide **UTR No. CNR8R52026010574175440 dated. 05.01.2026** and has requested to process the forest diversion of 3.254 Ha area of the aforesaid project and provide stage-2<sup>nd</sup> approval at the earliest.

Hence submitted with the remarks to accord Stage 2<sup>nd</sup> Approval to the User Agency for the aforementioned project after verifying the damage amount deposited by them into the CAMPA fund vide **UTR No. CNR8R52026010574175440 dated. 05.01.2026** amounting to **Rs. 1,23,29,257/-** please.



Sir,

Kindly refer to the online proposal of Government of Jammu & Kashmir on the above-mentioned subject seeking prior approval of the Central Government for diversion of 3.2549356 ha of forest land for non-forestry purpose in accordance with section 2 of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980. In the instant case, violation has been committed while granting approval under the Van (Sanrakshan Evam Samvardhan) Adhiniyam. Hence, in view of para 1.16 (iii), the proposal was placed before 76th REC meeting of the RO, Chandigarh held on 28th March, 2025 for consideration.

2. After due deliberation, the REC directed following:

(i) The User agency needs to deposit the penalty for land breaking as imposed by the UT Government in view of the relevant UT Government Act/Rules. In addition, the REC imposed penalty for violation committed over forest area without approval equal to twice the normal NPV as per para 1.16 (iii) of the Consolidated Guidelines and Clarifications issued under the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 and Van (Sanrakshan Evam Samvardhan) Rules, 2023.

3. The compliance to the above may be submitted within 30 days from the date of issue of this letter failing which the proposal shall be liable to be rejected for want of compliance.
