

In compliance with the Ministry of Environment and Forest (MoEF), Government of India's letter No. 11-9/98-Fc (pt) dated 3<sup>rd</sup> August 2009 wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Right) Act, 2006 (FRA, for short) on the Forest land proposed to be diverted for Non Forest purposes read with MoEF's letter dated 5<sup>th</sup> January 2013 wherein MoEF issued certain exemption/relaxation in respect of linear projects, it is certified that 0.349 hectares of Forest land is proposed to be diverted in favour of NHIDCL situated in Village Ambaran, Tehsil Akhnoor of District Jammu.
