

With reference to the above subject, in ref (1) Government of India has accorded in "In-Principle" (Stage-I) approval under Section 2 of the Forest (Conservation) Act, 1980 for the diversion of 0.54 ha. of forest land in Sy.No. 263, Alagilawada village, Sy.No. 381, Kadathi village and Sy.No. 202, Teligi village, Harapanahalli Taluk, Davanagere District for laying of Irrigation pipeline to fill the 60 tanks from Tungabhadra River in favour of the Executive Engineer, Karnataka Neeravari Nigam Limited (KNNL), Bhadra Canal Division, Davanagere, subjected to certain conditions stipulated therein. The user Agency has now submitted its compliance report in ref (2), which has been verified by RFO, Harpanahalli and ACF, Kudligi.

The original proposal was being dealt by the Davangere division. Now that Harapanahalli Taluk has been transferred to the newly formed Vijayanagara District, this office is sending the verified compliance report. Hence we are herewith submitting the Condition-wise Compliance Report and connected documents for compliance to the conditions stipulated in Stage-I clearance.
