The Government of India vide Ref (1) have accorded 'in-principle' (Stage-I) approval for diversion of 4.6038 hectares of forest land in Sy No. 10 Wadnahalli Village (0.9664 ha) and Sy No. 163 Yargala Village (3.6374 ha), Hatthakuni Hobli, Yadgir Taluk & District for widening to two/four lane with paved shoulders from Chittapur Cross to Yadgir Bypass (CH. 34.000 to CH. 70.900) of National Highway NH-150 (Gulbarga-Wadi-Yadgir Section) in

favour of Executive Engineer (National Highway Division), Public Works, Ports & Inland Water Transport Department, Kalaburgi, subject to fulfillment of certain conditions stipulated therein.

Based on Stage-I approval for the project, the Government of Karnataka vide Ref (2) has directed to submit the Compliance Report in respect of conditions of Stage-I approval.

Accordingly, this office vide Ref (3) has informed the User Agency and Field officers to submit the compliance report of in respect of the conditions of Stage-I approval.

In response, the User Agency vide Ref (4) has submitted the compliance report to the Deputy Conservator of Forests, Yadgiri Division, who after verification has, vide Ref (5), submitted the condition-wise Compliance Report to the Chief Conservator of Forests Kalburgi Circle, who has further submitted the same vide Ref (6) to this office.

Based on the reports received as above, the status of compliance to the conditions of Stage-I approval is as under.
