The Government of India vide ref (1) have accorded 'in-principle' (Stage-I) approval for diversion of 1.33 hectare of forest land in near Adkoli Cross in F. Sy. No.54A of Kansur village of Siddapur Taluk, Uttara Kannada District for establishing

1x10 MVA, 110/1 KV Substation along with construction of 110 KV LILO line from Jog-Sirsi DC line in favour of the Executive Engineer (Electrical), Major Works Division, KPTCL Uttara Kannada District at Vidyut Nagar, Hubballi subject to fulfillment of certain conditions.

The same was forwarded to this office by the Government of Karnataka vide ref (2) with a direction to submit the compliance report of conditions of Stage-I approval.

Accordingly, this office vide ref (3) informed the User Agency and field officers for further action to submit the compliance report in respect of the conditions of Stage-I approval.

In response, the User Agency vide ref (4) has submitted the condition-wise compliance report to the Deputy Conservator of Forests, Sirsi Division, who after verification have vide ref (5) submitted the condition wise compliance to the Conservator of Forests, Kanara Circle, Sirsi who has further submitted the same to this office vide ref (6).
