With reference to the above subject, the Government of India vide Ref (1) has accorded 'in-principle' (Stage-I approval) under Section 2 of VSES Adhiniyam 1980 subject to certain conditions stipulated therein.

Accordingly, this office vide Ref (2) has communicated the stage-I approval to Field Officers and User Agency and directed them to submit the Compliance Report in respect of the conditions of Stage-I approval.

In response, the User Agency vide Ref (3) has submitted the compliance report to the Deputy Conservator of Forests, Koppal Division. Who after verification vide Ref (4) has submitted the condition-wise Compliance Report to the Conservator of Forests, Ballari Circle and who has, in turn vide Ref (5) has submitted it to this office.
