With reference to the above subject, the Government of India vide Ref (1) has accorded 'in-principle' (Stage-I approval) under Section 2 of VSES Adhiniyam 1980 subject to certain conditions stipulated therein.

Accordingly, this office vide Ref (2) has communicated the stage-I approval to Field Officers and User Agency and directed them to submit the Compliance Report in respect of the conditions of Stage-I approval.

In response, the User Agency vide Ref (3) has submitted the compliance report to the Deputy Conservator of Forests, Sagar Division. Who after verification vide Ref (4) has submitted the condition-wise Compliance Report to the Chief Conservator of Forests, Shivamogga Circle and who has, in turn vide Ref (5) has submitted it to this office.

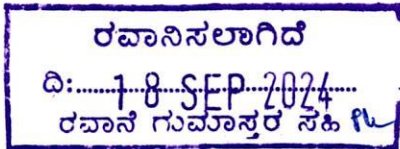



No. 103 & 164 of Udri Village, Kasaba hobli, Soraba Taluk, Shivamogga District (Sagar Forest Division) for laying 110KV SC line on DC Towers from the existing 110/11 KV Togarsi Substation to the proposed 1×10 MVA 110/11 KV Substation at Kuppagadde in Soraba Taluk, Shivamogga District in favour of the Executive Engineer (Electrical), Major Works Division, Karnataka Power Transmission Corporation Limited (KPTCL), Shivamogga subjected to the conditions.

The same has been forwarded by the Government of Karnataka vide ref (2) and The PCCF (HoFF) vide ref (3) to this office for submitting the demand note and further compliance as per the conditions stipulated by the GOI. With reference to the above subject, it is to inform that, after examining the proposal on the basis of the details submitted by GOK,

MOEF & Government of India has accorded in-principle (Stage-1) approval for the diversion of 6.073 Ha of forest land in Sy. No. 40 of Guduginakoppa Village and Sy. No. 103 & 164 of Udri Village, Kasaba hobli, Soraba Taluk, Shivamogga District (Sagar Forest Division) for laying 110KV SC line on DC Towers from the existing 110/11 KV Togarsi Substation to the proposed 1x10 MVA 110/11 KV Substation at Kuppagadde in Soraba Taluk, Shivamogga District in favour of the Executive Engineer (Electrical), Major Works Division, Karnataka Power Transmission Corporation Limited (KPTCL), Shivamogga subjected to the conditions.

The same has been forwarded by the Government of Karnataka vide ref (2) and The PCCF (HoFF) vide ref (3) to this office for submitting the demand note and further compliance as per the conditions stipulated by the GOI. As it is mentioned in condition A-3 of Ref (1) the User Agency shall restrict the felling of trees to minimum numbers in the diverted forest land and trees shall be felled under the strict supervision of the State Forest Department and the cost of felling of trees shall be deposited by the User Agency with Forest Department.

RFO Shiralkoppa has submitted the enumeration list vide ref (4) with the approximate details of Timber and Firewood. Assistant Conservator of Forest, Shikaripura Sub-Division, Shikaripura has forwarded the same vide ref (5).

As explained above, the cost of felling of trees, conversion, transportation and stocking of timber and firewood shall be borne by UA and be credited to State Government through the Treasury or by way of Demand Draft in favour of Deputy Conservator of Forest, Sagar Division, Sagar. A demand note for the above has been issued towards payment of cost of extraction of timber and firewood as below:

With reference to the above subject, it is to inform that, after examining the proposal on the basis of the details submitted by GOK, MOEF & Government of India has accorded in-principle (Stage-1) approval for the diversion of 6.073 Ha of forest land in Sy. No. 40 of

Guduginakoppa Village and Sy. No. 103 & 164 of Udri Village, Kasab hobli, Soraba Taluk, Shivamogga District (Sagar Forest Division) for laying 110KV SC line on DC Towers from the existing 110/11 KV Togarsi Substation to the proposed 1×10 MVA 110/11 KV Substation at Kuppagadde in Soraba Taluk, Shivamogga District in favour of the Executive Engineer (Electrical), Major Works Division, Karnataka Power Transmission Corporation Limited (KPTCL), Shivamogga subjected to the conditions.

The same has been forwarded by the Government of Karnataka vide ref (2) and The PCCF (HoFF) vide ref (3) to this office for submitting the demand note and further compliance as per the conditions stipulated by the GOI. As it is mentioned in condition A-3 of Ref (1) the User Agency shall restrict the felling of trees to minimum numbers in the diverted forest land and trees shall be felled under the strict supervision of the State Forest Department and the cost of felling of trees shall be deposited by the User Agency with Forest Department.

RFO Shiralkoppa has submitted the enumeration list vide ref (4) with the approximate details of Timber and Firewood. Assistant Conservator of Forest, Shikaripura Sub-Division, Shikaripura has forwarded the same vide ref (5).

As explained above, the cost of felling of trees, conversion, transportation and stocking of timber and firewood shall be borne by UA and be credited to State Government through the Treasury or by way of Demand Draft in favour of Deputy Conservator of Forest, Sagar Division, Sagar. A demand note for the above has been issued towards payment of cost of extraction of timber and firewood as below:
