With reference to the above subject, the Government of India vide Ref (1) has accorded 'in-principle' (Stage-I approval) under Section 2 of VSES Adhiniyam 1980 subject to certain conditions stipulated therein.

Accordingly, this office vide Ref (2) has communicated the stage-I approval to Field Officers and User Agency and directed them to submit the Compliance Report in respect of the conditions of Stage-I approval.



In-Principal (Stage 1) Forest clearance for the subject line is accorded by the Regional Ministry of Environment, Forest & Climate Change (RMoEFCC), Gol, Bangalore vide ref (ii) and (iii) above. In response a demand was received from DCF, Bangalore urban vide ref (iv) above with a total cost of Rs.32.42lakhs towards NPV, Penal NPV and plantation cost; copy enclosed. The same was uploaded online for your kind concurrence for a total amount of Rs.32.42 lakhs, however vide ref (v) the same was returned seeking a <u>detailed report on violation</u> & <u>revise NPV as per revised rates of MoEFCC, Gol</u>.

In the letter referred at SI.no (v) explanation was sought for violation of FCA in the construction of transmission line, following details are submitted for your kind perusal and consideration:

The subject project 400kV D/C transmission line from Madhugiri, Tumkur District to Yelahanka, Bangalore Urban District, Karnataka was envisaged by Ministry of Power, Govt of India under the Southern Region Grid Strengthening Scheme # 13; in the year 2009 for execution by POWERGRID. Copy of approval at Annexure-1. This project was envisaged to ameliorate the power scenario of southern states and further strengthen the National Grid. This project is crucial to meet the power requirement of Karnataka in general and Bangalore city in particular.

The route alignment for this line was finalized after detailed survey, thereby avoiding forest areas enroute in consultation with local forest officers during the year 2012-13. Subsequently, construction work was commenced, however, the work was stalled from 2014 to December 2017 due to stiff Right of Way problems from the public in Tumkur & Bangalore Urban districts. After initiation of few works like detailed survey and casting few foundations no further activities could be taken up by POWERGRID. Then, with the intervention of state & district administrations the work was re-commenced in 2018 after a gap of 4years.

Completion of this transmission line was essential to cater to the ever-increasing needs of Bangalore. The severe power crisis looming Bangalore city has put tremendous pressure on all the authorities involved; by Government of India (Gol) and Government of Karnataka (GoK). To complete this long pending transmission line several review meetings were held by the Hon'ble Prime Minister's Office with The Chief Secretary, Govt of Karnataka under PRAGATI, copy of project review meeting minutes are enclosed for ready reference at Annexure-2.

Based on this compensation will be released by POWERGRID as per notified rates of DC's. This revenue survey also has not revealed any involvement of forest or deemed forest in the line route.

After erection of towers (30/5 & 31/0) on private non forest lands in Sonnenahalli Village, Bangalore Urban district in Sep'19, and when the project was on the verge of completion, it was informed by forest department that the plantation area (Survey No. 79/P1) between these towers is under notification to become a 'Deemed Forest'. As per RTC this survey number is a revenue / govt. land, copy of RTC is at Annexure-3.

It is pertinent to mention that there are NO towers in this proposed deemed forest, only the transmission line connecting the 2 towers in non-forest land passes above (air space) deemed forest (mid length 213m & row 46m) measuring 0.98Ha, an indicative sketch is enclosed at Annexure-4. Here, only conductor wire passes above at a height of 10meters; on the fringes of deemed forest / without tree felling / without any construction work causing physical disturbance / damage to / in the deemed forest. Hence, as such no violation of FCA was intended.

Further, it is submitted that POWERGRID has been obtaining all the clearances with due compliance to all provisions of Forest Conservation, the subject case of violation in AIRSPACE has occurred inadvertently, and as such it to reiterate that due care will be taken to prevent such error of judgement in future projects.

Therefore, we request your good self to kindly condone the above violation in the interest of public purpose of the line and allow us to comply with the Forest (Stage-1) clearance conditions by depositing the applicable charges an get Final (Stage-2) clearance.

- 1. Chief Secretary welcomed the officers present and also the officers participating through Video Conference. CS informed that in future all District officers will participate in the meeting through Video Conference. The progress from the last meeting held on 22-9-2018 was reviewed.
- 2. CS expressed concern that even after the survey for identification of the affected land owners is completed, the survey reports are not being approved by the concerned Tahlsidars and sent to PGCIL for payment of compensation. <u>DCs to issue instructions that the approved survey reports have to be sent to PGCIL as expeditiously as possible.</u>
- 3. Chief Secretary directed the DC's to ensure that the Surveyors allotted for the work of PGCIL should not be allotted regular work till the PGCIL work is completed.
- 4. Dharmapuri Somanahalli 400 kV line :-
 - Tower erection in 2 locations in Mantapa village has been completed on 4-10-2018. Stringing is required to be done. There is a dispute between 2 land owners regarding the route to be taken for stringing. DC, Bengaluru Urban to hold a meeting with the concerned land owners and decide, if there has to be any deviation. If no consensus between the land owners is achieved, then the stringing work in the present route should be taken up after one week and completed in four days. Police to provide necessary support.
 - The survey report of Thammanayakanahalli, 2.5 kms has been received. However, there is dispute rcg. ownership in 1 km stretch. DC informed fresh phodi has to be done as per the

existing land conditions. Then this will take about 20 days. CS directed, <u>DC to allow PGCIL to do the stringing pending phodi</u> and identification of land owners for payment of compensation. DC, Bengaluru Rural assured that In another 4 villages, the <u>survey will be completed by 6th and in 9</u> <u>villages in another 1 week. The entire survey will be completed</u> by 26-10-2018 and reports sent to PGCIL.
- DIn Tumkur district, survey has been completed and reports are yet to be sent to PGCIL. DC, Tumkur assured that the <u>reports</u> will be submitted by 6-10-2018.
- In Bengaluru Urban district, survey of 6 kms has to be comleted. DC, Bengaluru Urban informed that surveyors have been deployed and the work will be completed before 26-10-2018.
- ED, PGCIL assured that the work will be completed by the end of December 2018, if the support given by DC and Police continues.
- 6. <u>Madhugiri (Tumkur) Dharmapuri 765 kV line (Via-Bengaluru Rural</u> / Chickballapur / Ramanagara) :
 - The entire crection and stringing work has been completed. Final sag work and installing spacers is going on.

 <u>In Hoskote taluk, Nandagudi hobli</u>, the land owners are obstructing the work mainly due to internal disputes. DC, Bengaluru Rural assured that <u>necessary support from the Police</u> <u>will be provided.</u> 14.0

- In Doddaballapur taluk, in Gantiganahalli village, the land owners are obstructing the work of putting spacers. Only one day's work is remaining. DC, Bengaluru Rural assured that necessary support will be provided by the Police to complete the work.

 - ED, PGCIL assured that the work will be <u>completed by 20th</u> October 2018 and commissioned by 15th November 2018.
- 8. <u>Kadapa Madhugiri 400 kV Transmission Line</u>

- <u>In Tumkur district</u>, the line passes through solar park lease lands. Out of 18 locations, 4 locations are cleared. I am directed to refer to the State Government's letter No.FEE22FLL2021 (e) dated 01/06/2021 seeking prior approval of the Central Government under Section'2' of the Forest (Conservation) Act, 1980 for the above project. In this regard, the area proposed for diversion was inspected on 05.07.2021 by the official of this office and it was noticed that stringing operations are already carried out in this area in an approximate length of 200 mtr. in violation of the Forest (Conservation) Act, 1980.

After careful examination of the proposal of the State Government, in-principle approval /Stage-I clearance of the Central Government is hereby granted for diversion of 0.98 ha. of forest land in Sy.No. 79/P1 of Sonnehalli village, Hesaraghatta Hobli, Bengaluru North (Additional) Taluk, Bengaluru Urban District for construction of 400 KV D/C Quad Tumkur (Vasantapura) to Yelahanka Transmission Line in Bengaluru Urban District (and Forest Division) in favour of Chief Manager, Power Grid Corporation of India Limited Southern Region Transmission System (SRTS)-II Regional Headquarters, Singanayakanahalli, Yelahanka Hobli, Bengaluru subject to the following conditions:-

Conditions which need to be complied prior to handing over of forest land by the A: State Forest Department.

1. The User Agency shall transfer online, the Net Present Value (NPV) of the forest land being diverted (0.391 ha) under this proposal, as per the orders of the Hon'ble Supreme Court of India dated 28.03.2008, 24.04.2008 and 09.05.2008 in Writ Petition (Civil) No.202/1995 and the guidelines issued by this Ministry vide its letter No. 5-3/2007-FC

dated 05.02. 2009. The requisite funds shall be transferred through online portal into CAMPA account of the Karnataka,

- Cost of raising plantation (including ten years maintenance) of ten times number of trees to be felled shall be realized from user agency towards compensatory afforestation. 2.
- Location of the area (map with DGPS coordinates) identified for raising the plantations shall be furnished along with compliance report.

The User Agency shall restrict the felling of trees to minimum number in the diverted forest land and the trees shall be felled under the strict supervision of the State Forest Department and the cost of felling of trees shall be deposited by the User Agency with the State Forest Department.

Since the User Agency has violated the provisions of F(C)Act, 1980, penalty for violation shall be realized from User Agency as specified under para 1.21 (ii) (a) & (b) of the Comprehensive Guidelines issued by Ministry vide letter No.5-2/2017-FC dated

28/03/2019. 6. State Government will initiate disciplinary action against the official concerned for not being able to prevent use of forest land for non-forestry purpose without prior approval of

- Government of India.
- User agency responsible for violation shall be prosecuted under local Act of the State for unauthorized use of forest land without the permission of State authority
- 8. All the funds received from the user agency under the project shall, be transferred/deposited in CAMPA account only through e-portal (https://parivesh.nic.in/). Amount deposited through other mode will not be accepted as compliance of the Stage-I clearance.
- 9. The compliance report shall be uploaded on e-portal (<u>https://parivesh.nic.in/</u>).
- 10. The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector.
- 11. The boundary of the diverted forest land shall be demarcated on ground at the project cost, by crecting four feet high reinforced cement concrete pillars, cach. inscribed with its serial number, distance from pillar to pillar and GPS co-ordinates.
 - 12: Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as prescribed in para 1.21 of Chapter 1 of the Handbook of comprehensive guidelines of Forest (Conservation) Act, 1980 as issued by this Ministry's letter No. 5-2/2017-FC dated 28.03.2019;
 - Conditions which need to be strictly complied on field after handing over of forest land to the user agency by the State Forest Department but the compliance in form **B**:

of undertaking shall be submitted prior to Stage-II approval:

- 1. Legal status of the diverted forest land shall remain unchanged.
- 2. At the time of payment of the Net Present Value (NPV) at the then prevailing rate, the User Agency shall furnish an undertaking to pay the additional amount of NPV, if so determined, as per the final decision of the Hon'ble Supreme Court of India.
- 3. Tree felling shall be restricted to the barest minimum possible and under confirmation from the local forest officials.
- 4. The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life, whichever is less.
- 5. The forest land shall not be used for any purpose other than that specified in the project proposal.
- 6. The forest land proposed to be diverted shall under no circumstances be transferred to any other agency, department or person without prior approval of the Central Government.
- 7. No damage to the flora and fauna of the adjoining area shall be caused.
- 8. The layout plan of the proposal shall not be changed without the prior approval of the Central Government.
- 9. The concerned Divisional Forest Officer, will monitor and take necessary mitigative measures to ensure that there is no adverse impact on the forests in the surrounding area.
- 10. The User Agency shall submit the annual self -compliance report in respect of the above stated conditions to the State Government and Integrated Regional Office, Bangalore by the end of March every year; and
- 11. The user agency shall comply all the provisions of the all Acts, Rules, Regulations, Guidelines, Hon'ble Court Order (s) and NGT Order (s) pertaining to this project, if any, for the time being in force, as applicable to the project.

After receipt of compliance report on fulfilment of the conditions mentioned above, the proposal shall be considered for final approval under Section-2 of the Forest (Conservation) Act, 1980. Transfer of forest land shall not be affected till final approval is granted by the Central Government in this regard.

Further, it may also be note that this in-principle approval shall be valid for a period of 5 years from the date of issue of this letter. In the event of non-compliance of the above conditions, this in-principle approval shall be revoked after 5 years.
