The Government of India vide Ref (1) have accorded 'in-principle' (Stage-I) approval for diversion of 1.121 hectare of forest land in Kunuru Village Sy No. 36 & 37 (Arkavathi Minor Forest), Kasaba Hobli, Kanakapura Taluk, Ramanagara District & Forest Division for laying of 66 KV SC line on DC towers for a distance of 7.297 km from existing 66/11 KV Harobele Sub-Station to proposed 66 KV Kunur Sub-Station subject to fulfillment of certain conditions stipulated therein.

Based on Stage-I approval for the project, the Government of Karnataka vide Ref (2) has directed to submit the Compliance Report in respect of conditions of Stage-I approval. Accordingly, this office vide Ref (3) has informed the User Agency and Field officers to submit the compliance report of in respect of the conditions of Stage-I approval.
