The Government of India vide ref (1) have accorded 'in-principle' (Stage-I) approval for the above-mentioned project subject to fulfilment of certain conditions.

In response, the User Agency vide ref (2) letter dated 15-01-2024 has submitted condition-wise compliance report to the Deputy Conservator of Forests, Bhadravathi Division, who after verification have vide ref (3) letter dated 14-02-2024 has submitted

condition wise compliance to the Chief Conservator of Forests Shivamogga Circle, who has further submitted the same to this office vide ref (4) letter dated 15-06-2024.

This office has verified the compliance report and found to be incomplete due to non- compliance of RF/PF notification as per Stage-I approval. Hence, directed to the field officers and user agency to submit RF/PF notification and upload online compliance report of further processing vide Ref (5).

In response, Chief Conservator of Forests, Shivamogga Circle vide Ref (4) letter dated 19-06-2025 has submitted RF/PF notification declared by the Government of Karnataka vide order No FEE 35 FAF 2025 dated 30-05-2025.

Based on the reports received and observations of this office, the status of compliance to the conditions of Stage-I approval is compiled by the User Agency.

Under the above circumstances, it is requested to move the matter with the Government of India, Ministry of Environment, Forests and Climate Change, Integrated Regional Office, Bengaluru to consider according the final (Stage-II) approval for the above-mentioned project.
