The Government have accorded Stage -I (in-principle) approval for the diversion of 0.4611 Ha of forest land for laying Optical, Fiber Cable by trenching/HDD method and installation of MH passing through forest area from Appappara to Thetturoad Jn and Kutta border to Kartikulam area under Tholpetty Range of Wayanad Wildlife Sanctuary subject to the conditions.
