At present the implementing authority **Sri Sudheer S S**, Tribal Development Officer, Tribal Development Office, Ranni entrusted with the execution of work - Construction of bridge at Avanippara Tribal Settlement - undertake that

1. Legal Status of the forest shall remain unchanged.
2. The demarcation of the forest area being diverted shall be carried out by erecting cement concrete pillars duly numbered at an interval of 20 meters, wherever possible at the cost of user agency before issue of Stage II clearance.

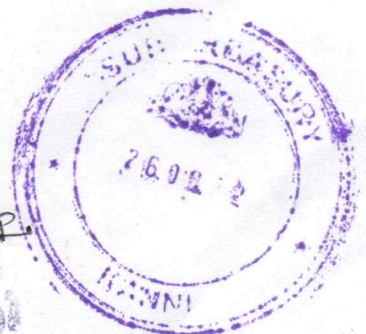

5. User Agency should ensure that Compensatory levies are deposited through challan generated online on the web portal and deposited in appropriate bank online only. Amount deposited through other mode will not be accepted as compliance of the stage I clearance.
  6. Necessary certificate/documents related to ensuring compliance of the Schedule Tribes and other Traditional Forest Dwellers (Recognition of forest Rights) Act 2006 as per the guidelines issued by Ministry of Environment & Forests vide letter No. 11-9/1998-FC (Pt) dated 05/07/2013 shall be furnished.
  7. The total forest area utilized for the project shall not exceed 0.0243ha.
  8. Any other condition that the Addl. PCCF (Central), Region office, Bangalore may impose from time to time for protection, improvement of flora and fauna in the forest area and public convenience, shall also be applicable.
  9. Violation of any of the conditions shall invite penal action, as deemed fit by the Additional Principal Chief Conservator of Forests (Central) Regional Office, Bangalore.

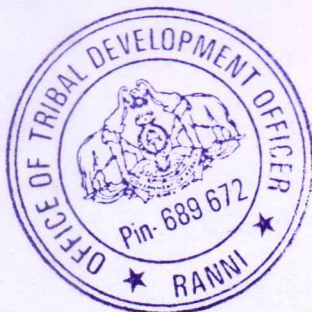
