

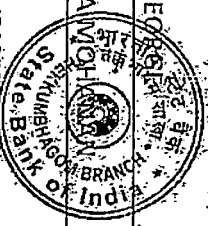

1	The User Agency shall transfer online, the Net Present Value (NPV) of the forest land being diverted under this proposal, as per the guideline issued by Ministry vide letter No.5-3/2011-FC (Vol-I) dated 06/01/2022. The requisite funds shall be transferred through online portal into CAMPA account of the State Concerned.	Complied
2	Cost of raising ten times number of trees to be felled (including maintenance) shall be realized from user agency towards compensatory afforestation	Complied
3	The User Agency shall restrict the felling of trees to minimum number in the diverted forest land and the trees shall be felled under the strict supervision of the State Forest Department and the cost of felling of trees shall be deposited by the User Agency with the State Forest Department	Agreed
4	All the funds received from the user agency under the project shall be transferred / deposited in CAMPA account only through e-portal (https://parivesh.nic.in/). Amount deposited through other mode will not be in accepted as compliance of the Stage-I clearance	Complied
5	The KML file of the forest area diverted and forest area selected towards CA plantation (ten times no. of trees to be felled) shall be uploaded on the e-green watch portal with all requisite details and same shall be submitted along with compliance report including GPS ids.	Complied
6	The State Government shall complete settlement of rights, in term of the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act 2006, if any, on the forest land to be diverted and submit the documentary evidence as prescribed by this Ministry in it's letter No. 11-9/1998-FC dated 3rd August 2009 read with 05.07.2013 with necessary enclosures, in support thereof.	Agreed
7	The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost as per the directions of concerned Divisional Forest Officer.	Agreed
8	The compliance report shall be uploaded on e-portal (https://parivesh.nic.in/).	Complied
9	Violation of any of these conditions will amount to violation of Forest (Conservation) Act. 1980 and action would be taken as prescribed in para 1.21 of Chapter 1 of the Handbook of comprehensive guidelines of Forest (Conservation) Act. 1980 as issued by this Ministry's letter No. 5-2/2017-FC dated 28.03.2019. 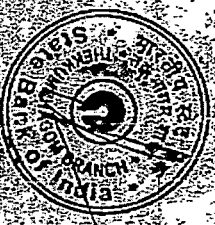

TO WHOM SO EVER IT MAY CONCERN

In compliance of the Ministry of Environment and Forests (MoEF), Government of India's letter No.119/98 FC (pt). dated 3rd August 2009 wherein the MOEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 (FRA, for short) on the forest land proposed to be diverted for non-forest purposes read with MoEF's letter dated 5th February 2013 wherein MoEF issued certain relaxation in respect of linear projects, it is certified that 00.8892 hectares of forest land proposed to be diverted in favour of Edavetty Gramapanchayath for the construction of Edavetty-Nadayam Road (purpose for diversion of forest land) in Idukki district falls within jurisdiction of Karikode village in Thodupuzha tehsils. It is further certified that:

(a) the complete process for identification and settlement of rights under the FRA has been carried out for the entire 008892 hectares of forest area proposed for diversion. A copy of records of all consultations and meetings of the Forest Rights Committee(s), Gram Sabha(s) are enclosed as annexure 2.

b) the diversion of forest land for facilities managed by the Government as required under section 3(2) of the FRA have been completed and the Grama Sabhas have given their consent to it.

(c) the proposal does not involve recognised rights of Primitive Tribal Groups and Pre-agricultural communities. Certified by the Project Officer, ITDP, Idukki enclosed as annexure 1.
