Sub:- Proposal is for diversion of 0.278 ha. Reserved Forest Land under section 2 (ii) of the Forest (Conservation) Act, 1980 for laying of underground OFC duct and cable within ROW of existing road SH 124 & SH 143 road passing through villages Shamgaon, Antawadi, Vagheri, Tal. Karad, Dist. Satara in the State of Maharashtra.

Sir,

In exercise of powers under general approval granted by MoEF&CC, Govt. of India vide Handbook of FCA Guidelines-2019, Chapter 4 (para-4.2), Government of Maharashtra granted 'In-principle' approval to the diversion of 0.278 ha. Forest Land under section-2 of the Forest (Conservation) Act, 1980 for laying of underground OFC duct and cable within ROW of existing road SH 124 & SH 143 road passing through villages Shamgaon, Antawadi, Vagheri, Tal. Karad, Dist.Satara, subject to fulfillment of the conditions stated in Order under reference No. (1). The Compliance of the conditions has been submitted by the Chief Conservator of Forests (T.), Kolhapur vide letter dated 14/07/2022 under reference No. (2) which is furnished as under:-

1.	The legal status of the land shall remain unchanged.	The User Agency has submitted the undertaking which is enclosed as- Annexure-I. (C.P.N.5)
2.	The cost of Net Present Value shall be exempted.	The User Agency has submitted an undertaking that they will agree for taking the exemption from the cost of Net Present Value and also they agreed to defray the cost of Net Present Value if required in the future. The User Agency has submitted the undertaking for the same which is enclosed as Annexure-II. (C.P.N.6)
3.	The Optical Fiber Cable Line will be laid within maximum size of the trench of 2.00 meters depth & 1.00 meter width with cable line under the PVC pipeline.	The User Agency has submitted the undertaking which is enclosed as Annexure-III. (C.P.N.7)

4.	The land under project will be reclaimed by the User Agency for which the agency shall submit a bank guarantee at the rate of Rs.50/- per running meter and an undertaking to that effect shall also be submitted. If the agency fails to reclaim the land to the satisfaction of concerned Deputy Conservator of Forests, the cost for reclamation will be covered from the bank guarantee.	The land under the project will be reclaimed by the User Agency for which the User Agency has submitted a bank guarantee of 2780 Rmt. x Rs.50 = Rs.1,39,000/- and also submitted an undertaking which is enclosed as Annexure-IV (C.P.N.8) that they do reclamation work as per PWD road standard. User Agency agrees that if the User agency fails to reclaim the land to the satisfaction of the concerned Deputy Conservator of Forests the cost for reclamation will be recovered from the bank guarantee. A copy of the Bank guarantee is attached on pages no.31 to 36. <i>(Total B.G. amount is Rs.2,36,300/-)</i>								
5.	If the cable is going to be laid in the formation width of the road, then additional charges in form of bank guarantee shall be given at the rate of Rs.35/- per running meter. Similarly for reclamation of side drain and for tarred portion, the guarantee will be at the of Rs.300/- per meter and Rs.750/- per meter respectively. An undertaking shall be obtained from the User Agency that it has agreed to make good any loss to Forest/ Environment while laying the cable in the forest area and during maintenance of the same in future.	User Agency submitted undertaking that the cable is going to be laid in the formation width of the road (side shoulder of road) and submitted addition charges in form of Bank guarantte of 2780 Rmt. x Rs.35 = Rs.97,300/- and also submitted an undertaking which is enclosed as Annexure-V(C.P.N.9) that they do reclamation work as per PWD road standard. User Agency agrees that if the User agency fails to reclaim the land to the satisfaction of the concerned Deputy Conservator of Forests the cost for reclamation will be recovered from the bank guarantee. 6.	For further maintenance of the project, the agency shall obtain permission from the concerned Deputy Conservator of Forests as and when required.	The User Agency has submitted the undertaking which is enclosed as Annexure-VI. (C.P.N.10)								
7.	The forest land shall not be used for any purpose other than specified in the proposal.	The User Agency has submitted the undertaking which is enclosed as- Annexure-VII. (C.P.N.11)								
8.	No felling of trees shall do during the implementation of project.	The User Agency has submitted the undertaking which is enclosed as- Annexure- VIII. (C.P.N.12)								
9.	No new forest area beyond the Right of Way of existing road should be broken for laying Optical Fiber Cable.	The User Agency has submitted the undertaking which is enclosed as- Annexure-IX.(C.P.N.13)								
10.	The User Agency shall defray the cost of Compensatory Afforestation over 1.0 ha. degraded Forest land at Gut No. 592, Compt. No. 786 at Village Nandal, Tal. Phaltan, Dist. 
