**Sub:** Diversion of 0.4232 ha. of Forest land under Forest (Conservation) Act, 1980 in favour of M/s. Reliance Jio Infocomm Limited, Nagpur for laying Optical Fiber Cable within RoW of existing Road of SH-357 (Paoni to Nagpur/ Bhandara Border) in Nagpur District in the State of Maharashtra.

The Govt. of Maharashtra vide resolution under reference 1 has accorded **in-principle** approval to the project proposal mentioned under subject above with a condition to submit compliance of conditions 1 to 24. Accordingly the User Agency has submitted their compliance to Deputy Conservator of Forests (T) Nagpur. The same is submitted by Chief Conservator of Forests (T) Nagpur to this office vide letter under reference 2. The details of conditions and remarks of the User Agency are as follows:-

1.	The legal status of the land shall remain unchanged.	As per compliance report submitted by the Deputy Conservator of Forests (T) Nagpur and forwarded by Chief Conservator of Forests (T) Nagpur the User Agency has submitted an Undertaking to this effect is enclosed as <b>Annexure-1</b> .
2.	The User Agency shall defray the cost of Net Present Value.	As per compliance report submitted by the Deputy Conservator of Forests (T) Nagpur and forwarded by Chief Conservator of Forests (T) Nagpur the User Agency has deposited an amount of Rs.4,05,333/- towards the cost of Net Present Value. Copy of the receipt along with an Undertaking is enclosed as <b>Annexure-2</b> .

3	The proposed aera falls in the RoW of the road passing through pinch point of Tiger Corridor, user agency shall obtain Wildlife Clearance.	As per compliance report submitted by the Deputy Conservator of Forests (T) Nagpur and forwarded by Chief Conservator of Forests (T) Nagpur mentions that the User Agency has submitted an online form for seeking recommendations of Standing Committee of NBWL / SBWL. A copy of the same is enclosed. It is also submitted that the same has been forwarded by Principal Chief Conservator of Forests (Wildlife) M. S. Nagpur vide letter no.3059, dtd.24.01.2023 to Govt. of Maharashtra. Copy of the same is enclosed. An Undertaking to this effect is enclosed as <b>Annexure-3</b> .
4.	Working permission cannot be granted till the wildlife clearance is obtained by the user agency from the competent authority.	As per compliance report submitted by the Deputy Conservator of Forests (T) Nagpur and forwarded by Chief Conservator of Forests (T) Nagpur the User Agency has submitted an Undertaking to this effect is enclosed as <b>Annexure-4</b> .
5.	The Optical Fiber Cable line will be laid within maximum size of the trench of 2.00 meters depth and 0.50 meter width with cable line under the PVC pipeline.	As per compliance report submitted by the Deputy Conservator of Forests (T) Nagpur and forwarded by Chief Conservator of Forests (T) Nagpur the User Agency has submitted an Undertaking to this effect is enclosed as <b>Annexure-5</b> .
6.	The land under project will be reclaimed by the User Agency for which the Agency shall submit a bank guarantee at the rate of Rs.50/- per RMT and an undertaking to that effect shall also be submitted. If the agency fails to reclaim the land to the satisfaction of concerned Deputy Conservator of Forests (T), the cost for reclamation will be covered from the Bank Guarantee.	As per compliance report submitted by the Deputy Conservator of Forests (T) Nagpur and forwarded by Chief Conservator of Forests (T) Nagpur the User Agency has submitted an Undertaking to this effect is enclosed as <b>Annexure-6 and Annexure-6-A to 6-E</b> .
7.	If the cable is going to be laid in the formation width of the road, then additional charges in form of Bank Guarantee shall be given @ Rs.35/- RMT. Similarly for reclamation of side drain and for tarred portion, the guarantee will be @ Rs.300/- per RMT and Rs.750/- Per RMT respectively. An undertaking shall be obtained from the User Agency that it has agreed to make good any loss to Forest / Environment while laying the cable in the forest area and during the maintenance of the same in future. 9.	The forest land shall not be used for any purpose other than specified in the proposal. 10.	No felling of trees shall be done during the implementation of project.
