Government of Maharashtra, vide order under reference No.1 has accorded In-Principle approval to the project proposal mentioned under subject above with a condition to submit compliance of 23 points.

Accordingly, the Conservator of Forests (T), Dhule vide letter under reference No. 2, 3 & 4 has submitted the compliance of conditions on 23 points to this office. The compliance report on 23 points as desired by the Government of Maharashtra vide order dated 27/03/2023 is being submitted as under:




