Government of Maharashtra, vide order under reference No.1 has accorded In-Principle approval to the project proposal mentioned under subject above with a condition to submit compliance of 24 points. Accordingly, the Chief Conservator of Forests (T.), Kolhapur vide letter under reference No.2 has submitted the compliance of conditions on 24 points to this office. 
