In exercise of powers under general approval granted by MoEF&CC, Govt. of India vide Handbook of FCA Guidelines-2019, Chapter 4 (para-4.2), Government of Maharashtra granted 'In-principle" approval to the diversion of 0.4993 ha. Reserved Forest Land under section-2 of the Forest (Conservation) Act, 1980 for laying of underground OFC duct and cable within ROW of existing Road passing through villages- Kas, Phalani & Bamnoli, Tal.
