In exercise of powers delegated to the Government of Maharashtra vide Government of India's order No. F.No.11-9/98/FC, dated 13/5/2011 and 16/6/2011, Government of Maharashtra conveyed sanction for diversion of 2.00 ha. Protected Forestland for construction of Administrative Building & Residential Quarters for Officers and Police Staff (Arm Out Post) At-Yelchil, Tal. Aheri, Dist.
