In exercise of powers delegated to the Government of Maharashtra vide Government of India's order No. F.No.11-9/98/FC, dated 13/5/2011 and 16/6/2011, Government of Maharashtra conveyed sanction for diversion of 2.00 ha. Protected Forest land for construction of Administrative Building & Residential Quarters for Officers and Police Staff (Arm Out Post) At-Aaldandi (Nender Camp), Tal-Ettapalli, Dist. Gadchiroli under Forest (Conservation) Act, 1980 subject to fulfillment of the conditions stated in the letter under reference. The compliance report of the conditions is furnished as under:-
