Government of India, MoEF&CC, Integrated Regional Office, Nagpur vide letter under reference No.1 had accorded in-principle approval under Section-2 of the Forest (Conservation) Act, 1980 for diversion of 132.102 ha. subject to the fulfillment of the 27 conditions. Accordingly, the Conservator of Forests (T.), Gadchiroli vide letter under reference No. 2 has submitted the compliance report of said conditions to this office. The cost of compensatory afforestation at the prevailing wage rates as per the compensatory afforestation scheme and the cost of survey, demarcation, and erection of permanent pillars if required on the CA land shall be deposited in advance with the Forest Department by the project authority. The CA will be maintained for 10 years.

The scheme may include appropriate provisions for anticipated cost increases for works scheduled for subsequent years. For protection from encroachment and better management of the CA plantation; the fencing shall be done from the compartment boundary.
