The Ministry of Environment, Forest and Climate Change, Government of India, Regional Office, Nagpur vide letter under reference No.1 has accorded 'in-principle' approval to the abovementioned proposal. Condition No. x of 'in-principle' approval is reproduced as follows:

***'In conformity with Wildlife Protection Act, 1972 and The Prevention of Cruelty to Animals Act, 1960, the User Agency in consultation with concerned DCF, may provide suitable guided cross passage structures as per need and along possible traditional routes of Wildlife for their smooth movement.'***

In this regard, the Chief Conservator of Forests (T.), Gadchiroli vide letter under reference No.2 has forwarded the compliance report submitted by the Deputy Conservator of Forests, Allapalli Forest Division, Allapalli wherein request of the User Agency for exception of construction of cross passage is forwarded for further necessary action alongwith the undertaking submitted by the User Agency.

The User Agency vide their undertaking has submitted that Rumble Strips, Speed Regulatory Boards, Wildlife Crossing informative boards, etc. will be provided at locations stated by the Forest Department.

The User Agency has submitted that presently road is in pathetic condition. Sanctioned road work consists widening the existing 5.5 m wide carriageway to 10 m wide carriageway. Also, as per minutes of the 24<sup>th</sup> meeting of SBWL dated 17/04/2025, approval of NBWL will not be required for working in EVL area of 54.274 ha. The User Agency has requested an exemption for the construction of suitable guided cross passage structures.


