The Government of India, Ministry of Environment, Forest and Climate Change, IRO Office Nagpur has accorded in-principal approved for the subject proposal under Section 2 (ii) of the forest (Conservation) Act, 1980 subject to fulfillment of the conditions mentioned in the letter dated 06/04/2023 under referene-1. Accordingly the Conservator of forests (T) Dhule vide letter dated 3/7/2023 has submitted the compliance of conditions of In-Principle approval to this office. The compliance report of the conditions of In-Principle approval was furnished vide letter dated 06.04.2023.
