



Mitigation Measures for replacement of 110 kv D/C transmission line in the wildlife Corridor will be-

1. The minimum ground clearance for 110 kV transmission line is 6m. In addition to this, it is proposed to maintain additional clearance 3 meters over and above minimum clearance above ground from the lowest conductor of transmission line in the Wildlife Corridor.




2. The Stringing of conductor for the transmission line shall be carried out maintaining a separation between energized conductors as follows:

Vertical distance between two conductors: 4 m (appx.)

The above arrangement will nullify the likelihood of electrocution of large, winged birds like hornbill, Owls because the distance between energized conductors will be always more than the maximum wingspan of the bird.


3. To prevent accidental collision of birds with the conductor bird diverter/colored/contrast marker devices will be installed on the earth wire to make it visible to birds, as shown in picture below.



4. The excavated pits shall be properly barricaded and fenced to prevent accidental falling of mammals.

Specifications of the Bird Flight Diverter:

- a. For Bird flight Diverter installation, one bird flight diverter shall be installed at every 10 Meter on the earth wire / Optical Ground Wire (OPGW) and one bird flight diverter shall be installed at every 15 m on phase conductors in a staggered way such that as a whole, the power line will have effectively one diverter at every 5m to 6m. In case of bundled conductors, bird flight diverters may be installed on the lower conductor of the bundle in staggered manner.
- b. For Bird Flight Diverter installation stretches can be identified with local ecologist on field.
- c. For visibility of Bird Flight Diverter, a warning disc shall be provided.

Additional mitigation measures to minimize adverse impacts:

- 1. Constructing when the vegetation is dormant, from Oct-March, to minimize impacts. Construction should be avoided in flowering and fruiting season (April-May).
- To minimize the disturbance to wildlife, no new approach road will be constructed in the forest area. The
