In exercise of powers delegated to the Government of Maharashtra vide Government of India's order No. F.No.11/160/2019/FC, dated 23rd June, 2021, Government of Maharashtra conveyed sanction for diversion of 0.7 ha. Forest land under Forest (Conservation) Act, 1980 for construction of LILO on existing 220 KV Boisar Nallasopara Transmission Line for Palghar Substation at Morekuran, Tal. & Dist. 


