I am to say that the Central Government vide letter No.3-MN C 060/2021-SHI/1085-80 dated 5th July, 2022 conveyed the 'In-Principle Approval' for diversion of 72.23 ha of forest land for construction of two-lane with paved shoulder of Mandeu-Jiri River Section from Km 80.630 to Km 96.870 of Tamenglong- Mahur Road in the State of Manipur on EPC Mode by NHIDCL under Section-2 of FCA (1980) subject to compliance of stipulated conditions mentioned in the IPA. The User Agency (NHIDCL) and Divisional Forest Officer/Tamenglong Forest Division have complied with the said conditions and the Compliance Report is given below.
