Sub: Diversion of 14.928 ha of forest land for construction of Sono Barrage Project near village Jaida of Gopabandhu Nagar Tahasil of Mayurbhanj District, Odisha within the jurisdiction of Balasore (WL) and Baripada Forest Division by the Executive Engineer, Mayurbhanj Investigation Division, Udala.

Ref:- Letter No.5-ORC307/2017-BHU dated 04.08.2017 of the Conservator of Forests (Central), Govt. of India, MoEF&CC, Regional Officer, Bhubaneswar.

Sir,

In inviting reference to the above mentioned subject, this is to inform that Government of India, Ministry of Environment, Forest & Climate Change, Regional Office, Bhubaneswar have accorded Stage-I approval vide their Letter No.5-ORC307/2017-BHU dated 04.08.2017 for diversion of 14.928 ha of forest land (2.654 ha in Balasore (WL) division and 12.274 ha in Baripada Forest Division) for construction of Sono Barrage Project near village Jaida of Gopabandhu Nagar Tahasil of Mayurbhanj District, Odisha subject to fulfillment of twenty five(25) Nos of condition stipulated therein. Further the Govt of Odisha in FE & CC Department have imposed one No. of additional condition. The user agency has complied all the conditions imposed by Govt of India, MoEF &CC RO, Bhubaneswar as well as State Government. In this regard the point wise compliances are furnished below.

<u>Condition No.(i):-</u> Legal status of forest land proposed for diversion shall remain unchanged.

Compliance: In compliance to the above, the FD, STR-cum-RCCF, Baripada Circle has reported that, the User Agency has furnished undertakings duly countersigned by the concerned DFOs that, the legal status of forest land proposed for diversion shall remain unchanged, which are enclosed as **Annexure-1 Series**.



Condition No.(ii):- The State Govt. shall charge the Net Present Value (NPV) of forest area proposed to be diverted under this proposal from the user agency as per the Orders of Hon'ble Supreme Court of India dated.28.03.2008, 24.04.2008 and 09.05.2008 and 09.05.2008 in Writ Petition(Civil) No.202/1995 and the guidelines issued by this Ministry vide its letter No.5-3/2007-FC dated 05.02.2009 in this regard. While conveying the compliance of this condition, mention be made of the Eco-class and density of forest for which NPV has been charged.

Compliance: In compliance to the above, the FD, STR-cum-RCCF, Baripada Circle has reported that the User Agency has deposited Rs.1,32,91,014/- towards NPV pertaining to 12.274 ha forest land proposed to be diverted in Baripada Forest Division and Rs.25,41,948/- /- towards NPV pertaining to 2.654 ha forest land proposed to be diverted in Balasore (WL) Division.

<u>Condition No.(iii):</u>—At the time of payment of the Net Present Value (NPV) at the present rate, the user agency shall furnish an undertaking to pay the additional amount of NPV, if so determined, as per the final decision of the Hon'ble Supreme Court of India.

Compliance: In compliance to the above, the FD, STR-cum-RCCF, Baripada Circle has reported that, the User Agency has furnished an undertaking duly countersigned by concerned DFOs to pay the additional amount of NPV, if so determined, as per the final decision of the Hon'ble Supreme Court of India, which is enclosed as Annexure-3.

Condition No.(iv):- Compensatory afforestation over 14.97 ha. of non-forest identified in Plot No.38, Khata No.315 of village Daundi under Gopabandhu Nagar Tahasil of Baripada Forest Division and Plot No.357, 539 & 401, Khata No.152 of village Gohira under Jamada Tahasil of Rairangpur Forest Diversion against the area of forest land proposed to be diverted shall be raised and maintained by the State Forest Department at the cost of the user agency.

Compliance: In compliance to above, FD, STR-cum-RCCF, Baripada Circle has reported that the PCCF (FD&NO, FC Act.), O/o the PCCF & HoFF, Odisha has approved the Compensatory Afforestation Scheme with maintenance of 10 years at the wage rate of Rs.450/- MD vide his memo No.18076 dated 05.09.2024 as per details given below.

<u>Condition No.(v):-</u> The non-forest land identified for raising compensatory afforestation shall be transferred and mutated in favour of the State Forest Department before issue of Stage-II approval.

Compliance: In compliance to the condition, the FD, STR-cum-RCCF, Baripada Circle has reported that the Tahasildar, Gopabandhu Nagar Tahasil has mutated and transferred the following non-forest land in favour of Government of Odisha, Forest and Environment Department..

Condition No.(vi):- The non-forest land which is transferred and mutated in favour of the State Forest Department for the purpose of compensatory afforestation shall be declared as Reserved Forest under Section-4 or Protected Forest under Section-29 of the Indian Forest Act, 1927, or under the relevant Section(s) of the local Forest Act. The Nodal Offices must report compliance within a period of 6 months from the date of grant of final approval and send a copy of the original notification declaring the non-forest land under section-4 or section-29 of the Forest Act, 1927, or under the relevant section of the local Forest Act as the case may be, to this Ministry for information and record.

Compliance: In compliance to above, the FD, STR-cum-RCCF, Baripada Circle has reported that, the non-forest CA land over 6.07 Ha. in Mouza-Daundia, Tahasil-Gopabandhu Nagar, District- Mayurbhanj which is transferred and mutated in favour of Forest & Environment Department, has been declared as "Daundia Protected Forest" under Section-33 of Odisha Forest Act,1972 vide Notification No.FE-DIV-FLD-0068-2024(10F-(Cons)-286/2016-56/FE&CC, Dated-01.01.2025 of Government of Odisha, Forest, Environment and Climate Change Department.

Similarly, the non-forest CA land over 8.903Ha. in Mouza-Gohira, Tahasil-Jamda, District-Mayurbhanj which is transferred and mutated in favour of Forest & Environment Department, has been declared as "Gohira Protected Forest" Forest under Section-33 of Odisha Forest Act,1972 vide Notification No.FE-DIV-FLD-0068-2024(10F-(Cons)-286/2016)-49/FE&CC, Dated-01.01.2025 of Government of Odisha, Forest, Environment and Climate Change Department.

<u>Condition No.(vii):-</u> The User agency shall transfer the cost of raising and maintaining the compensatory afforestation for 10 years, at the current wage rate, to the State Forest Department.

Compliance: In compliance to above, FD, STR-cum-RCCF, Baripada Circle has reported that the PCCF (FD&NO, FC Act.), O/o the PCCF & HoFF, Odisha has approved the Compensatory Afforestation Scheme with maintenance of 10 years at the wage rate of Rs.450/- MD vide his memo No.18076 dated 05.09.2024 as per details given below.

<u>Condition No. (ix):-</u> The user agency shall obtain Environment Clearance as per the provisions of the Environment(Protection) Act, 1986, if required.

Compliance:- In compliance to above, the FD, STR-cum-RCCF, Baripada Circle has reported that the User Agency has obtained Environment Clearance for construction of Sono Barrage Project at village Jaida, Dist-Mayurbhanj vide Ref No.85, dt.14.02.2011of Member Secretary, State Environment Impact Assessment Authority (SEIAA), Orissa, which is enclosed as Annexure-9 Series.

<u>Condition No. (x):-</u> The Catchment Area Treatment Plan shall be prepared and implemented at the cost of user agency. It may be ensured that water harvesting structure be included as a component in CAT Plan.

Compliance:- In compliance to above, the FD, STR-cum-RCCF, Baripada Circle has reported that the Catchment Area Treatment Plan for the project for Rs.14,04,77,900.00 has been approved at the wage rate of 450/- MD vide memo no.18076, dt.05.09.2024 of PCCF(Nodal). Water harvesting structure has been included as a component in CAT Plan.

The User Agency has deposited the said amount in State specific CAMPA Account in four spells.

Initially, the Catchment Area Treatment Plan (CATP) has been approved for Rs. 4,34,73,000/- at the wage rate of Rs. 200/- MD. The UA has deposited a sum of Rs 5,86,39,841/- on 29.03.2018 in the State specific CAMPA Account No. 150825712731356 in Corporation Bank, Lodhi Complex Branch, New Delhi online through Parivesh portal which includes Rs.4,34,73,000/- towards cost of CATP.

- Due to enhancement of wage rate the said scheme has been revised at the wage rate of Rs.308 MD amounting to Rs.6,24,43,400/- The user agency has deposited a sum of Rs. 1,89,70,400/- towards differential cost of CATP (Rs.6,24,43,400/- Rs.4,34,73,000/-) in two spells. The UA has deposited a sum of Rs 1,50,00,000/- on 08.03.2022 in the State specific CAMPA Account No. 1508257112731830 in Union Bank of India, Lodhi Complex Branch, New Delhi online through Parivesh portal which includes differential cost of CATP of Rs.1,45,36,200/-. Again, the user agency has deposited Rs. 44,34,200/- towards balance differential cost of CATP on 23.03.2022 in the State specific CAMPA Account No. 150825712731456 in Union Bank of India, Lodhi Complex Branch, New Delhi online through Parivesh portal.
- Due to enhancement of wage rate the said scheme has again been revised at the wage rate of Rs.450/- MD amounting to Rs.14,04,77,900/-. The user agency has deposited a sum of Rs. 7,80,34,500 towards differential cost of CATP (Rs14,04,77,900/- -Rs.6,24,43,400/-) on 01.11.2024. The UA has deposited a sum of Rs 8,66,29,000/- on 01.11.2024 in the State specific CAMPA Account No. 150825712731658 in Union Bank of India, FCS Centre,Jelitta Towers, Mission Road, Bengaluru online through Parivesh portal which includes differential cost of CATP of Rs.7,80,34,500/-.

The financial outlay of CATP scheme @ Rs. 450/- MD, the copies of the demand notices, the copies of payment receipts of the above amounts and the status of payment downloaded from Parivesh portal are enclosed as **Annexure-10 Series**.

<u>Condition No. (xi):-</u> Plantation of suitable species shall be raised and maintained along the canal, at the cost of user agency, if possible.

Compliance:-In Compliance to above, the User Agency has given undertakings duly countersigned by the concerned DFOs that Plantation of suitable species shall be raised and maintained along the canal, at the cost of user agency, which are enclosed as Annexure-11 Series.

Condition No. (xii):- Water will be provided free of cost to the Forest Department, if required, for raising nursery/plantation in nearby areas.

Compliance:- In Compliance to above, the User Agency has given undertakings duly countersigned by the concerned DFOs that water will be provided free of cost to the Forest Department, if required, for raising nursery/plantation in nearby areas, which are enclosed as Annexure-12 Series.



<u>Condition No.(xiii):-</u> No tree felling shall be done between Full Reservoir Level(FRL) and 4 meters below Full Reservoir Level(FRL).

Compliance:- In Compliance to above, the User Agency has given undertakings duly countersigned by the concerned DFOs that no tree felling shall be done between Full Reservoir Level (FRL) and 4 meters below Full Reservoir Level (FRL), which are enclosed as Annexure-13 Series.

<u>Condition No. (xiv):-</u> The royalty of trees need not be demanded from the user agency as per Ministry's letter No.13-20/2015-CAMPA, dated.09.06.2016.

Compliance:- In Compliance to above, the FD, STR-cum-RCCF, Baripada Circle has reported that the User Agency has informed that no demand has been received from forest department as per Ministry's letter No.13-20/2015-CAMPA, dated.09.06.2016, which are enclosed as Annexure-14 Series.

Condition No.(xv):- The boundary of the forest land proposed to be diverted shall be demarcated on the ground at the project cost, by erecting four feet high reinforced cement concrete pillars, each inscribed with its serial number, DGPS coordinates, distance from adjoining pillars etc. As per Ministry's letter No.13-20/2015-CAMPA dated 09.06.2016, the cost of expenditure like boundary walls, stone pillars, demarcation charges, charges for felling of trees and their transportation to depots shall be deposited with DFO concerned and the work should be undertaken departmentally in order to ensure that the task of erection of boundary walls, stone pillars, demarcation charges etc. are undertaken faithfully and in the best interests of the forests before the diversion and handing over of the forest land takes place. The work on these items should be completed within 6months from the grant of final approval to diversion of forest land.

Compliance:- In Compliance to above, the FD, STR-cum-RCCF, Baripada Circle has reported that the User Agency has submitted the list with total 870nos pillars posted by erecting four feet high reinforced cement concrete pillars, each inscribed with its serial number, DGPS coordinates, distance from adjoining pillars in respect of Baripada and Balasore(WL) Divisions as per Ministry's letter No.13-20/2015-CAMPA, dated.09.06.2016. The boundary pillars posted by the User Agency has been verified and authenticated by the Divisional Forest Officers, Baripada and Balasore(WL) Divisions.

Condition No.(xvi):- The State Forest Department/UA shall submit the surveyed sketch map with location and natural reference point of 14.97 ha. of non-forest identified in Plot No.38, Khata No.315 of village Daundi under Gopabandhu Nagar Tahasil of Baripada Forest Division and Plot No.357,539 & 401, KhataNo.152 of village Gohira under Jamada Tahasil of Rairangpur Forest Division as proposed for CA, giving the DGPS readings giving the latitude and longitude and distance between them.

Compliance:- In Compliance to above, the FD, STR-cum-RCCF, Baripada Circle has reported that the User Agency has submitted surveyed sketch map with location and natural reference point of 14.97 ha. of non-forest identified in Plot No.38, Khata No.315 of village Daundi under Gopabandhu Nagar Tahasil of Baripada Forest Division and Plot No.357,539 & 401, KhataNo.152 of village Gohira under Jamada Tahasil of Rairangpur Forest Division as proposed for CA, giving the DGPS readings with the latitude and longitude and distance between them. The map has been authenticated by User Agency, DFO, Baripada and Rairangpur Divisions. The survey sketch maps are enclosed as **Annexure-16 Series**.

Condition No.(xvii):- No labour camp hall be established on the forest land.

Compliance:- In Compliance to above, the User Agency has given an undertaking duly countersigned by the concerned DFOs that no labour camp shall be established on the forest land for construction of the project, which are enclosed as **Annexure-17 Series**.

<u>Condition No. (xviii):-</u> The user agency shall provide alternate fuel preferably LPG to the labourers and the staff working at the site so as to avoid any damage and pressure on the adjacent forest areas.

Compliance:- In Compliance to above, the User Agency has given an undertaking duly countersigned by the concerned DFOs to provide alternate fuel preferably LPG to the labourers and the staff working at the site so as to avoid any damage and pressure on the adjacent forest areas, which are enclosed as **Annexure-18 Series**.

<u>Condition No.(xix):-</u> No additional or new path will be constructed inside the forest area for any activity related to the project work.

Compliance:- In Compliance to above, the User Agency has given an undertaking duly countersigned by the concerned DFOs that no additional or new path will be constructed inside the forest area for any activity related to the project work, which are enclosed as Annexure-19 Series.

<u>Condition No.(xx):-</u> Earth or any material shall neither be brought from nor the debris resulting during construction be disposed of in the adjoining forest area by the user agency.

Compliance:- In Compliance to above, the User Agency has given an undertaking duly countersigned by the concerned DFOs that no earth or any material shall neither be brought from nor the debris resulting during construction be disposed of in the adjoining forest area, which are enclosed as Annexure-20 Series.

<u>Condition No.(xxii):-</u>The forest land shall not be used for any purpose other than that specified in the proposal and under no circumstances be transferred to any other user agency, department or person without prior approval of the Ministry of Environment, Forest & Climate Change.

Compliance:- In Compliance to above, the User Agency has given an undertaking duly countersigned by the concerned DFOs that the forest land proposed for diversion for the project shall not be used for any purpose other than that specified in the proposal and under no circumstances be transferred to any other user agency, department or person without prior approval of the Ministry of Environment, Forest & Climate Change, which are enclosed as Annexure-22 Series.

Condition No.(xxiii):- The State Government shall complete settlement of rights, in term of the Scheduled Tribes and Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006, if any, on the forest land to be diverted and submit the documentary evidence as prescribed by this Ministry in its letter No.11-9/1998-FC(pt.) dated.03.08.2009 read with letter No.11- 9/1998-FC (pt.)dated 05.02.2013, in support thereof. The original FRA certificate or attested by the issuing authority shall be submitted before Stage-II approval.

Compliance:- In compliance to above, the RCCF, FD, STR-cum-RCCF, Baripada Circle has reported that the FRA certificate in original for the project pertaining to Baripada and Balasore(WL) Divisions has been submitted to the Government of Odisha, F&E Department vide No.20940/9F(Irrg.0-345/2016, dt.09.11.2016 of Addl. Principal Chief Conservator of Forests(Forest Diversion and Nodal Officer, FC Act), O/o the PCCF,Odisha. Photo copies of FRA certificates pertaining to Baripada and Balasore(WL) Divisions issued by the Collector, Mayurbhanj and Balasore which are enclosed as **Annexure-23 Series**.

<u>Condition No.(xxiv):-</u> Any other conditions that Ministry of Environment, Forest & Climate Change may stipulate, from time to time, in the interest of conservation, protection and development of forests and wildlife shall be complied by the user agency.

Compliance:- In compliance to above, the User Agency has furnished an undertaking duly countersigned by the concerned DFOs to abide by any other conditions that Ministry of

<u>Condition No. (xxv):-</u> The user agency and the State Government shall ensure compliance to provisions of the all Acts, Rules, Regulations and Guidelines, for the time being in force, as applicable to the project.

Compliance:- In Compliance to the condition, the User Agency has given an undertaking duly countersigned by the concerned DFOs to comply the provisions of the all Acts, Rules, Regulations and Guidelines, for the time being in force, as applicable to the project, which are enclosed as Annexure-25 Series.

Additional Condition imposed by Government of Odisha, Forest, Environment & Climate Change Department vide No.10F(CON)286/ 2016-20273/F&E, Bhubaneswar, Dated 03.10.2017.

<u>Condition:</u> The user agency shall pay towards cost of removal of trees enumerated before commencement of work and tree felling should be taken up in phases strictly as per requirement under the supervision of the Divisional Forest Officers of Baripada and Balasore(WL) Division.

In view of the above, the compliance to the conditions imposed by the GoI, MoEF & CC, Regional Office, Bhubaneswar as well as the State Government is sent herewith for according final approval for diversion 14.928 ha of forest land for construction of Sono Barrage Project near village Jaida of Gopabandhu Nagar Tahasil of Mayurbhanj District, Odisha within the jurisdiction of Balasore (WL) and Baripada Forest Division by the Executive Engineer, Mayurbhanj Investigation Division, Udala for approval under Section-2(1)(ii) of Van (Sanrakshan Evam Samvardhan) Adhiniyam,1980.
