**Sub: Proposal for diversion of 9.441 ha of forest land in Lamdunguri RF for construction of Additional Spillway of Hirakud Dam Project, Burla in Sambalpur District in the State of Odisha- Submission of Stage-I compliance**

Ref:- GoI, MoEF & CC, ERO, Bhubaneswar Letter F. No.5-ORC345/2018-BHU dated 01.05.2018

Sir,

In inviting reference to the above mentioned subject, this is to inform that Government of India, Ministry of Environment, Forest & Climate Change, Integrated Regional Office, Bhubaneswar have accorded Stage-I approval vide their Letter No.5-ORC345/2018-BHU dated 01.05.2018 in respect of proposal for diversion of 9.441 ha of forest land in Lamdunguri RF for construction of Additional Spillway of Hirakud Dam Project, Burla in Sambalpur District in the State of Odisha subject to fulfillment of twenty one (21) Nos. of conditions stipulated therein. Further, Government of Odisha in FE & CC Department have imposed 4 (Four) nos. of additional condition. The User Agency has complied all the conditions imposed by Govt. of India, MoEF & CC, IRO, Bhubaneswar and additional four (4) Nos. of conditions imposed by State Govt. The point wise compliance basing on the reports of the DFO, Sambalpur Forest Division and RCCF, Sambalpur Circle are furnished below.

**Condition No.(i):-** *Legal status of the land proposed for diversion shall remain unchanged.*

**Compliance:** - In compliance to the above, the user agency has furnished an undertaking that the legal status of the forest land proposed for diversion shall remain unchanged, which is enclosed as **Annexure-I.**

**Condition No. (ii):-** *The State Govt. shall charge Net Present Value (NPV) of forest area proposed to be diverted under this proposal from the user agency as per the Orders of Hon'ble Supreme Court of India dated 28.03.2008, 24.04.2008 and 09.05.2008 in Writ Petition (Civil) No. 202/1995 and the guidelines issued by this Ministry vide its letter no. 5-3/2007-FC dated 05.02.2009 in this regard. While conveying the compliance of this condition, mention be made of the Eco-class and density of forest for which NPV has been charged:*

**Compliance:-** In compliance to the above, the RCCF, Sambalpur Circle has reported that DFO, Sambalpur has raised demand vide his office Memo No.2845 dt.29.05.2018 to deposit Rs. 59,10,066/- towards NPV against 9.441 ha of the forest area proposed for diversion in Lamdunguri R.F having Eco-Class III and Canopy density below 0.4 .The User Agency has deposited a sum of Rs. 59,10,066/- in Adhoc CAMPA, New Delhi (Corporation Bank A/C No.-037100101025222, IFSC code- CORP0000371 through online payment mode vide electronic Cheque No.70201, dtd.29.06.18 and UTR No. U000000436013142.The above-mentioned amount have been credited to SB A/c No 52010126374655 maintained in the Compensatory Afforestation Fund- Odisha in Corporation Bank, Lodhi Complex, New Delhi-110003 as confirmed by the DIG Adhoc-CAMPA vide his letter no 1-26/2014-CAMPA dated 23rd January 2019.

Besides that, DFO, Sambalpur has demanded revised cost of NPV as per the guidelines issued by the MoEF &CC, GoI on dt. 06.01.2022 @ Rs.9,57,780/- ha vide his office Memo No.5623 dt. 29.09.2022 with request to the user agency to deposit the differential Cost of NPV. The user agencies vide its L.No.436 dt. 05.04.2023 has cited the guidelines of MoEF &CC, GoI dt. 22.03.2022 stated that the new rate is not applicable for the project as the project has accorded Stage-I approval on 01.05.2018.The demand letter, deposit challan etc are enclosed as **Annexure-II** series.

**Condition No.(iii):-** *At the time of payment of the Net Present Value (NPV) at the present rate, the user agency shall furnish an undertaking to pay the additional amount of NPV, if so determined, as per the final decision of the Hon'ble Supreme court of India.*

**Compliance:-** In compliance to the above, the user agency has furnished an undertaking to pay the additional amount of NPV , if so determined, as per the final decision of the Hon'ble Supreme Court of India of India, which is enclosed as **Annexure-III.**

**Condition No. (iv):-** *Compensatory afforestation shall be raised over 9.441 Ha of non forest land identified in plot no. 1292, Khata No. 1/1, Kisam- Ghasapadia of village Kello under Bonai Tahasil of Sundergarh district against the area of forest land proposed to be diverted at the cost of the user agency.*

**Compliance:-** In compliance to the above, the DFO, Sambalpur has reported that the Compensatory afforestation shall be raised over 9.441 Ha of non-forest land identified in Plot No. 1292, Khata No. 1/1, Kisan- Ghasapadia of village Kello under Bonai Tahasil of Sundergarh district against 9.441 ha of forest land proposed to be diverted. Accordingly the DFO, Bonai Forest Division has prepared the Compensatory Afforestation Scheme to take up Block plantation @ 1600 plants/ ha over 7.453 ha and ANR with gap plantation @ 200 plants per ha over 1.958 ha at the wage rate of Rs.213.50/- per MD with 10 years maintenance.

The financial outlay of CA scheme was technically approved by Addl. PCCF (FD & NO, FC Act) for Rs.23,17,800/- at the wage rate of Rs.213.50/- per M/D. DFO, Sambalpur had requested to DFO, Bonai to raise demand for the approved CA Scheme. DFO, Bonai vide his office Memo No.7354 dt.16.07.2018 has raised demand to deposit levy towards the CA. The user agency has already deposited a sum of Rs.23,17,800/ towards compensatory afforestation in Ad-hoc CAMPA, Corporation Bank, New Delhi A/C No. 520101263743655 IFSC code-CORP0000371 through online payment mode vide electronic Cheque no.70209, dt.30.07.18 and UTR No. U000000458922700. The above mentioned amount have been credited to SB A/c No 52010126374655 maintained in the Compensatory Afforestation Fund, Odisha in Corporation Bank, Lodhi Complex, New Delhi-110003 as confirmed by the DIG Adhoc- CAMPA vide his letter no 1-26/2014-CAMPA dated 23rd January 2019. Due to enhancement of wage rate the financial out lay of the above CA scheme has been revised @Rs.280/- Per MD and technically approved by Addl. PCCF(FD&NO,FC Act) amounting to Rs.24,99,000/-. The differential amount of Rs.1,81,200/- (Rs.24,99,000 – Rs.23,17,800/-) has been demanded by DFO, Sambalpur vide his office Memo No.475 dt. 15.02.2019 and the said amount has already been deposited by user agency to Adhoc - CAMPA Corporation Bank, New Delhi A/C No.-150825722787751, IFSC code-CORP0000371. Once again the CA scheme has been revised @ Rs 326/- per M/D by the CCF (FD&NO,FC Act) with a financial out lay of Rs.47,51,500/- .DFO, Sambalpur has raised demand vide his Memo No. 5644 dt. 30.09.2022 to deposit the differential amount of CA. The User Agency has deposited the differential amount of Rs.22, 52,500/- in Adhoc CAMPA, Union Bank of India, New Delhi A/C No.-150825722787775, IFSC code-UBIN0996335 through online portal of MoEF & CC. The CA scheme has revised due to hike in wage rate by from Nodal wing @ 333/MD for Rs.47,92,200/-.DFO, Sambalpur has raised demand vide his office Memo No. 1878 dt. 22.03. 2023 to deposit the differential amount of CA. The UA has deposited Rs.40,700/- in A/C No. 150825722787291, IFSC code –UBIN 0996335, UTR No. SBIN 523088680552 dt. 29.03. 2023. The documents of the compliance are enclosed as **Annexure-IV series**.

**Condition No-(v):-** *The non-forest land identified for raising compensatory afforestation shall be transferred and mutated in favour of the State Forest Department before issue of Stage-II approval.*

**Compliance:-** In compliance to the above, the RCCF, Sambalpur Circle has reported that the non-forest land identified for raising compensatory afforestation has already been transferred and mutated in favour of the State Forest Department. In this regard, the Tahasildar, Bonai has issued RoR vide alienation Case No. 5/2019, bearing Khata No.1/2, Plot No.1292/1603 over an area 9.4409 of Village Kelo of Tahasil Bonai vide his office L.No.982 dt. 18.05.2020 addressed to DFO, Bonai. The documents to the compliance are enclosed as **Annexure-V Series**.

**Condition No. (vi):-** *State Govt. will formulate compensatory afforestation scheme with focused soil & moisture conservation along with regeneration, cleaning, silvicultural activities and shall ensure maintenance of these plantations for a period of seven years to ten years as per requirement.*

**Compliance:-** In compliance to the above, the RCCF, Sambalpur Circle has reported that the DFO, Bonai Forest Division in whose jurisdiction the identified land for compensatory afforestation falls, had formulated the Compensatory Afforestation Scheme with an estimated cost of Rs.23,17,800/- (Twenty three lakhs seventeen thousand eight hundred) only with due focus on Soil & Moisture Conservation along with regeneration, cleaning, silvicultural activities based on the site condition with 10 years maintenance. The above scheme has already been approved Addl. PCCF (FD & NO FC Act) for Rs.23,17,800/- at the wage rate of Rs.213.50/- MD enclosed in the **Annexure-III series**. The approved CA scheme has been submitted along with the diversion proposal itself.

**Condition No.(vii):-** *The non-forest land over which compensatory afforestation will be taken up shall be notified as PF/RF and shall remain under the administrative control of the State Forest Department.*

**Compliance:-** In compliance to the above, the RCCF, Sambalpur Circle has reported that the non forest land over which compensatory afforestation will be taken up has already mutated land has been notified as PF under Section-33 of O.F.A, 1972 by Forest, Environment and Climate Change Department, Government of Odisha vide Notification No.15724 dt. 03.09.2021 as Kello Protected Forest over 9.441 ha in Bonai forest Division, which is enclosed as **Annexure-VI**.

**Condition No.(viii):-** *The user agency shall comply with the conditions stipulated by State Govt. vide letter No.10F(Cons)276/2016-7866/F&E dated 06.04.2018.*

The compliance to the conditions stipulated by the State Government at the time of forwarding the proposal to MoEF &CC, GoI dt. 06.04.2018 are furnished below.

**State Condition No. 14(A) :-***The user agency shall pay towards cost of removal of trees enumerated before commencement of work on Stage-II approval and tree felling should be taken up in phases strictly as per requirement under the supervision of the Divisional Forest Officer, Sambalpur Division.*

**Compliance:-**It is reported by the RCCF, Sambalpur that the tree felling on non-forest land of the project has been taken up in phased manner as per the field requirement by the user agency .In 1<sup>st</sup> phase DFO, Sambalpur vide his office memo no. 2917 dt. 01.06.2018 has allowed to fell 1847 trees and has requested the user agency to deposit the royalty of trees to the Tahasildar, Sambalpur. The royalty has been assessed as Rs.23,39,330/-.The user agency has deposited Rs.23,39,330/- to the Tahasildar, Sambalpur online in the A/C No.10856686466,IFSC Code-SBIN0000175 on through transfer of e- cheque No.70208 dt. 30.07.2018. General Manager(c), Sambalpur zone of OFDC Ltd. has raised demand for cutting & removal charge of 1847 trees vide L. No.1367 dt. 13.08.2018.The user agency has also deposited Rs. 43,69,328/- to the MD,OFDC Ltd., Sambalpur (C/KL) online to the A/C No.041302000000242,IFSC Code-IOBA0000413 through e- cheque 70241 dt. 21.12.2018. In 2<sup>nd</sup> phase DFO, Sambalpur vide his office memo no. 5563 dt. 05.11.2018 has allowed to fell 2699 trees and has requested the user agency to deposit the royalty of trees to the Tahasildar, Sambalpur .The royalty has been assessed as Rs.15,98,093/-.The user agency has deposited Rs.15,98,093/- to the Tahasildar ,Sambalpur online in the A/C No.10856686466,IFSC Code-SBIN0000175 through e- cheque No. 70248 on dt. 22.12.2018. General Manager(c), Sambalpur zone of OFDC Ltd. has raised demand for cutting & removal charges of 2699 trees vide L. No. 193 dt. 01.02.2019. The user agency has also deposited Rs.52,99,118/- to the MD, OFDC Ltd., Sambalpur (C/KL) online to the A/C No.041302000000242, IFSC Code-IOBA0000413 through e- cheque No. 70259 dt. 21.02.2019. The user agency has also deposited to the MD, OFDC Ltd. ,Sambalpur (C/KL) online through e-cheque No. 190427 dt. 13. 02.2020 for felling and removal of 115 trees standing on Lamdunguri RF. The documents to the compliance are enclosed

**Annexure-VII (a)**

**State Condition No. 14(B):-** *Environment clearance, if required, shall be obtained by the user agency before construction activities take place in the project site.*

**Compliance: -** It is reported by the RCCF, Sambalpur that the Ministry of Environment, Forest & Climate Change, GoI has accorded Environmental Clearance in favour of the user agency vide L .No. J-12011/25/2017-IA.1 (Part file) dt. 02. 07. 2018. The supporting documents are enclosed as

**Annexure-VII (b).**

**State Condition No. 14( c) :-** *This being applied as linear project, the user agency shall bear the cost of plantation of 10 times the no. of plants in an area to be specified by the DFO, Sambalpur preferably in close proximity to the project area.*

**Compliance:-**It is reported by the RCCF, Sambalpur that the Scheme for 10 times plantation of 9.441 ha of forest land in Lamdunguri RF for construction of Additionally spillway of Hirakud Dam Project in Sambalpur district with financial outlay of Rs.5,07,51,044/- has been approved by



him and communicated to DFO, Sambalpur vide his office Memo No.286 dt. 04.02.2020. The DFO, Sambalpur vide his Memo No.1084 dt.13.02.2020 has raised demand to user agency. The user agency has deposited on line Rs.5,07,51,044/- in S.B A/c No. 252301000418, IFSC code-ICIC 0002523 in the name of Divisional Forest Officer, Sambalpur dt. 24.03.2020. The documents to the compliance are enclosed as **Annexure-VII(c)**.

**State Condition No. 14 (D):-** *As has been decided by Government in WR Department, the project affected persons shall be provided with compensation /R/R benefits before the project work gets underway with approval of MoEF&CC, ERO.*

**Compliance:** - In compliance to the above, the RCCF, Sambalpur Circle has reported that the Compensation to the project affected persons has already been started. Payment towards compensation has already been done to the PAFs of Re-rolling colony, Cable colony, Premnagar, plots has been allotted and they have vacated their quarter. Allotment of plots and payment to the PAFs of First Gap & Gujatal is progress. PAFs have started construction of their house at allotted plots in R&R colony.

**Condition No. (ix):-** *All the funds received from the user agency under the project shall be transferred through e-portal to the Ad-hoc CAMPA in the Saving Bank Account pertaining to the State concerned. The user agency should ensure that the compensatory levies (CA cost, NPV etc) are deposited through challan generated online on web portal and deposited in appropriate bank online only. Amount deposited through other mode will not be accepted as compliance of the Stage-I clearance.*

**Compliance:-** In compliance to the above, the RCCF, Sambalpur Circle has reported that all the funds (CA Cost, NPV etc) received from the User Agency under this project have been transferred through e-portal to the Ad-hoc CAMPA in the Saving Bank Account using e-payment module of Ministry of Environment, Forests & Climate Change, Government of India. The details of Compensatory Levies deposited in the prescribed format are enclosed as **Annexure-L** to the compliance and tabulated as follows:

**Condition No.(x):-** The boundary of the forest land proposed to be diverted shall be demarcated on the ground at the project cost, erecting four feet reinforced cement concrete pillars, each inscribed with its serial number, DGPS coordinates, distance from adjoining pillars etc. As per Ministry Letter No.13-20/2015-CAMPA dated 09.06.2016, the cost of expenditure like boundary walls, stone pillars, demarcation charges, charges for felling of trees and their transportation to depots shall be deposited with DFOs concerned and the work should be undertaken departmentally in order to ensure that the task of erection of boundary walls, stone pillars, demarcation charges etc. are undertaken faithfully and in the best interest of the forests before the diversion and handing over of the forest land takes place. The work on these items should be completed within 6 months from the grant of final approval to diversion of forest land.

**Compliance:-** In compliance to the above, the RCCF, Sambalpur Circle has reported that the boundary of the forest land proposed for diversion has already been demarcated on the ground through erected reinforced cement concrete pillars based on the digital survey. The serial number, the DGPS co-ordinates and distance from pillar to pillar have been inscribed on the pillars at the cost of the user agency. The copy of the DGPS map is enclosed in the compliance along with The necessary undertaking in this regard is enclosed as **Annexure-VIII series**.

**Condition No. (xi):-** The state forest department /UA shall submit the surveyed sketch of non-forest land identified for CA, giving the forward and backward bearing of each demarcation pillar and distance between them. The state forest department /User Agency shall submit the DGPS reading of each demarcated pillar giving latitude and the longitude.

**Compliance:-** In compliance to the above, the RCCF, Sambalpur Circle has reported that the user agency has submitted the digitally surveyed map of the non-forest land identified for CA over 9.441 ha in plot no. 1292, Khata No. 1/1, Kisam-Ghasapadia of village Kello, under Bonai Tahasil of Sundergarh District with the forward & backward bearings of each demarcated pillar and distance between them which is enclosed as **Annexure-IX**.

**Condition No. (xii):-** *The user agency shall plant trees in available vacant spaces, as per feasibility, around the project site at their own cost, maintaining a record and for annual report, self compliance submission.*

**Compliance:-** In compliance to the above, the RCCF Sambalpur Circle has reported that the user agency has furnished an undertaking that they shall plant trees in available vacant spaces as per feasibility around the project site at their own cost maintaining a record and also submit the annual self compliance report which is enclosed as **Annexure-X**.

**Condition No. (xiii):-** *No labour camp shall be established on the forest land.*

**Compliance:-** In compliance to the above, the RCCF Sambalpur Circle has reported that the user agency has furnished an undertaking that no labour camp shall be allowed in the forest land which is enclosed as **Annexure-XI**.

**Condition No. (xiv):-** *The user agency shall provide alternate fuel preferably LPG to the labourers and the staff working at the site so as to avoid any damage and pressure on the adjacent forest areas.*

**Compliance:-** In compliance to the above, the RCCF Sambalpur Circle has reported that the user agency has furnished an undertaking that they shall provide alternate fuel preferably LPG to the laborers and the staff working at the site, to avoid any damage and pressure on the adjacent forest areas which is enclosed as **Annexure-XII**.

**Condition No. (xv):-** *No additional or new path will be constructed inside the forest area for any activity related to the project work.*

**Compliance:-** In compliance to the above, the RCCF Sambalpur Circle has reported that the user agency has furnished an undertaking that no additional or new path shall be constructed inside the forest area for any activity related to the project work which is enclosed as **Annexure-XIII**.

**Condition No. (xvi):-** *Earth or any material shall neither be brought from nor the debris resulting during construction be deposited of in the adjoining forest area by the user agency.*

**Compliance:-** In compliance to the above, the RCCF, Sambalpur Circle has reported that the user agency has furnished an undertaking that the earth or any material shall neither be brought from nor the debris resulting during construction be deposited of in the adjoining forest area by the user agency which is enclosed as **Annexure-XIV**.

**Condition No. (xvii):-** *The user agency while executing works, shall not fell any tree or damage forest growth in the surrounding forest area in any manner.*

**Compliance:-** In compliance to the above, the RCCF, Sambalpur Circle has reported that the user agency has furnished an undertaking that while executing works, shall not fell any tree of damage forest growth in the surrounding forest area in any manner which is enclosed as **Annexure-XV**.

**Condition No. (xviii):-** *The forest land shall not be used for any purpose other than that specified in the proposal and under no circumstances be transferred to any other user agency, department or person without prior approval of the Ministry of Environment, Forest & Climate Change.*

**Compliance:** - In compliance to the above, the RCCF, Sambalpur Circle has reported that the user agency has furnished an undertaking that the forest land shall not be used for any purpose other than specific in the proposal and under no circumstances be transferred to any of the user agency, department or person without prior approval of the Ministry of Environment, Forest & Climate Change which is enclosed as **Annexure-XVI**.

**Condition No. (xix):-** *The State Government shall complete settlement of rights, in term of the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006, if any, on the forest land to be diverted and submit the documentary evidence as prescribed by this Ministry in its letter No. 11-9/1998-FC (pt) dated 03.08.2009 read with letter no.11-9/1998-FC (pt.) dated 05.02.2013 and 05.07.2013, in support thereof. The user agency shall submit original FRA certificate before issue of Stage-II approval.*

**Compliance:-** In compliance to the above, the RCCF, Sambalpur Circle has reported that there is no habitation of Schedule Tribe and Other Traditional Forest Dwellers in the proposed diverted forest land. The copy of original FRA certificate is annexed as **Annexure- XVII**.

**Condition No. (xx):-** *Any other condition that Ministry of Environment, Forest & Climate Change may stipulate, from time to time, in the interest of conservation, protection and development of forests & wildlife shall be complied by the user agency.*

**Compliance: - In** compliance to the above, the RCCF, Sambalpur Circle has reported that the user agency has furnished an undertaking that any other condition that Ministry of Environment, Forest & Climate Change may stipulate, from time to time, in the interest of conservation, protection and development of forests & wildlife will be complied by the user agency, which is enclosed as **Annexure- XVIII**

**Condition No. (xxi):-** *The State Government and the user agency shall ensure compliance to provisions of the all Acts, Rules, Regulations, Guidelines, NGT Order (s) & Hon'ble Court Order (s) pertaining to this project, if any, for the time being in force, as applicable to the project.*

**Compliance:-** In compliance to the above, the RCCF, Sambalpur Circle has reported that the user agency has submitted an undertaking duly countersigned by the DFO, Sambalpur Forest Division to comply all the provisions of all Acts, Rules, Regulations, Guidelines, NGT Court Order (s) & Hon'ble Court Order (s) pertaining to this project as applicable. The undertaking duly furnished by the user agency is enclosed as in **Annexure-XIX**.

**Additional Conditions imposed by the State Govt vide their letter No.10F (Cons) 276/2016-7866/F&E, Bhubaneswar dated 06.04.2018**

The compliance to the additional conditions imposed by the State Government vide L. No. 10F (Cons) 276/2016-7866/F&E dt. 06.04.2018 have been furnished in the compliance to the condition No. (viii) of the MoEF & CC ,GoI above.
