**Sub: Diversion of 3.347 ha of Forest Land (1.445 ha in Balasore (WL) Division , 0.337 ha in Bhadrak (WL) Division and 1.565 ha in Mangrove (WL), Division Rajnagar for laying of 660 mm (26") dia Crude Oil pipeline along with 51 mm optical Fiber Cable in respect of Paradeep-Numaligarh Crude Oil Pipeline Project in District of Balasore, Bhadrak, Jagatsinghpur and Kendrapada of Odisha in favour of Numaligarh Refinery Limited, Assam – Stage-I compliance regarding.**

**Ref:- Letter No.5-ORB549/2023-BHU dated 28.03.2023 of the Deputy Inspector General of Forests (C), GoI, MoEF& CC, Regional Office, Bhubaneswar.**

Sir,

In inviting reference to the above mentioned subject, this is to inform that Government of India, Ministry of Environment, Forest & Climate Change, Regional Office, Bhubaneswar has accorded Stage-I/In-principle approval vide their letter No. 5-ORB549/2023-BHU dated 28.03.2023 in respect of diversion of 3.347 ha forest land (1.445 ha in Balasore (WL) Division , 0.337 ha in Bhadrak (WL) Division and 1.565 ha in Mangrove (WL), Division Rajnagar for laying of 660 mm (26") dia Crude Oil pipeline along with 51 mm optical Fiber Cable in respect of Paradeep-Numaligarh Crude Oil Pipeline Project in District of Balasore, Bhadrak, Jagatsinghpur and Kendrapada of Odisha in favour of Numaligarh Refinery Limited, Assam in State of Odisha subject to fulfillment of 8 nos. of conditions prior to handing over of forest land by the State Forest Department and 23 nos. of conditions after handing over of forest land to the User Agency by the State Forest Department. The point wise compliances based on the reports of the FD,STR-cum-RCCF, Baripada Circle & RCCF, Bhubaneswar Circle pertaining to Balasore (WL) Division, Bhadrak (WL) Division and Mangrove (WL), Division Rajnagar are as follows:-

***Condition No.-i: The user agency shall transfer online, the Net Present Value (NPV) of 3.347 ha forest land being diverted under this proposal, as per the Orders of Hon'ble***

*Supreme Court of India dated 28.03.2008, 24.04.2008 and 09.05.2008 in Writ Petition (Civil) No.202/1995 and the guidelines issued by this Ministry vide its letter No.5-3/2011-FC (Vol-1) dated 06.01.2022, 19.01.2022 & 22.03.2022. The requisite funds shall be transferred through online portal in CAMPA account of the State concerned.*

**Compliance:** In compliance to the above the FD,STR-cum-RCCF, Baripada Circle and RCCF, Bhubaneswar Circle have reported that, the user agency has deposited an amount of Rs.32,05,691/- out of the total deposited amount of Rs.68,05,391/- towards the cost of NPV of the total forest land being diverted under this proposal over 3.347 ha (1.445 ha in Balasore (WL) Divn., 0.337 ha in Bhadrak (WL) Division and 1.565 ha in Mangrove (WL) Division, Rajnagar under this proposal to Odisha State CAMPA Account in parivesh portal. Regarding proof of such payment of the NPV amount, the demand notice of the DFOs concerned vide their Memo No.3411 dt.06.05.2023, No.1607 dt.18.04.2023 and No.2466 dt.18.04.2023 respectively alongwith the deposit particulars made by the UA like deposit challan dt.15.05.2023 with UTR No. SBIN423166487174 dt.16.07.2023 are enclosed as **Annexure-A & B** respectively.

**Condition No.-ii:** *The land identified for the purpose of Compensatory Afforestation shall be clearly depicted on a Survey of India Topo sheet of 1: 50,000 scale.*

**Compliance:** In compliance to the above the FD,STR-cum-RCCF, Baripada Circle and RCCF, Bhubaneswar Circle have reported that, the user agency has furnished the Topomap No.F45U11 in 1:50,000 scale showing the CA land identified for the project which is enclosed as **Plate-1** duly countersigned by the user agency and the DFO, Mangrove (WL) Division Rajnagar.

**Condition No.-iii:** *The user agency shall transfer the cost of raising and maintaining the compensatory afforestation/additional compensatory afforestation at the current wage rate in consultation with State Forest Department in the account of CAMPA of the concerned State through online portal. The Scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years.*

**Compliance:** In compliance to the above the RCCF, Bhubaneswar Circle has reported that, the user agency has deposited an amount of Rs.35,99,700/- out of total deposited amount of Rs.68,05,391/- towards the cost of raising of CA / Additional CA etc. under this proposal to Odisha State CAMPA Account in parivesh portal. Regarding proof of such payment the demand notice of the DFO, Mangrove (WL) Division , Rajnagar vide his Memo No.2466 dt.18.04.2023 alongwith the deposit particulars made by the UA like deposit challan dt.15.05.2023 with UTR No. SBIN423166487174 dt.16.07.2023 are enclosed as **Annexure-A & B** respectively.

**Condition No.-iv:** *The KML files of the area to be diverted and the CA areas shall be uploaded on the e-Green watch portal with all requisite details before issuing working permission towards linear projects or submitting compliance report for seeking Stage-II approval, as the case may be.*

**Compliance:** In compliance to the above the FD,STR-cum-RCCF, Baripada Circle and RCCF, Bhubaneswar Circle have reported that, the user agency has already uploaded the KML file of the area to be diverted and the CA area under this proposal on e-green-watch portal with all requisite details before issue of working permission in their favour.

**Condition No.-v:** *All the funds received from the user agency under the project shall be transferred deposited i CAMPA account only through e-portal (<https://parivesh.nic.in/>). Amount deposited through other mode will not be accepted as compliance of the Stage-I clearance*

**Compliance:** In compliance to the above the FD,STR-cum-RCCF, Baripada Circle and RCCF, Bhubaneswar Circle have reported that, the user agency has deposited all the following compensatory levies in Odisha State CAMPA Account through e-portal. The details of payment made thereof against the three nos. of divisions are as follows. Regarding proof of such payment the 12 point CAMPA format furnished by the DFOs concerned are enclosed as **Annexure-C Series.**, and have also been enclosed as **Annexure-A&B.**

**Condition No.-vi:** *The compliance report of the Stage-I approval shall be uploaded on e-portal (<https://parivesh.nic.in/>).*

**Compliance:** In compliance to the above the FD,STR-cum-RCCF, Baripada Circle and RCCF, Bhubaneswar Circle have reported that, the user agency has already given an undertaking to upload the compliance report of the Stage-I approval in respect of the above three division duly countersigned by the DFOs concerned which are enclosed as **Annexure- C(A) Series.**

**Condition No.-vii:** *The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector.*

**Compliance:** In compliance to the above the FD,STR-cum-RCCF, Baripada Circle and RCCF, Bhubaneswar Circle have reported that, the Collector , Balasore District has issued the FRA certificate against diversion of 1.445 ha of forest land under Balasore (WL) Division vide his letter No.1273 dt.05.07.2023, Collector, Bhadrak District has issued FRA certificate against diversion of 0.337 ha of forest land under Bhadrak (WL) Division vide his letter No.935 dt.20.07.2023 and Office Order No.925 dt.15.07.2023 and similarly Collector, Kendrapara

District has issued FRA certificate against diversion of 0.6101 ha of forest land vide his letter No.1623 dt.17.08.2023 & O.O.No.1616 dt.17.08.2023 and Collector Jagatsinghpur District has also issued FRA certificate over 0.955 ha of forest land diverted (so all total  $0.6101 + 0.955$  ha = 1.5651 ha of forest land diverted ) under Mangrove (WL) Division, Rajnagar. All the above FRA certificate are enclosed as **Annexure – D Series**.

***Condition No.-viii: The boundary of the proposed forest land for diversion, shall be demarcated on ground at the project cost, by erecting four feet high reinforced cement concrete pillars, each inscribed with its serial number, distance from pillar to pillar and GPS co-ordinates.***

***Compliance:*** In compliance to the above the FD,STR-cum-RCCF, Baripada Circle and RCCF, Bhubaneswar Circle have reported that, the boundary of the proposed forest land to be diverted over 3.347 ha of Forest Land (1.445 ha under Balasore (WL) Division , 0.337 ha under Bhadrak (WL) Division and 1.565 ha under Mangrove (WL), Division Rajnagar have already been demarcated on the ground by erecting 4 feet high RCC pillars and each boundary pillar inscribed with its Sl No., GPS Coordinates & distance from pillar to pillar. In proof of the same the details of the pillars posted around the proposed diverted land, with Sl. No., GPS Coordinate and pillar to pillar distance under three divisions mentioned above with due countersignature of the user agency and DFO concerned are furnished in separate booklet form enclosed as **Annexure-X Series**.

***B: Conditions which need to be strictly complied on field after handing over of forest land to the user agency by the State Forest Department but the compliance in form of undertaking shall be submitted prior to Stage-II approval.***

***Condition No.-i: Legal status of forest land proposed for diversion shall remain unchanged.***

***Compliance:*** In compliance to the above the FD,STR-cum-RCCF, Baripada Circle and RCCF, Bhubaneswar Circle have reported that, the user agency has furnished undertaking that the “Legal status of forest land proposed for diversion shall remain unchanged” duly countersigned by the DFOs concerned which are enclosed as **Annexure E Series**.

***Condition No.-ii: Compensatory afforestation shall be raised over 7.00 ha degraded forest land identified in Patchhela PRF of Mahakalapada WL. Range under Mangrove (WL) Division, Rajnagar within three years from the date of Stage-II Clearance and maintained thereafter by the State Forest Department, at the cost of user agency. The trees shall be indigenous to the area and naturally growing species shall be planted using intensive planting technique to ensure survival of the plantation. Intensive monitoring of the plantation needs to be done and documented using Geo tagging so that the increase of canopy density and survival and growth of plantation can be evaluated at regular intervals.***

***Compliance:*** In compliance to the above the RCCF, Bhubaneswar Circle has reported that, the user agency has already deposited an amount of Rs.35,99,700/- towards the cost of CA in Odisha State CAMPA Account through e-payment in parivesh portal vide UTR No. SBIN423166487174 dt.16.07.2023. Regarding proof of such payment against the approved CA

scheme vide this office Memo No.1168 dt.21.10.2023, demand letter of the DFO, Mangrove (WL) Division Rajnagar and the deposit particulars made by the UA like deposit challan copy etc. are enclosed as **Annexure-A & B** respectively. Compensatory Afforestation shall be raised in Patchhela PRF under Mahakalapada (WL) Range under Mangrove (WL) Division Rajnagar as per the CA scheme approved by this office.

**Condition No.-iii:** *The user agency shall implement intensive Soil & Moisture Conservation measures along both sides of the proposed crude oil pipeline corridor passing through forest area at project cost in consultation with DFO.*

**Compliance:** In compliance to the above the FD,STR-cum-RCCF, Baripada Circle and RCCF, Bhubaneswar Circle have reported that, the user agency has submitted undertaking that “*They shall implement intensive Soil & Moisture Conservation measures along both sides of the proposed crude oil pipeline corridor passing through forest area at project cost in consultation with DFO*” duly countersigned by the DFOs concerned which are enclosed as **Annexure F Series**.

**Condition No.-iv:** *The user agency shall take all measures for protection and conservation of wildlife in the area.*

**Compliance:** In compliance to the above the FD,STR-cum-RCCF, Baripada Circle and RCCF, Bhubaneswar Circle have reported that the user agency has submitted undertaking that “*the user agency shall take all safety measures for protection and conservation of wildlife in the area during execution of the work*” duly countersigned by the DFOs concerned which are enclosed as **Annexure W Series**.

**Condition No.-v:** *The State Govt. shall ensure the implementation the guidelines letter No.FE-DIV-MISC-0024- 2021-16250/FE&CC dated 13.09.2021.*

**Compliance:** In compliance to the above the FD,STR-cum-RCCF, Baripada Circle and RCCF, Bhubaneswar Circle have reported that all the DFOs concerned have furnished undertaking that “*the State Govt. shall ensure the implementation of the guidelines vide letter No.FE-DIV-MISC-0024- 2021-16250/FE&CC dated 13.09.2021*” duly signed by them which are enclosed as **Annexure W(A) Series**.

**Condition No.-vi:** *At the time of payment of Net Present Value (NPV) at the then prevailing rate, the user agency shall furnish an undertaking to pay the additional amount of NPV, if so determined, as per the final decision of the Hon'ble Supreme Court of India.*

**Compliance:** In compliance to the above the FD,STR-cum-RCCF, Baripada Circle and RCCF, Bhubaneswar Circle have reported that, the user agency has furnished undertaking that “*At the time of payment of Net Present Value (NPV) at the then prevailing rate, to pay the additional*

amount of NPV, if so determined, as per the final decision of the Hon'ble Supreme Court of India" duly countersigned by the DFOs concerned which are enclosed as **Annexure G Series**.

**Condition No.-vii:** *The user agency shall obtain Environmental Clearance as per the provisions of Environment (Protection) Act, 1980, if applicable.*

**Compliance:** In compliance to the above the FD,STR-cum-RCCF, Baripada Circle and RCCF, Bhubaneswar Circle have reported that, the proposed project does not require prior environmental clearance as per the provision under environment (protection ) Act, 1980. However the user agency has furnished an undertaking to obtain environment clearance if applicable duly countersigned by the DFOs concerned which are enclosed as **Annexure H Series**.

**Condition No.-viii:** *The pipeline shall be laid down 1.2 meter below the ground in forest area as proposed by the State Govt. and after laying down of pipe line the ground will be levelled.*

**Compliance:** In compliance to the above the FD,STR-cum-RCCF, Baripada Circle and RCCF, Bhubaneswar Circle have reported that, the user agency has furnished undertaking that "the pipeline shall be laid down 1.2 meter below the ground in forest area as proposed by the State Govt. and after laying down of pipe line the ground will be levelled" duly countersigned by the DFOs concerned which are enclosed as **Annexure I Series**.

**Condition No.-ix:** *The user agency shall take adequate safety measures for accidental leakage of oil product pipeline.*

**Compliance:** In compliance to the above the FD,STR-cum-RCCF, Baripada Circle and RCCF, Bhubaneswar Circle have reported that, the user agency has furnished undertaking that "They shall take adequate safety measures for accidental leakage of oil product pipeline" duly countersigned by the DFOs concerned which are enclosed as **Annexure J Series**.

**Condition No.-x:** *The user agency shall implement intensive Soil & Moisture Conservation measures along both sides of the proposed gas pipeline corridor passing through forest area at project cost.*

**Compliance:** In compliance to the above the FD,STR-cum-RCCF, Baripada Circle and RCCF, Bhubaneswar Circle have reported that, the user agency has furnished undertaking that "They shall implement intensive Soil & Moisture Conservation measures along both sides of the proposed gas pipeline corridor passing through forest area at project cost" duly countersigned by the DFOs concerned which are enclosed as **Annexure K Series**.

**Condition No.-xi:** *No labour camp shall be established on the forest land and the user agency shall provide fuels preferably alternate fuels to the labourers and the staff working at the site so as to avoid any damage and pressure on the nearby forest areas*



**Compliance:** In compliance to the above the FD,STR-cum-RCCF, Baripada Circle and RCCF, 113  
Bhubaneswar Circle have reported that, the user agency has furnished undertaking *"That no labour camp shall be established on the forest land and they shall provide fuels preferably alternate fuels to the labourers and the staff working at the site so as to avoid any damage and pressure on the nearby forest areas"* duly countersigned by the DFOs concerned which are enclosed as **Annexure L Series**.

**Condition No.-xii:** *No additional or new path will be constructed inside the forest area for any activity related to the project work.*

**Compliance:** In compliance to the above the FD,STR-cum-RCCF, Baripada Circle and RCCF, Bhubaneswar Circle have reported that, the user agency has furnished undertaking that *"no additional or new path will be constructed inside the forest area for any activity related to the project work"* duly countersigned by the DFOs concerned which are enclosed as **Annexure M Series**.

**Condition No.-xiii:** *The user agency while executing works, shall not fell any tree or damage forest growth in the surrounding forest area in any manner.*

**Compliance:** In compliance to the above the FD,STR-cum-RCCF, Baripada Circle and RCCF, Bhubaneswar Circle have reported that, the user agency has furnished undertaking that *"While executing works, they shall not fell any tree or damage any forest growth in the surrounding forest area in any manner"* duly countersigned by the DFOs concerned which are enclosed as **Annexure N Series**.

**Condition No.-xiv:** *The user agency shall explore the possibility of successful transplantation of maximum number of trees identified to be felled and shall ensure that any tree felling shall be done only when it is unavoidable and that too under strict supervision of the State Forest Department.*

**Compliance:** In compliance to the above the FD,STR-cum-RCCF, Baripada Circle and RCCF, Bhubaneswar Circle have reported that, the user agency has furnished undertaking *"that they shall explore the possibility of successful transplantation of maximum number of trees identified to be felled and shall ensure that any tree felling shall be done only when it is unavoidable and that too under strict supervision of the State Forest Department"* duly countersigned by the DFOs concerned which are enclosed as **Annexure O Series**.

**Condition No.-xv:** *The layout plan of the proposed forest land shall not be changed without the prior approval of Ministry of Environment, Forest & Climate Change.*

**Compliance:** In compliance to the above the FD,STR-cum-RCCF, Baripada Circle and RCCF, Bhubaneswar Circle have reported that, the user agency has furnished undertaking *"that the layout plan of the proposed forest land shall not be changed without the prior approval of*



241 Ministry of Environment, Forest & Climate Change" duly countersigned by the DFOs concerned which are enclosed as **Annexure P Series**.

**Condition No.-xvi:** *The forest land shall not be used for any purpose other than that specified in the proposal.*

**Compliance:** In compliance to the above the FD,STR-cum-RCCF, Baripada Circle and RCCF, Bhubaneswar Circle have reported that, the user agency has furnished undertaking that "the forest land shall not be used for any purpose other than that specified in the proposal" duly countersigned by the DFOs concerned which are enclosed as **Annexure Q Series**.

**Condition No.-xvii:** *The forest land proposed to be diverted shall under no circumstances be transferred to any other user agency, department or person without the prior approval of Ministry of Environment, Forest & Climate Change.*

**Compliance:** In compliance to the above the FD,STR-cum-RCCF, Baripada Circle and RCCF, Bhubaneswar Circle have reported that, the user agency has furnished undertaking that "the forest land proposed to be diverted shall under no circumstances be transferred to any other user agency, department or person without the prior approval of Ministry of Environment, Forest & Climate Change" duly countersigned by the DFOs concerned which are enclosed as **Annexure R Series**.

**Condition No.-xviii:** *No damage to the flora and fauna of the adjoining area shall be caused.*

**Compliance:** In compliance to the above the FD,STR-cum-RCCF, Baripada Circle and RCCF, Bhubaneswar Circle have reported that, the user agency has furnished undertaking that "no damage to the flora and fauna of the adjoining area shall be caused" duly countersigned by the DFOs concerned which are enclosed as **Annexure S Series**.

**Condition No.-xix:** *The concerned Divisional Forest Officer, will monitor and take necessary mitigative measures to ensure that there is no adverse impact on the forests in the surrounding area.*

**Compliance:** In compliance to the above the FD,STR-cum-RCCF, Baripada Circle and RCCF, Bhubaneswar Circle have reported that, all the above three nos. of DFOs concerned have submitted their undertaking that "they shall monitor and take necessary mitigative measures to ensure that there is no adverse impact on the forests in the surrounding area" which are enclosed as **Annexure S(A) Series**.

**Condition No.-xx:** *The user agency shall submit annual self monitoring report on compliance of stipulated conditions to the Nodal Officer (FCA) of the State and concerned Integrated Regional Office of this Ministry by the end of March every year.*



**Compliance:** In compliance to the above the FD,STR-cum-RCCF, Baripada Circle and RCCF, Bhubaneswar Circle have reported that, the user agency has furnished undertaking *"They shall submit annual self monitoring report on compliance of stipulated conditions to the Nodal Officer (FCA) of the State and concerned Integrated Regional Office of this Ministry by the end of March every year"* duly countersigned by the DFOs concerned which are enclosed as **Annexure T Series.**

**Condition No.-xxi:** *Any other conditions that the Ministry of Environment, Forests & Climate Change may impose from time to time in the interest of afforestation, conservation and management of flora and fauna in the area, shall be complied by the user agency.*

**Compliance:** In compliance to the above the FD,STR-cum-RCCF, Baripada Circle and RCCF, Bhubaneswar Circle have reported that, the user agency has furnished undertaking *that "any other conditions that the Ministry of Environment, Forests & Climate Change may impose from time to time in the interest of afforestation, conservation and management of flora and fauna in the area, shall be complied by them"* duly countersigned by the DFOs concerned which are enclosed as **Annexure U Series.**

**Condition No.-xxii:** *The State Govt. and user agency shall ensure compliance to provisions of the all Acts, Rules, Regulations, Guidelines, NGT Order (s) & Hon'ble Court Order (s) pertaining to this project, if any, for the time being in force, as applicable to the project.*

**Compliance:** In compliance to the above the FD,STR-cum-RCCF, Baripada Circle and RCCF, Bhubaneswar Circle have reported that, the user agency has furnished undertaking that *"the State Govt. and user agency shall ensure compliance to provisions of all the Acts, Rules, Regulations, Guidelines, NGT Order (s) & Hon'ble Court Order (s) pertaining to this project, if any, for the time being in force, as applicable to the project"* duly countersigned by the DFOs concerned which are enclosed as **Annexure V Series.**

**Condition No.-xxiii:** *Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as prescribed in Para 1.21 of Chapter 1 of the Handbook of comprehensive guidelines of Forest (Conservation) Act, 1980 as issued by this Ministry's letter No.5-2/2017-FC dated 28.03.2019.*

**Compliance:** In compliance to the above the FD,STR-cum-RCCF, Baripada Circle and RCCF, Bhubaneswar Circle have reported that, the user agency has furnished undertaking that *"violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as prescribed in Para 1.21 of Chapter 1 of the Handbook of comprehensive guidelines of Forest (Conservation) Act, 1980 as issued by this Ministry's letter No.5-2/2017-FC dated 28.03.2019"* duly countersigned by the DFOs concerned which are enclosed as **Annexure Y Series.**
