Diversion of 13.22 ha of forest land for construction of Khurda Road-Bolangir New Sub: B.G. Rail Link Project Phase-IV i.e. Km 180 to 238 Km under Boudh Forest Division-Stage-I compliance regarding

Sir,

In reference to the above mentioned subject, this is to inform that Government of India, Ministry of Environment, Forest & Climate Change, Integrated Regional Office, Bhubaneswar have accorded Stage-I approval vide their Letter F. No. 5-ORC441/2021-BHU dated 09.02.2021 for diversion of 13.22 ha of forest land for construction of Khurda Road-Bolangir New B.G. Rail Link Project Phase-IV i.e. Km 180 to 238 Km under Boudh Forest Division by East Coast Railway, subject to the fulfilment of the eleven (11) nos. of conditions under A and twenty one (21) nos. of conditions under B stipulated therein respectively. The User Agency has complied all the conditions imposed by the Government of India, MoEF & CC, IRO, Bhubaneshwar as well as one (1) no. of additional condition imposed by the State Government respectively. The point-wise compliances basing on the reports of the DFO, Boudh Forest Division and the RCCF, Berhampur Circle are as follows:-

A: Conditions which need to be complied prior to handing over of forest land by the State Forest Department

<u>Condition No.(i)</u>: - The user agency shall transfer online, the Net Present Value (NPV) of 13.22 ha of forest being diverted under this proposal as per the Orders of Hon'ble Supreme Court of India dated 28.03.2008, 24.04.2008 and 09.05.2008 in Writ Petition (Civil) No.202/1995 and the guidelines issued by this Ministry vide its letter No.5-3/2007-FC dated 05.02.2009. The requisite finds shall be transferred through online portal in CAMPA account of the State concerned.

Compliance: In Compliance to the above, the RCCF, Berhampur Circle has reported that the User Agency has deposited an amount of Rs.82,75,720/- in State CAMPA fund, Union Bank of India, Sundarnagar Branch, New Delhi vide UTR No.SBIN521125058845 dated 05.05.2021. The tabular statement of Eco-Value Class and density of the forest land proposed to be diverted for realization of NPV are given below:-

<u>Condition No.(ii)</u>: - The identified Revenue forest land of 13.26 ha for raising of additional compensatory afforestation shall be transferred and mutated in the name of Forest Department and notified as RF/PF prior to Stage-II approval.

Compliance: In Compliance to the above, the RCCF, Berhampur Circle has reported that, the identified Revenue forest land over 13.26 ha in village Balkira under Boudh Tahasil of Boudh District for raising of Addl. CA has been transferred and mutated in favour of the State Forest Department and a copy of the RoR in proof of the same is enclosed as **Annexure-II.** Further, the Draft PF Notification Proposal has already been sent to the Government in FE & CC Department vide this office Memo No.20942 dated 14.10.2022 for notification of PF (copy enclosed as

Annexure-IIA).

<u>Condition No.(iii)</u>: - The land identified for the purpose of Compensatory Afforestation and additional Compensatory Afforestation shall be clearly depicted on Survey of India Topo sheet of 1:50,000 scale.

Compliance: In Compliance to the above, the RCCF, Berhampur Circle has reported that, the land identified for raising of CA in Subarnagiri RF and Addl. CA in Revenue Forest land of village Balkira under Boudh Tahasil of Boudh District have been clearly depicted on Survey of India Topo sheet No.F45S2 and F45S1 enclosed as **Plate No.IIIA and IIIB respectively.** Also the DGPS surveyed CA land map duly authenticated by the ORSAC has been enclosed as **Annexure as Plate No. IIIC and IIID** respectively.

<u>Condition No.(iv)</u>: - The user agency shall transfer the cost of raising and maintaining the compensatory afforestation and additional compensatory afforestation at the current wage rate in consultation with State Forest Department in the account of CAMPA of the concerted State through online portal. The scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years.

Compliance: In Compliance to the above, the RCCF, Berhampur Circle has reported that the User Agency has deposited the amount of Rs.26,97,700/- towards cost of CA with 10 years maintenance over 26.44 ha of degraded forest land in Subarnagiri RF (Compartment No.1) and also an amount of Rs.43,87,500/- towards Addl. CA with 10 years maintenance cost over 13.26 ha of degraded Revenue forest kissam land in Village Balkira under Boudh Tahasil @ Rs.308/- per MD of wage rate in State CAMPA Fund, Union Bank of India, Sundarnagar Branch, New Delhi vide UTR No.SBIN521125058845 dated 05.05.2021. In proof of payment of the above cost of CA & Addl. CA, the financial outlay duly approved by Nodal Officer, downloaded copy of the payment particulars from the web-portal, payment challan with UTR number and demand notice of the DFO against the UA for payment of such CA and Addl. CA amount are enclosed as **Annexure-IVA**, **IVB, IVC & IVD** respectively.

Further, due to enhancement of wage rate @ Rs.326/- per MD, the UA has also deposited an amount of Rs.4,49,200/- towards differential amount of CA over 26.44 ha of degraded Reserve forest land in Subarnagiri RF Compartment-1 and an amount of Rs.1,98,500/- towards differential amount of Addl. CA over 13.26 ha of degraded Revenue Forest land in Balkira village of Boudh Tahasil of Boudh District respectively. Regarding proof of deposit of such differential amount of CA and Addl. CA, the financial outlay @ Rs.326/- per MD approved by Nodal Officer, downloaded copy of the payment particulars from the web-portal, payment challan with UTR number and demand notice of the DFO against the UA for payment of such differential amount has been enclosed as **Annexure-VA**, **VB**, **VC & VD** respectively.

<u>Condition No.(v)</u>: - The site specific wildlife conservation plan shall be prepared and duly approved by CWLW, Odisha may be implemented at project cost.

Compliance: In Compliance to the above, the RCCF, Berhampur Circle has reported that the user agency has deposited an amount of Rs.13,71,23,500/- towards implementation of the SSWLCP in project impact area over Boudh, Phulbani and Athmallik Forest Divisions pertaining to this project in ORISSA State CAMPA account fund, Union Bank of India, Sundarnagar Branch, New Delhi vide UTR No.SBIN321259433694 dated 16.09.2021. The SSWLCP has been duly approved by the PCCF (WL) & CWLW, Odisha for the above three (3) Divisions vide his letter No.8172 dated 26.08.2021. The details of amount realized from the UA for implementation of SSWLCP Division wise are given below:

Condition No.(vi): - All the funds received from the user agency under the project shall be transferred & deposited in CAMPA account only through e-portal (http://parivesh.nic.in/). Amount deposited through other mode will not be accepted as compliance of the Stage-I

Compliance: In Compliance to the above, the RCCF, Berhampur Circle has reported that the details of fund deposited by the user agency in State Ad-hoc CAMPA account towards all the Compensatory Levies deposited by the UA through challan generated online on web-portal of

PARIVESH are as follows:

In support of deposit of the above Compensatory levies by the user agency, the 12 Point CAMPA format furnished by the DFO, Boudh Division duly countersigned by Nodal Officer has been enclosed as Annexure-VII.

<u>Condition No.(vii)</u>: - The cost of felling of trees shall be deposited by the user agency with State Forest Department.

Compliance: In Compliance to the above, the RCCF, Berhampur Circle has reported that the user agency has informed regarding no tree felling is required for construction of Khordha Road -

Bolangir New BG Rail Link Project from 180-238 Km pertaining to Boudh Division. Hence, deposition of the cost of felling of trees is not required which is enclosed as Annexure-VIII.

Condition No.(viii): - The compliance report of the Stage-I approval shall be uploaded on eportal (http://parivesh.nic.in/).

Compliance: In Compliance to the above, the RCCF, Berhampur Circle has reported that the user agency has already uploaded the Stage-I compliance report on e-portal which is enclosed as Annexure-IX.

Condition No.(ix): The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector.

Compliance: In Compliance to the above, the RCCF, Berhampur Circle has reported that the user agency has furnished the FRA certificate issued by the Collector and District Magistrate, Boudh District vide Order No.964/SSD dated 23.07.2019 which is enclosed as Annexure-X.

<u>Condition No.(x)</u>: The boundary of the proposed forest land for diversion shall be demarcated on ground at the project cost by erecting four feet high reinforced cement concrete pillars each inscribed with its serial number, distance from pillar to pillar and GPS co-ordinates.

Compliance: In Compliance to the above, the RCCF, Berhampur Circle has reported that the boundary of the forest land proposed to be diverted has already been demarcated on the ground at the project cost by erecting four feet high reinforced cement concrete pillars around each patch of forest land covering all the villages each inscribed with its Serial number, DGPS co-ordinates, distance from pillar to pillar etc. The description of the pillar posted with its DGPS co-ordinates in the composite map is enclosed as Annexure-XI.

Condition No.(xi): Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as prescribed in Para 1.21 of Chapter-1 of the Handbook of comprehensive guidelines of Forest (Conservation) Act, 1980 as issued by this Ministry's letter No.5-2/2017-FC dated 28.03.2019.

Compliance: In Compliance to the above, the RCCF, Berhampur Circle has reported that the user agency has furnished an undertaking that the violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as prescribed in Para 1.21 of Chapter-1 of the Handbook of comprehensive guidelines of Forest (Conservation) Act, 1980 as issued by this Ministry's letter No.5-2/2017-FC dated 28.03.2019 which is enclosed as Annexure-XII.

B: Conditions which need to be strictly complied on field after handing over of forest land to the user agency by the State Forest Department but the compliance in form of undertaking shall be submitted prior to Stage-II approval.

Condition No.(i): - Legal status of forest land proposed for diversion shall remain unchanged. Compliance: In Compliance to the above, the RCCF, Berhampur Circle has reported that, the user agency has furnished an undertaking duly countersigned by the DFO, Boudh Forest Division

that the legal status of forest land proposed for diversion shall remain unchanged which is enclosed

as Annexure- XIII.

Condition No.(ii): - Compensatory Afforestation shall be raised over 26.44 ha degraded forest land identified in Subarnagiri RF under Boudh Forest Division within three years from the date of Stage-II Clearance and maintained thereafter by the State Forest Department as per approved plan/ scheme and maintained thereafter at the cost of user agency. The species to be planted shall be indigenous to the area and naturally growing species shall be planted using intensive planting technique to ensure survival of the plantation.

Compliance: In Compliance to the above, the RCCF, Berhampur Circle has reported that, the DFO, Boudh Division has furnished an undertaking that Compensatory Afforestation shall be raised over 26.44 ha of degraded forest land identified in Subarnagiri RF (Compartment No.1) under Boudh Forest Division within three years from the date of Stage-II Clearance and maintained thereafter by the State Forest Department as per approved plan/ scheme and maintained thereafter at the cost of user agency. The species to be planted shall be indigenous to the area and naturally growing species shall be planted using intensive planting technique to ensure survival of the plantation which is enclosed as Annexure- XIV.

Condition No.(iii): - Additional compensatory afforestation shall be raised over 13.26 ha of Revenue Forest land identified in Village Balkira under Boudh Tahasil of Boudh Forest Division within three years from the date of Stage-II clearance and maintained thereafter by the State Forest Department as per approved plan/ scheme and maintained thereafter at the cost of user agency. The species to be planted shall indigenous to the area and naturally growing species shall be planted using intensive planting technique to ensure survival of the plantation.

Compliance: In Compliance to the above, the RCCF, Berhampur Circle has reported that, the DFO, Boudh Division has furnished an undertaking that the additional compensatory afforestation shall be raised over 13.26 ha of Revenue Forest land identified in Village Balkira under Boudh Tahasil of Boudh District in Boudh Forest Division within three years from the date of Stage-II clearance and maintained thereafter by the State Forest Department as per approved plan/ scheme and maintained thereafter at the cost of user agency. The species to be planted shall indigenous to the area and naturally growing species shall be planted using intensive planting technique to ensure survival of the plantation which is enclosed as Annexure-XV.

Condition No.(iv): - At the time of payment of Net Present Value (NPV) at the then prevailing rate, the user agency shall furnish an undertaking to pay the additional amount of NPV, if so determined as per the final decision of the Hon'ble Supreme Court of India.

Compliance: In Compliance to the above, the RCCF, Berhampur Circle has reported that the user agency has furnished an undertaking duly countersigned by the DFO, Boudh Forest Division that at the time of payment of Net Present Value (NPV) at the then prevailing rate, the user agency shall pay for the additional amount of NPV, if so determined as per the final decision of the Hon'ble Supreme Court of India which is enclosed as Annexure- XVI.

<u>Condition No.(v)</u>: - Speed regulating signage will be erected along the railway line at regular intervals in Protected Areas/ Forest Areas.

Compliance: In Compliance to the above, the RCCF, Berhampur Circle has reported that the user agency has furnished an undertaking duly countersigned by the DFO, Boudh Forest Division that speed regulating signage will be erected along the railway line at regular intervals in Protected Areas/ Forest Areas which is enclosed as **Annexure-XVII**.

<u>Condition No.(vi)</u>: - The user agency shall provide suitable under/over passes in Protected Area/ Forest Area as per recommendations of CWLW/NBWL/FAC/REC.

Compliance: In Compliance to the above, the RCCF, Berhampur Circle has reported that the user agency has furnished an undertaking duly countersigned by the DFO, Boudh Forest Division that the user agency shall provide suitable under/ over passes in Protected Area/ Forest Area as per recommendations of CWLW/NBWL/FAC/REC which is enclosed as **Annexure-XVIII**.

<u>Condition No.(vii)</u>: - The user agency shall ensure regular joint patrolling along railway line at vulnerable locations along with Forest Department to prevent wildlife mortality.

Compliance: In Compliance to the above, the RCCF, Berhampur Circle has reported that the user agency has furnished an undertaking duly countersigned by the DFO, Boudh Forest Division that the user agency shall ensure regular joint patrolling along railway line at vulnerable locations along with Forest Department to prevent wildlife mortality which is enclosed as **Annexure-XIX**.

<u>Condition No.(viii)</u>: - The user agency shall obtain Environmental Clearance as per the provisions of the Environmental (Protection) Act, 1986, if applicable.

Compliance: In Compliance to the above, the RCCF, Berhampur Circle has reported that being a linear project Environmental Clearance is not applicable as per the provisions of the Environmental (Protection) Act, 1986.

<u>Condition No.(ix)</u>: - No labour camp shall be established on the forest land and the user agency shall provide fuels preferably alternate fuels to the labourers and the staff working at the site so as to avoid any damage and pressure on the nearby forest areas.

Compliance: In Compliance to the above, the RCCF, Berhampur Circle has reported that the user agency has furnished an undertaking duly countersigned by the DFO, Boudh Forest Division that no labour camp shall be established on the forest land and the user agency shall provide fuels preferably alternate fuels to the labourers and the staff working at the site so as to avoid any damage and pressure on the nearby forest areas which is enclosed as **Annexure-XX**.

<u>Condition No.(x)</u>: - No additional or new path will be constructed inside the forest area for any activity related to the project work.

Compliance: In Compliance to the above, the RCCF, Berhampur Circle has reported that the user agency has furnished an undertaking duly countersigned by the DFO, Boudh Forest Division that no additional or new path will be constructed inside the forest area for any activity related to the project work which is enclosed as **Annexure-XXI**.

<u>Condition No.(xi)</u>: - The user agency while executing works shall not fell any tree or damage forest growth in the surrounding forest area in any manner.

Compliance: In Compliance to the above, the RCCF, Berhampur Circle has reported that the user agency has furnished an undertaking duly countersigned by the DFO, Boudh Forest Division that the user agency while executing works shall not fell any tree or damage any forest growth in the surrounding forest area in any manner which is enclosed as **Annexure-XXII**.

<u>Condition No.(xii)</u>: - The layout plan of the proposed forest land shall not be changed without the prior approval of Ministry of Environment, Forest & Climate Change.

Compliance: In Compliance to the above, the RCCF, Berhampur Circle has reported that the user agency has furnished an undertaking duly countersigned by the DFO, Boudh Forest Division that the layout plan of the proposed forest land shall not be changed without the prior approval of Ministry of Environment, Forest & Climate Change which is enclosed as **Annexure-XXIII**.

<u>Condition No.(xiii)</u>: -The forest land shall not be used for any purpose other than that specified in the proposal.

Compliance: In Compliance to the above, the RCCF, Berhampur Circle has reported that the user agency has furnished an undertaking duly countersigned by the DFO, Boudh Forest Division that the forest land shall not be used for any purpose other than that specified in the proposal which is enclosed as **Annexure-XXIV**.

<u>Condition No.(xiv)</u>: - The forest land proposed to be diverted shall under no circumstances be transferred to any other user agency, department or person without the prior approval of Ministry of Environment, Forest & Climate Change.

Compliance: In Compliance to the above, the RCCF, Berhampur Circle has reported that the user agency has furnished an undertaking duly countersigned by the DFO, Boudh Forest Division that the forest land proposed to be diverted shall under no circumstances be transferred to any other user agency, department or person without the prior approval of Ministry of Environment, Forest & Climate Change which is enclosed as **Annexure-XXV**.

<u>Condition No.(xv)</u>: - No damage to the flora and fauna of the adjoining area shall be caused.

Compliance: In Compliance to the above, the RCCF, Berhampur Circle has reported that the user agency has furnished an undertaking duly countersigned by the DFO, Boudh Forest Division that no damage to the flora and fauna of the adjoining area shall be caused which is enclosed as

Annexure- XXVI.

<u>Condition No.(xvi)</u>: - The concerned Divisional Forest Officer will monitor and take necessary mitigative measures to ensure that there is no adverse impact on the forests in the surrounding area.

Compliance: In Compliance to the above, the RCCF, Berhampur Circle has reported that the DFO, Boudh Forest Division has furnished an undertaking that the DFO will monitor and take

necessary mitigative measures to ensure that there is no adverse impact on the forests in the surrounding area which is enclosed as Annexure- XXVII.

<u>Condition No.(xvii)</u>: - The user agency shall explore the possibility of successful translocation of maximum number of trees identified to be felled and shall ensure that any tree felling shall be done only when it is unavoidable and that too under strict supervision of the State Forest Department.

Compliance: In compliance to the above, the RCCF, Berhampur Circle has reported that the user agency has furnished an undertaking duly countersigned by the DFO, Boudh Forest Division that the user agency shall explore the possibility of successful translocation of maximum number of trees identified to be felled and shall ensure that any tree felling shall be done only when it is unavoidable and that too under strict supervision of the State Forest Department which is enclosed as **Annexure-XXVIII**.

<u>Condition No.(xviii)</u>: - The period of diversion under this approval shall be co-terminus with the period of lease granted in favour of user agency or the project life, whichever is less.

Compliance: In compliance to the above, the RCCF, Berhampur Circle has reported that the user agency has furnished an undertaking duly countersigned by the DFO, Boudh Forest Division that the period of diversion under this approval shall be co-terminus with the period of lease granted in favour of user agency or the project life, whichever is less is enclosed as **Annexure-XXIX**.

<u>Condition No.(xix)</u>: - The user agency shall submit annual self monitoring report on compliance of stipulated conditions to the Nodal Officer (FCA) of the State and concerned Integrated Regional Office of this Ministry by the end of March of every year.

Compliance: In compliance to the above, the RCCF, Berhampur Circle has reported that the user agency has furnished an undertaking duly countersigned by the DFO, Boudh Forest Division that the user agency shall submit annual self monitoring report on compliance of stipulated conditions to the Nodal Officer (FCA) of the State and concerned Integrated Regional Office of this Ministry by the end of March of every year which is enclosed as **Annexure-XXX**.

<u>Condition No.(xx)</u>: - Any other conditions that the Ministry of Environment, Forests & Climate Change may impose from time to time in the interest of afforestation, conservation and management of flora and fauna in the area shall be complied by the user agency.

Compliance: In compliance to the above, the RCCF, Berhampur Circle has reported that the user agency has furnished an undertaking duly countersigned by the DFO, Boudh Forest Division that any other conditions that the Ministry of Environment, Forests & Climate Change may impose from time to time in the interest of afforestation, conservation and management of flora and fauna in the area shall be complied by the user agency which is enclosed as **Annexure-XXXI**.

<u>Condition No.(xxi)</u>: - The State Govt. and user agency shall ensure compliance to provisions of the all Acts, Rules, Regulations, Guidelines, NGT Order (s) & Hon'ble Court Order (s) pertaining to this project, if any, for the time being in force, as applicable to the project.

Compliance: In compliance to the above, the RCCF, Berhampur Circle has reported that the user agency has furnished an undertaking duly countersigned by the DFO, Boudh Forest Division that

<u>Condition No. 1</u>: - The User Agency shall take up Avenue Plantation on either side of alignment of the track at its own cost in consultation with the DFO.

Compliance: In compliance to the above, the RCCF, Berhampur Circle has reported that the user agency has deposited an amount of Rs.10,87,99,555/- in ORISSA State CAMPA fund, Union Bank of India, Lodhi Complex Branch, New Delhi vide UTR No.SBIN322063943411 dated 04.03.2022 to take up Avenue Plantation on either side of alignment of the track with 10 years maintenance over 116 RKM.
