(15.069 Ac.) of forest land for Improvement of Road from Kharabhuin PWD Road chhak to Khandahata P.S Road via- Sankulei, Ghantabania, Panasputuli road for the year 2018-19 by the Superintending Engineer, Rural Works Division, Boudh under Boudh Forest Division - Stage-I Compliance regarding**

**Ref:- (i) GoI, MoEF & CC, Regional Office, Bhubaneswar Letter issued vide Letter No.5-ORC543/2022-BHU dt.18.01.2023**

**(ii) Letter No.10F(Cons)53/2022-2247/FE&CC dated 06.02.2023 of Govt. of Odisha, FE & CC Department**

Sir,

In inviting reference to the above mentioned subject, this is to inform that Government of India, Ministry of Environment, Forest & Climate Change, Integrated Regional Office, Bhubaneswar have accorded Stage-I approval vide their Letter No.5-ORC543/2022-BHU dt.18.01.2023 in lieu of diversion of 6.098 Ha. (15.069 Ac.) of forest land for Improvement of Road from Kharabhuin PWD Road chhak to Khandahata P.S Road via- Sankulei, Ghantabania, Panasputuli road for the year 2018-19 in the State of Odisha subject to fulfilment of Ten (10) nos. of conditions in Condition (A) and Twenty Two (22) nos. of conditions in Condition (B) stipulated therein respectively. The User Agency has complied all the conditions imposed by Govt. of India, MoEF & CC, Regional Office, Bhubaneswar. The point wise compliance basing on the report of the DFO, Boudh Forest Division and the RCCF, Berhampur Circle are as follows:-

***A: Conditions which need to be complied prior to handing over of forest land by the State Forest Department***

***Condition No. A(i):- The user agency shall transfer online, the Net Present value (NPV) of 6.098 ha forest land being diverted under this proposal, as per the Orders of Hon'ble Supreme Court of India dated 28.03.2008, 24.04.2008 and 09.05.2008 in Writ Petition***

*(Civil) No.202/1995 and the guidelines issued by this Ministry vide its letter No.5-3/2011-FC (Vol-I) dated 06.01.2022, 19.1.2022 & 22.03.2022. The requisite funds shall be transferred through online portal in CAMPA account of the state concerned.*

**Compliance:-** In compliance of the above, the RCCF, Berhampur Circle has reported that the User Agency has deposited an amount of Rs.58,40,542/- (Rupees Fifty eight lakh forty thousand five hundred forty two only) in ORRISA CAMPA Fund, Union Bank of India, FCS Centre, 21/1, III Floor, Jelitta Towers, Mission Road, Bengaluru-560027 vide UTR No. SBINR52023040341507996 dt.03.04.2023 which has been reflected in the web-portal of PARIVESH. The tabular statement of Eco-Value-Class and density for realization of NPV is given below.

The demand note of the DFO, Boudh Forest Division and payment particulars made by the User Agency are enclosed as **Annexure-I(A), I(B) & I (C)** respectively.

**Condition No. A(ii):-** *The identified non-forest land of 6.11 Ha. for raising compensatory afforestation shall be transferred and mutated in the name of Forest Department and notified as RF/PF prior to Stage-II approval.*

**Compliance:-** In compliance of the above, the RCCF, Berhampur Circle has reported that the identified non-forest Govt. land over 6.11 Ha identified in Village Kuchpaju under Harbhanga Tahasil of Boudh District for raising of compensatory afforestation has been transferred and mutated in favour of the State Forest Department. A copy of the RoR is enclosed as **Annexure-II**. The same has also been declared as "Kuchpaju Protected Forest" vide Notification No.17798/FE&CC dt.18.09.2024 which is enclosed as **Annexure-II (A)**.

**Condition No. A(iii):-** *The land identified for the purpose of Compensatory Afforestation/ Addl. C.A. shall be clearly depicted on a Survey of India Topo sheet of I:50000 Scale.*

**Compliance:-** In compliance of the above, the RCCF, Berhampur Circle has reported that the land identified for the purpose of Compensatory Afforestation and Additional Compensatory Afforestation have been clearly depicted on a Survey of India Topo sheet of I:50000 Scale which is enclosed as **Plate - I & II** respectively.

**Condition No. A(iv):-** *The KML files of the area to be diverted and the CA & Addl. CA areas shall be uploaded on the e-Green watch portal with all requisite details before issuing working permission towards linear projects or submitting compliance report for seeking Stage-II approval, as the case may be.*

**Compliance:-** In compliance of the above, the RCCF, Berhampur Circle has reported that the DFO, Boudh Forest Division has furnished an undertaking that the KML files of the area to be diverted and the CA areas with all requisite details shall be uploaded on the e-Green watch portal after getting the Stage-II/Final approval which is enclosed as **Annexure-III**.

**Condition No. A(v):-** *The user agency shall transfer the cost of raising and maintaining the compensatory afforestation/Addl. CA at the current wage rate in consultation with State Forest Department in the account of CAMPA of the concerned State through online portal. The Scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years.*

**Compliance:-** In compliance of the above, the RCCF, Berhampur Circle has reported that the User Agency has deposited an amount of Rs.3,89,400/- (Rupees Three lakh eighty nine thousand four hundred only) towards Cost of Compensatory Afforestation with 10 years maintenance over 6.11 Ha of non-forest land in Mouza Kuchpaju and an amount of Rs.48,41,000/- (Rupees Forty eight lakh forty one thousand only) towards Addl. Compensatory Afforestation with 10 years maintenance over 5.00 Ha degraded forest land in Mankadakhesa RF in ORRISA CAMPA Fund, Union Bank of India, FCS Centre, 21/1, III Floor, Jelitta Towers, Mission Road, Bengaluru-560027 vide UTR No. SBINR52023040341507996 dt.03.04.2023 which has been reflected in the web-portal of PARIVESH.

The copy of approved CA/Addl CA Scheme, demand notice and Payment particulars are enclosed as **Annexure-IV(A), IV(B) & IV(C)** respectively.

**Condition No. A(vi):-** *A Site Specific Wildlife Conservation Plan shall be prepared and duly approved by Chief Wildlife Warden, Odisha for implementation at the project cost to mitigate the adverse impact on movement of wildlife as well as man-animal conflict. Wild animals underpass/overpass may be constructed at the locations identified by the Chief Wildlife Warden at the project cost.*

**Compliance:-** In compliance of the above, the RCCF, Berhampur Circle has reported that the User Agency has deposited an amount of Rs.1,93,61,400/- (Rupees One crore ninety three lakh sixty one thousand four hundred only) towards implementation of SSWLCP in project impact area of covering both the Divisions i.e. Boudh and Athmalik in ORRISA CAMPA Fund, Union Bank of India, FCS Centre, 21/1, III Floor, Jelitta Towers, Mission Road, Bengaluru-560027 vide UTR No. SBINR52024011095182551 dt.10.01.2024 which has been reflected in the web-portal of PARIVESH. The details of amount realized for implementation of SSWLCP is given below.

**Condition No. A(vii):-** All the funds received from the user agency under the project shall be transferred/deposited in CAMPA account only through e-portal (<https://parivesh.nic.in/>). Amount deposited through other mode will not be accepted as compliance of the Stage-I clearance.

**Compliance:-** In compliance of the above, the RCCF, Berhampur Circle has reported that the details of funds deposited by the User Agency in Ad-hoc CAMPA account towards NPV, CA, Addl. CA, SSWLCP & Avenue Plantation and differential cost of the Avenue Plantation etc. through challan generated online on web-portal of PARIVESH are as follows and the prescribed 12 point CAMPA format showing details of deposit of the above Compensatory levies realized from the User Agency, is enclosed as **Annexure-VI**.

**Condition No. A(viii):-** The compliance report of the Stage-I approval shall be uploaded on e-portal (<https://parivesh.nic.in/>).

**Compliance:-** In compliance of the above, the RCCF, Berhampur Circle has reported that the User Agency has furnished an undertaking duly countersigned by the DFO, Boudh Forest Division that they have already uploaded the compliance report of the Stage-I approval on e-portal (<https://parivesh.nic.in/>) which is enclosed as **Annexure-VII**.

**Condition No. A(ix):-** The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector.

**Compliance:-** In compliance of the above, the RCCF, Berhampur Circle has reported that the User Agency has submitted the FRA Certificate issued by the Collector & District Magistrate, Boudh vide his order no.990 dt.01.02.2024 which is enclosed as **Annexure-VIII**.

**Condition No. A(x):-** *The boundary of the proposed forest land for diversion shall be demarcated on ground at the project cost by erecting four feet high reinforced cement concrete pillars, each inscribed with its serial number, distance from pillar to pillar and GPS co-ordinates.*

**Compliance:-** In compliance of the above, the RCCF, Berhampur Circle has reported that the boundary of the forest land proposed for diversion has been demarcated on the ground at the project cost by erecting four feet high reinforced cement concrete pillars each inscribed with its number, DGPS coordinates, distance from pillar to pillar etc., which is enclosed as **Annexure-IX**. The description of the pillar posted is given in composite Index map duly vetted by the ORSAC which is enclosed as **Plate-III**.

**B: Conditions which need to be strictly complied on field after handing over of forest land to the user agency by the State Forest Department but the compliance in form of undertaking shall be submitted prior to Stage-II approval.**

**Condition No. B(i):-** *Legal status of forest land proposed for diversion shall remain unchanged.*

**Compliance:-** In compliance of the above, the RCCF, Berhampur Circle has reported that the User Agency has furnished an undertaking duly countersigned by the DFO, Boudh Forest Division that the legal status of forest land proposed for diversion shall not be changed which is enclosed as **Annexure-X**.

**Condition No. B(ii):-** *Compensatory afforestation shall be raised over 6.11 Ha. of non-forest land identified in Plot No. 59, Khata No. 20 of Kissam-Patita of village Kuchpaju under Harabhanga Tahasil of Boudh District under Boudh Forest Division within three years from the date of Stage-II clearance and maintained thereafter by the State Forest Department at the cost of user agency.*

**Compliance:-** In compliance of the above, the RCCF, Berhampur Circle has reported that the DFO, Boudh Forest Division has furnished an undertaking that Compensatory afforestation shall be raised over 6.11 Ha of non-forest land identified over Plot No. 59/396, Khata No. 22 of Kissam-Patita of village Kuchpaju under Harabhanga Tahasil of Boudh District under Boudh Forest Division within three years from the date of issue of Stage-II clearance and maintained thereafter by the State Forest Department at the cost of user agency which is enclosed as **Annexure-XI**.

**Condition No. B(iii):-** *Additional compensatory afforestation shall be raised over 5.00 Ha. of degraded forest land identified in Mankadakhesa RF under Manamunda Range of Boudh Forest Division within three years from the date of Stage-II clearance and maintained thereafter by the State Forest Department, at the cost of user agency. The species to be planted shall be indigenous to the area and naturally growing species shall be planted using intensive planting technique to ensure survival of the plantation.*

**Compliance:-** In compliance of the above, the RCCF, Berhampur Circle has reported that Additional Compensatory Afforestation shall be raised over 5.00 Ha of degraded forest land identified in Mankadakhesa RF under Manamunda Range of Boudh Forest Division within three years from the date of Stage-II clearance and maintained thereafter by the State Forest Department, at the cost of user agency. The species to be planted shall be indigenous to the area and naturally growing species shall be planted using intensive planting technique to ensure survival of the plantation which is enclosed as **Annexure-XII**.

**Condition No. B(iv):-** *The species to be planted in the CA/Addl. CA scheme shall be of native species of the area. At least 18 months of seedlings should be planted. Intensive monitoring of the plantation needs to be done and documented using Geo tagging so that the increase of canopy density and survival and growth of plantation can be evaluated at regular intervals.*

**Compliance:-** In compliance of the above, the RCCF, Berhampur Circle has reported that the DFO, Boudh Forest Division has furnished an undertaking that 18 months old native species seedlings shall be planted in the CA/Addl. CA area. Intensive monitoring of the plantation and documentation using Geo tagging shall be done to evaluate the increase of canopy density and survival and growth of plantation at regular intervals which is enclosed as **Annexure-XIII**.

**Condition No. B(v):-** *At the time of payment Net Present Value (NPV) at the then prevailing rate, the user agency shall furnish an undertaking to pay the additional amount of NPV, if so determined as per the final decision of the Hon'ble Supreme Court of India.*

**Compliance:-** In compliance of the above, the RCCF, Berhampur Circle has reported that the User Agency has furnished an undertaking duly countersigned by the DFO, Boudh Forest Division to pay the additional amount of NPV, if so determined, as per the final decision of the Hon'ble Supreme Court of India, which is enclosed as **Annexure-XIV**.

**Condition No. B(vi):-** *User agency shall take up avenue plantation on either side of alignment of the road at the project cost in consultation with the DFO. In this regard State Govt. shall adhere to the Ministry's letter No. 7-12/2022-RPHQ dt. 01.09.2022.*

**Compliance:-** In compliance of the above, the RCCF, Berhampur Circle has reported that the User Agency has deposited an amount Rs.1,93,11,512/- (Rupees One crore ninety three lakh eleven thousand five hundred twelve only) to take up Avenue Plantation with 10 years of maintenance over 36.2 RKM on either side of alignment of the road and the User Agency has deposited the said amount in ORRISA CAMPA Fund, Union Bank of India, FCS Centre, 21/1, III Floor, Jelitta Towers, Mission Road, Bengaluru-560027 vide UTR No. SBINR52023040341507996 dt.03.04.2023 which has been reflected in the web-portal of PARIVESH.

Further, due to enhancement of wage rate from Rs.352/- to Rs.450/- vide notification no.2278 dt.13.03.2024 of Labour Commissioner, Odisha, the User Agency has also been demanded an amount of Rs.39,06,256/- (Rupees thirty nine lakh six thousand two hundred fifty six) only towards differential Cost of Avenue Plantation with 10 years maintenance over 36.25 RKM on either side of alignment of the road and the User Agency has deposited the said amount in ORRISA CAMPA Fund, Union Bank of India, FCS Centre, 21/1, III Floor, Jelitta Towers, Mission Road, Bengaluru-560027 vide UTR No. SBINR52024060326678815 dt.03.06.2024 which has been reflected in the web-portal of PARIVESH.

The approved Avenue Plantation scheme, demand note of the DFO, Boudh Forest Division and Payment particulars made by the User Agency are enclosed as **Annexure-XVII (A), XVII (B), XVII (C), XVII (D)** respectively.

Further, the DFO, Boudh Forest Division has furnished an undertaking that Avenue Plantation shall be taken up as per Ministry's letter no. 7-12/2022-RPHQ dt.01.09.2022, which is enclosed as **Annexure-XVIII**.

**Condition No. B(vii):-** *The user agency shall use fly ash for the road construction and for filling up of void created due to soil borrows which will be followed by compaction and spreading of top soil over it as per Fly Ash Notification No. S.O. 254 (E) dated 25.01.2016.*

**Compliance:-** In compliance of the above, the RCCF, Berhampur Circle has reported that the User Agency has furnished an undertaking duly countersigned by the DFO, Boudh Forest Division to use fly ash for the road construction and for filling up of void created due to soil borrows which will be followed by compaction and spreading of top soil over it as per Fly Ash Notification No. S.O. 254 (E) dated 25.01.2016 which is enclosed as **Annexure-XIX**.

**Condition No. B(viii):-** *The user agency shall submit an undertaking to ensure that flanks of roads should be filled by transported soil and not with soil dug from the side of the roads.*

**Compliance:-** In compliance of the above, the RCCF, Berhampur Circle has reported that the User Agency has furnished an undertaking duly countersigned by the DFO, Boudh Forest Division to ensure that flanks of roads should be filled by transported soil and not with soil dug from the side of the roads which is enclosed as **Annexure-XX**.

**Condition No. B(ix):-** *The designing of new culverts/bridges and redesigning the existing ones over the natural streams/rivers/canals should be done in such a manner that it does not hamper the natural course of water, does not give rise to water-logging, so that it does not hamper movement of wild animals including fishes & amphibians migration.*

**Compliance:-** In compliance of the above, the RCCF, Berhampur Circle has reported that the User Agency has furnished an undertaking duly countersigned by the DFO, Boudh Forest Division that the designing of new culverts/bridges and redesigning of the existing ones over the natural streams/rivers/canals should be done in such a manner that it does not hamper the natural course of water, does not give rise to water-logging, so that it does not hamper movement of wild animals including fishes & amphibians migration which is enclosed as **Annexure-XXI**.

**Condition No. B(x):-** *Speed regulating signage will be erected along the road at regular intervals in Protected Areas/Forest Areas.*

**Compliance:-** In compliance of the above, the RCCF, Berhampur Circle has reported that the User Agency has furnished an undertaking duly countersigned by the DFO, Boudh Forest Division that the speed regulating signage will be erected along the road at regular intervals in Protected Areas/Forest Areas which is enclosed as **Annexure-XXII**.

**Condition No. B(xi):-** *The user agency shall obtain Environment Clearance as per the provisions of the Environmental (Protection) Act, 1986, if applicable.*

**Compliance:-** In compliance of the above, the RCCF, Berhampur Circle has reported that being a Linear Project, Environment Clearance as per the provisions of the Environmental (Protection) Act, 1986 is not applicable for this project.

**Condition No. B(xii):-** *No labour camp shall be established on the forest land and the user agency shall provide fuels preferably alternate fuels to the laborers and the staff working at the site so as to avoid any damage and pressure on the nearby forest areas.*

**Compliance:-** In compliance of the above, the RCCF, Berhampur Circle has reported that the User Agency has furnished an undertaking duly countersigned by the DFO, Boudh Forest Division that no labour camp shall be established on the forest land and the user agency shall provide fuel preferably alternate fuels to the laborers and the staff working at the site so as to avoid any damage and pressure on the nearby forest areas which is enclosed as **Annexure-XXIII**.

**Condition No. B(xiii):-** *No additional or new path will be constructed inside the forest area for any activity related to the project work.*

**Compliance:-** In compliance of the above, the RCCF, Berhampur Circle has reported that the User Agency has furnished an undertaking duly countersigned by the DFO, Boudh Forest Division that no additional or new path will be constructed inside the forest area for any activity related to the project work which is enclosed as **Annexure-XXIV**.

**Condition No. B(xiv):-** *The user agency while executing works, shall not fell any tree or damage forest growth in the surrounding forest area in any manner.*

**Compliance:-** In compliance of the above, the RCCF, Berhampur Circle has reported that the User Agency has furnished an undertaking duly countersigned by the DFO, Boudh Forest Division that while executing works, they shall not fell any tree or damage forest growth in the surrounding forest area in any manner which is enclosed as **Annexure-XXV**.

**Condition No. B(xv):-** *The layout plan of the proposed forest land shall not be changed without the prior approval of Ministry of Environment, Forest & Climate Change.*

**Compliance:-** In compliance of the above, the RCCF, Berhampur Circle has reported that the User Agency has furnished an undertaking duly countersigned by the DFO, Boudh Forest Division that the layout plan of the proposed forest land shall not be changed without the prior approval of Ministry of Environment, Forest & Climate Change which is enclosed as **Annexure-XXVI**.

**Condition No. B(xvi):-** *The forest land shall not be used for any purpose other than that specified in the proposal.*

**Compliance:-** In compliance of the above, the RCCF, Berhampur Circle has reported that the User Agency has furnished an undertaking duly countersigned by the DFO, Boudh Forest Division that the forest land shall not be used for any purpose other than specified in the proposal which is enclosed as **Annexure-XXVII**.

**Condition No. B(xvii):-** *The forest land proposed to be diverted shall under no circumstances be transferred to any other user agency, department or person without the prior approval of Ministry of Environment, Forest & Climate Change.*

**Compliance:-** In compliance of the above, the RCCF, Berhampur Circle has reported that the DFO, Boudh Forest Division has furnished an undertaking that the forest land proposed to be diverted shall under no circumstances be transferred to any other user agency, department or person without the prior approval of Ministry of Environment, Forest & Climate Change, which is enclosed as **Annexure-XXVIII**.

**Condition No. B (xviii):-** *No damage to the flora and fauna of the adjoining area shall be caused.*

**Compliance:-** In compliance of the above, the RCCF, Berhampur Circle has reported that the User Agency has furnished an undertaking duly countersigned by the DFO, Boudh Forest Division that no damage to the flora and fauna of the adjoining area shall be caused which is enclosed as **Annexure-XXIX.**

**Condition No. B (xix):-** *The concerned Divisional Forest Officer will monitor and take necessary mitigative measures to ensure that there is no adverse impact on the forest in the surrounding area.*

**Compliance:-** In compliance of the above, the RCCF, Berhampur Circle has reported that the DFO, Boudh Forest Division has furnished an undertaking that he will monitor and take necessary mitigative measures to ensure that there is no adverse impact on the forest in the surrounding area which is enclosed as **Annexure-XXX.**

**Condition No. B(xx):-** *The user agency shall submit annual self-monitoring report on compliance of stipulated conditions to the Nodal Officer (FCA) of the State and concerned Integrated Regional Officer of this Ministry by the end of March every year.*
