Sub: Diversion of 7.8199ha forest land for Widening and Strengthening of existing double lane road to two laned with 1.5m wide paved shoulder on either side from Km 35/700 to Km 71/120 of NH-220 of Rairangpur to Jashipur Section coming within Rairangpur & Karanjia Forest Division within the jurisdiction of Mayurbhanj District in the State of Odisha- Submission of Stage-I compliance regarding.

Sir,

In reference to the above mentioned subject, this is to inform that Government of India, Ministry of Environment, Forest & Climate Change, Eastern Regional Office, Bhubaneswar has accorded '**in-principle**' approval vide No.5-ORC358/2018-BHU dated 18.07.2018 for diversion of 7.8199 ha forest land for Widening and Strengthening of existing road to two lane with 1.5m wide paved shoulder on either side from Km 35/700 to Km 71/120 of NH-220 of Rairangpur to Jashipur Section coming within Rairangpur & Karanjia Forest Division within the jurisdiction of Mayurbhanj District in the State of Odisha subject to fulfilment of twenty four (24) nos. of conditions stipulated therein as well as 4 (four) nos of additional conditions imposed by the State Government. The User Agency has complied all the conditions imposed by Govt. of India, MoEF & CC, ERO, Bhubaneswar as well as by the State Government.

The point wise compliance basing on the report of the FD, STR-cum-RCCF, Baripada Circle is as follows:-

Condition No.2(i):-Legal status of forest land proposed for diversion shall remain unchanged.

Compliance: In compliance to the above, the FD, STR-cum-RCCF, Baripada Circle has reported that the User Agency has submitted an undertaking that legal status of forest land proposed for diversion shall not be changed duly countersigned by both the DFO, Rairangpur & Kanranjia Division which is enclosed as **Annexure-1**.

Condition No.2(ii):- The state Govt. shall charge the Net Present Value(NPV) of forest area proposed to be diverted under this proposal from the user agency as per the Orders of Hon'ble Supreme Court of India dated 28.03.2008, 24.04.2008 and 09.05.2008 in the Writ Petition (Civil) No 202/1995 and the Guidelines issued by the Ministry vide its letter No.5-3/2007- FC dated 05.02.2009 in this regard. While conveying the compliance of this condition mentioned be made of the Eco- class and density of forest for which NPV has been charged.

Compliance: In compliance to the above, the FD, STR-cum-RCCF, Baripada Circle has reported that the User Agency has deposited **Rs.48,95,257/-out of total deposit amount of Rs.69,01,857/-** towards the cost of NPV for diversion of 7.8199 ha forest land in respect of both Karanjia & Rairangpur Divisions as calculated below in ORISSA CAMPA Saving Bank Account No.150826120160123 maintained in the Corporation Bank, CGO Complex Phase -1 Lodhi Road, New Delhi - 110003 through RTGS mode vide **UTR No.SBIN518302968105 dt.29.10.2018** as per demand letter of both the DFO, Rairangpur & Karanjia Division vide their Memo No.3094 dt.21.08.2018 & Memo No.4315 dt.18.08.2018 .

Condition No.2(iii):-At the time of payment of the Net Present Value NPV at the present rate, the user agency shall furnish an undertaking to pay the additional amount of NPV, if so determined, as per the final decision of the Hon'ble Supreme Court of India.

Compliance: In compliance to the above, the FD, STR-cum-RCCF, Baripada Circle has reported that the User Agency has submitted an undertaking to this effect duly countersigned by both the DFO, Rairangpur & Karanjia Division Which is enclosed as **Annexure-4**.

Condition No.2(iv):-Compensatory afforestation shall be raised over 7.819 ha. of non-forest land identified in plot No1066/2,1067/1,1068 &1087, khata No. 198 of village Ghodadega of KusumiTehasil under Rairangpur Forest Division of Mayurbhanj district against the area of forest land proposed to be diverted at the cost of the user agency.

Compliance: In compliance to the above, the FD, STR-cum-RCCF, Baripada Circle has reported that the User Agency has deposited **Rs.39,90,600/-**(Rs.20,06,600.00 @ Rs.224.30 per MD + differential cost of Rs.1,90,200.00 @ Rs.303.40 per MD + Rs.35,600.00 @ Rs.311/- per MD+ Rs.17,58,200.00 @ Rs.326/- per MD) for raising Compensatory Afforestation over 7.819 ha. of non-forest land identified in plot No1066/2,1067/1,1068 & 1087, khata No. 198 of village Ghodadega under Kusumi Tahasil of Mayurbhanj District under Rairangpur Forest Division. The financial outlay at the wage rate of Rs.224.30/- per man-day for Rs. 20,06,600/- approved by PCCF&HOFF, Odisha and subsequent revision@ Rs.303.40, Rs.311.00and Rs.326.00 per MD by Nodal Officer are enclosed as **Annexure- 7(A),7(B),7(C)and 7(D)** respectively .

ConditionNo.2(v):- The non-forest land identified for raising of compensatory afforestation shall be transferred and mutated in favour of the state forest Department before issue of stage II approval.

Compliance: In compliance to the above, the FD, STR-cum-RCCF, Baripada Circle has reported that the following non-forest land in Village-Ghodadega under Kusumi Tahasil of Mayurbhanj District identified for raising Compensatory Afforestation has already been mutated in favour of the State Forest Department on dt.17.11.2021 by the Tahasildar, Kusumi Tahasil, Badampahar.

ConditionNo.2(vi):-The non-forest land over which compensatory afforestation will be taken up shall be notified as PF/RF and shall remain under the administrative control of the State Forest Department.

Compliance: In compliance to the above, the Draft Notification Proposal for declaration of the mutated non- forest land over which compensatory afforestation shall be raised as Protected Forest has already been submitted to the Additional Chief Secretary to Government, FE&CC Department, Bhubaneswar vide this office Letter No.516 dt.07.01.2022 of PCCF and HoFF, Odisha. (Copy enclosed as Annexure-6).

Condition No.2(vii):-State Govt. will formulate compensatory afforestation scheme with focused soil & moisture conservation, along with regeneration cleaning, silvicultural activities and shall ensure maintenance of these plantation for a period of seven to ten years as per requirement.

Compliance: In compliance to the above, the FD, STR-cum-RCCF, Baripada Circle has reported that the Compensatory afforestation scheme has been formulated by the DFO, Rairangpur Forest Division with provision of soil and moisture conservation measures, regeneration cleaning, silvicultural activities etc. with maintenance of plantation for a period of 10 years & the same has also been approved by the PCCF, Odisha at the present schedule of wage rate of Rs.224.30 per MD & has been subsequently revised @Rs Rs.303.40, Rs.311.00 and Rs.326.00 per MD the copy of which is enclosed as Annexure- 7(A),7(B),7(C) and 7(D)).

Condition No.2(viii):-The User agency shall transfer the cost of raising and maintaining the compensatory afforestation at the current wages rate in consultation with State forest Department in the account of Ad-hoc CAMPA of the concerned State through online portal. The scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years.

Compliance: In compliance to the above, the FD, STR-cum-RCCF, Baripada Circle has reported that the Scheme for raising of Compensatory Afforestation over an area of 7.819 ha of non-forest land identified in Village-Ghodadega under Badampahar Range in Rairangpur Forest Division with financial outlay of **Rs.20,06,600.00** (Rupees Twenty Lakh Six Thousand Six Hundred) only with 10 years maintenance at the wage rate of Rs.224.30/- per man day was technically approved by the PCCF, Odisha vide his letter No.16817, dt.06.08.2018 (Copy enclosed). The User Agency had deposited the said amount of **Rs.20,06,600.00** out of deposited amount of Rs.69,01,857/- in Adhoc CAMPA, Orissa Saving Account No. 150826120160123 maintained in Corporation Bank, CGO, Complex, Ph-I, Lodhi Road, New Delhi vide **UTR No. SBIN518302968105 dated.29.10.2018**. The copy of demand letter and deposit particulars with challan no. are enclosed as **Annexure- 8(A) and 8(B) respectively**.

Again, on revision of financial outlay of Compensatory Afforestation Scheme for **Rs.21,96,800.00** (Rupees Twenty One Lakh Ninety Six Thousand Eight Hundred) only approved by the PCCF(Nodal) at the wage rate of Rs.303.40 per man day with 10 years, the User Agency

deposited the differential amount of **Rs.1,90,200.00** (Rs.21,96,800/- – Rs.20,06,600/-) in ORISSA CAMPA Account No.150826120160106 maintained in Union Bank of India, Lodhi Complex Branch, New Delhi.vide **UTRNo.SBIN52021071933549822 dated.19.07.2021**. The copy of demand letter and deposit particulars with challan no. are enclosed as **Annexure- 8(C) and 8(D) respectively**.

Again on revision of financial outlay of Compensatory Afforestation Scheme for **Rs.22,32,400.00**(Rupees Twentytwo Lakh Thirtytwo Thousand Four Hundred) only approved by the Addl. PCCF(Nodal) at the wage rate of Rs.311/- per man day with 10 years maintenance, the User Agency deposited the differential amount of **Rs.35,600/-**(Rs.22,32,400/- - Rs.21,96,800/-) in ORISSA CAMPA Account No.150826120160113 maintained in Union Bank of India, Lodhi Complex Branch, New Delhi vide **UTR No. SBIN521239136237 dt.27.08.2021**. The copy of demand letter and payment particulars ie. Challan with UTR No. are enclosed as **Anneuxure- 8(E) and 8(F) respectively**.

Finally, on revision of financial outlay of Compensatory Afforestation Scheme for **Rs.39,90,600.00** (Rupees Thirty nine Lakh Ninety Thousand Six Hundred) only approved by the CCF(Nodal) at the wage rate of Rs.326/- per man day with 10 years maintenance, the User Agency deposited the differential amount of **Rs.17,58,200/-** (Rs.39,90,600/- - Rs.22,32,400/-) in ORISSA CAMPA Account No.150826120160712 maintained in Union Bank of India, FCS Center 21/1 III Floor, Jelitta Tower, Mission Road, Bengaluru vide **UTR No. CNRBR50222112894304197 dt.28.11.2022**. The copy of demand letter and payment particulars are enclosed as **Anneuxure-8(G) and 8(H) respectively**.

Condition No.2(ix):-The user agency should ensure that the compensatory levies(C.A. cost, NPV etc) are deposited through e-challan generated online on web portal and deposited in appropriate bank online only. Amount deposited through other mode will not be accepted as compliance of the Stage-I clearance.

Compliance: In compliance to the above, the FD, STR-cum-RCCF, Baripada Circle has reported that the User Agency has deposited the following amount towards Compensatory levies (Cost of NPV, CA, SSWLCP & Avenue Plantation) through online on web portal in Orissa State CAMPA Account.

Condition No.2(x):-The User Agency shall comply the recommendations of the State Government.

(a) A site specific wildlife management plan for the project area as well as its impact area is required to be prepared by the user agency and the same be approved by the principal Chief Conservator of forests (WL) & Chief Wild Life Warden which would also include the essential safeguards/ mitigative measures to be adopted at project cost for ensuring smooth/ safe movement of elephants and other wildlife. The plan has to be implemented at project cost. The project authorities shall provide under passes at strategic locations as per guidelines prescribed in the Eco- friendly measures to mitigate impacts of linear infrastructure on wildlife published by Wildlife Institute of India and adopted by ministry of Environment, Forest and climate Change at their cost.

Compliance: In compliance to the above, the FD, STR-cum-RCCF, Baripada Circle has reported that the Site Specific Wildlife Management Plan for the project area as well as its impact area has already been approved by the PCCF (WL) and Chief Wildlife Warden, Odisha, Bhubaneswar with total financial outlay of Rs.274.300 Lakh vide his Letter no.10885 dt.20.12.2019 (copy enclosed as **Annexure-10**). The User Agency deposited the amount of **Rs.2,45,06,400/-** in ORISSA CAMPA Account No.150826120160106 maintained in Union Bank of India, Lodhi Complex branch, block-11 CGO Complex, Phase-1, Lodhi road, New Delhi vide **UTR No. SBIN52021071933549822** dated 19.07.2021.

The Copy of demand letter by the DFO, Karanjia & Rairangpur Division which is enclosed as **Annexure-10(A1) , 10(A2) & 10(A3)** respectively.

Subsequently, the scheme was revised for Rs. 2,85,09,600.00 at the wage rate of Rs.315/- per manday vide his memo no.3416, dt.19.04.2022 copy enclosed as **Annexure-10(A4)** which includes the essential safeguards/ mitigative measures to be implemented at the project cost for ensuring smooth/ safe movement of the wild elephants and other wildlife as follows-

Further, the User Agency has given an undertaking to pay differential cost of Site Specific Wildlife Management plan due to increase of wage rate from time to time(Enclosed as **Annexure-10(A7)**). Also the User Agency has submitted an undertaking that the project authority shall provide under pass at identified locations as per guidelines prescribed in the Eco- friendly measures to mitigate impacts of linear infrastructure on wildlife published by Wildlife Institute of India adopted by ministry of Environment, Forest and Climate Change (Enclosed as **Annexure-10(A8)**). As regards the execution of the works relating to the project area approved by PCCF(WL), the UA has submitted the undertaking duly countersigned by DFO, Karangia and Rairangpur Division (Enclosed as **Annexure-10(A-9)**).

(b)The user agency shall undertake avenue plantation along both sides of the road in the entire alignment of the project area at their cost in consultation of respective Divisional Forest officers.

Compliance: In compliance to the above, the FD, STR-cum-RCCF, Baripada Circle has reported that the Divisional Forest Officer, Karanjia Forest Division vide his memo no.3524, dt.16.07.2022 had submitted Scheme for Avenue Plantation with gabion made of bamboo twigs for 4850 nos. seedlings to be planted with 3(Three) years maintenance with a financial outlay of Rs.48,47,012.00 (Rupees Forty Eight Lakh Forty Seven Thousand Twelve) only at the current wage rate of Rs.326.00 per manday. The Scheme of such Avenue Plantation for Rs. 48,47,012.00 at the wage rate of 326/- per mandays with 3 (Three) years maintenance has also been approved vide memo No.2769, dt.22.07.2022 of the FD, STR-cum-RCCF, Baripada Circle. A copy of such approved scheme has been enclosed as **Annexure- 10(A10)**.

Similarly, the Divisional Forest Officer, Rairangpur Forest Division vide his memo no.3485, dt.11.07.2022 had submitted Scheme for Avenue Plantation with gabion made of bamboo twigs for 3725 nos. of seedlings to be planted with 3(Three) years maintenance with a financial outlay of Rs.37,22,705.00 (Rupees Thirty-Seven Lakh Twenty-Two Thousand Seven Hundred Five) only as per the current wage rate of Rs.326.00 per manday. The Scheme for such Avenue Plantation for Rs.37,22,705.00 at the wage rate of 326/- per mandays with 3 (Three) years maintenance has been approved vide memo no.2766, dt.22.07.2022 of the FD-STR-cum-RCCF, Baripada Circle. A copy of such approved scheme has also been enclosed as **Annexure-10(A-11)**.

The Executive Engineer, NH Division Baripada has deposited the total amount of Rs.85,69,717.00 (Rs.48,47,012.00 for Karanjia Division+ Rs.37,22,705.00 for Rairangpur Division) in ORISSA State CAMPA SB No.150826120160774 of Union Bank of India, Lodhi Complex Branch, New Delhi on dt.19.08.2022 vide UTR No.SBINR52022081900112334 (**Copy**

of demand demand letter, Challan generated & payment mode is enclosed herewith as Annexure- 10(B1),10(B2),10(B3) and 10(B4) respectively. He has also furnished an undertaking to take up the avenue plantation in consultation with respective DFOs at the project cost enclosed as Annexure-10(B5).

(c) Map of RF patches in A3/A4 size indicating pillar positions coming within the road in the entire alignment of the project duly authenticated by the concerned DFOs shall be furnished.

Compliance: In compliance to the above, the FD, STR-cum-RCCF, Baripada Circle has reported that the User Agency has furnished the Map of RF patches in A4 size coming within the road in the entire alignment of the project duly authenticated by the Divisional Forest Officer, Karanjia and Rairangpur Division which is enclosed as **Annexure-11**.

(d) Cost benefit analysis for this project shall be furnished as per revised guidelines of MoEF& CC, dt. 1.8.2017 if required.

Compliance: In compliance to the above, the FD, STR-cum-RCCF, Baripada Circle has reported that the User Agency has submitted that Cost Benefit Analysis for this project is not required as forest area involved in the project proposed for diversion is less than 20 Ha which is enclosed as **Annexure-12**.

Condition No.2(xi):-*The designing of new culverts/bridges and re-designing the existing ones over the natural streams/ rivers/canal should be done in such a manner that it does not hamper the natural course of water, does not give rise to water-logging, so that it does not hamper movement of wild animals including fishes & amphibians migration.*

Compliance: In compliance to the above, the FD, STR-cum-RCCF, Baripada Circle has reported that the User Agency has furnished an undertaking duly countersigned by both the DFO, Rairangpur and Karanjia Division that the designing of new culvert/bridge and re-designing the existing ones over the manual ones over the natural streams/ rivers/canal should be done in such a manner that it does not hamper the natural course of water, does not give rise to water-logging, so that it does not hamper movement of wild animals including fishes & amphibians migration which is enclosed as **Annexure No.13**.

Condition No.2(xii):-*The boundary of the forest land proposed to be diverted shall be demarcated on the ground at the project cost, by erecting four feet high reinforced cement concrete pillars, each inscribed with its serial number, DGPS coordinates, distance from adjoining pillars etc. The cost of expenditure like RCC/ stone pillars, demarcation charges, charges for felling of trees and their transportation to depots shall be deposited with DFOs concerned and the work should be undertaken departmentally as per directions of Ministry's letter No. 13-20/2015- CAMPA dated 09.06.2016.*

Compliance: In compliance to the above, the FD, STR-cum-RCCF, Baripada Circle has reported that the boundary of the forest land proposed to be diverted have already been demarcated on the ground at the project cost, by erecting four feet high reinforced cement

concrete pillars, each inscribed with its serial number, DGPS coordinates, distance from adjoining pillars etc.

The User Agency has furnished an undertaking duly countersigned by both the DFO, Rairangpur and Karanjia Division to pay the charges for felling of trees and their transportation to depots with concerned DFO and the work will be undertaken departmentally as per directions of Ministry's letter No. 13-20/2015- CAMPA dated 09.06.2016 which is enclosed as **Annexure-14**.

Condition No.2(xiii):-The State Forest Department/UA shall submit the surveyed sketch of non-forest land identified for CA giving the forward and backward bearing of each demarcation pillar and distance between them. The State Forest Department/User Agency shall submit the DGPS reading of each demarcated pillar giving the latitude and the longitude.

Compliance: In compliance to the above, the FD, STR-cum-RCCF, Baripada Circle has reported that the User agency has submitted the surveyed sketch map of non-forest land identified for CA giving the forward and backward bearing of each demarcation pillar and distance between them & DGPS reading of each demarcated pillars giving the latitude and longitude duly authenticated by both the DFOs, Karanjia & Rairangpur Divisions which is enclosed as **Annexure-15**.

Condition No.2(xiv):-The User Agency shall use fly ash for the road construction and for filling up of void created due to soil borrows which will be followed by compaction and spreading of top soil over it as per fly ash Notification No. S.O. 254 (E) dated 25.01.2016.

Compliance: In compliance to the above, the FD, STR-cum-RCCF, Baripada Circle has reported that the user agency has furnished an undertaking duly countersigned by both the DFO, Rairangpur and Karanjia Division that fly ash will be used for the road construction and for filling up of void created due to soil borrows which will be followed by compaction and spreading of top soil over it as per fly ash Notification No. S.O. 254 (E) dated 25.01.2016 which is enclosed as **Annexure-16**.

Condition No.2(xv):-The User Agency shall submit an undertaking to ensure that flanks of roads should be filled by transported soil and not with soil dug from the side of the roads.

Compliance: In compliance to the above, the FD, STR-cum-RCCF, Baripada Circle has reported that the User Agency has furnished an undertaking duly countersigned by both the DFO, Rairangpur and Karanjia Division that flanks of roads will be filled by transported soil and not with soil dug from the side of the roads which is enclosed as **Annexure-17**.

Condition No.2(xvi):-No additional or new path will be constructed inside the forest area for any activity related to the project work.

Compliance: In compliance to the above, the FD, STR-cum-RCCF, Baripada Circle has reported that the User Agency has furnished an undertaking duly countersigned by both the DFO, Rairangpur and Karanjia Division that no additional or new path will be constructed inside the forest area for any activity related to the project work which is enclosed as **Annexure-18**.

Condition No.2(xvii):-No Labour Camp shall be allowed in the Forest Area.

Compliance: In compliance to the above, the FD, STR-cum-RCCF, Baripada Circle has reported that the User Agency has furnished an undertaking duly countersigned by both the DFO, Rairangpur and Karanjia Division that no Labour Camp will be constructed in the forest area which is enclosed as **Annexure-19**.

Condition No.2(xviii):-The User Agency shall provide LPG or alternate fuel, to laboures working at the site to avoid damage/tree felling and ensure no fuel wood use.

Compliance: In compliance to the above, the FD, STR-cum-RCCF, Baripada Circle has reported that the User Agency has furnished an undertaking duly countersigned by both the DFO, Rairangpur and Karanjia Division that LPG or alternate fuel will be provided to laboures working at the site to avoid damage/tree felling and ensure no fuel wood use which is enclosed as **Annexure-20**.

Condition No.2(xix):-The user agency while executing works, shall not fell any tree or damage forest growth in the surrounding forest area in any manner.

Compliance: In compliance to the above, the FD, STR-cum-RCCF, Baripada Circle has reported that the User Agency has furnished an undertaking duly countersigned by both the DFO, Rairangpur and Karanjia Division that during execution of works no damage or felling of trees will be done in the surrounding forest area in any manner which is enclosed as **Annexure-21**.

Condition No.2(xx):-The forest land shall not be used for any purpose other than that specified in the proposal and under no circumstances be transferred to any other user agency, department or person without the prior approval of Ministry of Environment, Forest & Climate Change.

Compliance: In compliance to the above, the FD, STR-cum-RCCF, Baripada Circle has reported that the User Agency has furnished an undertaking duly countersigned by both the DFO, Rairangpur and Karanjia Division that the forest land will not be used for any purpose other than that specified in the proposal and under no circumstances be transferred to any other user agency, department or person without the prior approval of Ministry of Environment, Forest & Climate Change which is enclosed as **Annexure-22**.

Condition No.2(xxi):-*The layout plan of the proposed forest land shall not be changed without the prior approval of Ministry of Environment, Forest & Climate change.*

Compliance: In compliance to the above, the FD, STR-cum-RCCF, Baripada Circle has reported that the User Agency has furnished an undertaking duly countersigned by both the DFO, Rairangpur and Karanjia Division that the layout plan of the proposed forest land will not be changed without the prior approval of Ministry of Environment, forest & Climate change which is enclosed as **Annexure-23**.

Condition No.2(xxii):-*The state Government shall complete settlement of right in term of the Scheduled Tribes and Traditional Forest Dwellers (Recognition of forest Rights) Act.2006, if any, on the forest land to be diverted and submit the documentary evidence as prescribed by this Ministry in its letter No.11-9/1998-FC (pt) dated 03.08.2009 read with letter No.11-9/1998-FC (pt) dated 05.02.2013 and 05.07.2013 in support thereof. The user agency shall submit original FRA certificate before issue of Stage-II approval.*

Compliance: In compliance to the above, the FD, STR-cum-RCCF, Baripada Circle has reported that the FRA Certificate has been issued by the Collector & District Magistrate, Mayurbhanj for the above project . A copy of the FRA certificate issued by the Collector & District Magistrate, Mayurbhanj vide his No.1029, dt.24.04.2017 has been enclosed as **Annexure-24**.

Condition No.2(xxiii):-*Any other condition that the Ministry of Environment, forest & climate change may impose from time to time in the interest of afforestation, conservation and management of flora and fauna in the area, which shall be complied by the user agency.*

Compliance: In compliance to the above, the FD, STR-cum-RCCF, Baripada Circle has reported that the User Agency has furnished an undertaking duly countersigned by both the DFO, Rairangpur and Karanjia Division that any other condition that the Ministry of Environment, Forest & Climate Change may impose from time to time in the interest of afforestation, conservation and management of flora and fauna in the area, shall be complied by the user agency which is enclosed as **Annexure-25**.

Condition No.2(xxiv):-*The State Govt. and user agency shall ensure compliance to provisions of the all Acts, Rules, Regulations Guidelines, NGT order(s) & Hon'ble Court Order(s) pertaining to this project, if any, for the time being in force, as applicable to the project.*

Compliance: In compliance to the above, the FD, STR-cum-RCCF, Baripada Circle has reported that the User Agency has furnished an undertaking duly countersigned by both the DFO, Rairangpur and Karanjia Division that the State Govt. and user agency shall ensure compliance to provisions of the all Acts, Rules, Regulations Guidelines, NGT order(s) & Hon'ble Court Order (s) pertaining to this project, if any, for the time being in force, as applicable to the project which is enclosed as **Annexure-26**.

In view of the above, the compliance to the conditions imposed by Government of India, MoEF & CC, ERO, Bhubaneswar is sent herewith for according final approval for diversion of 7.8199 ha forest land for widening and strengthening of existing road to two lane with 1.5m wide paved shoulder on either side from Km 35/700 to Km 71/120 of NH-220 of Rairangpur to Jashipur Section coming within Rairangpur & Karanjia Forest Division within the jurisdiction of Mayurbhanj District in the State of Odisha under Section 2 of Forest (Conservation) Act, 1980.
