Sub: Proposal for diversion of 27.343 ha of forest land for widening of existing 2 Lane to 2 lane with 1.5 mtr wide paved shoulder from Km 0/00 to Km 81/00 Km and from 93/00 Km to 119/00 Km of NH-157 on EPC mode in Kandhamal and Ganjam District in State of Odisha.

In inviting reference to the above mentioned subject, this is to inform that Government of India, Ministry of Environment, Forest & Climate Change, Integrated Regional Office, Bhubaneswar has accorded Stage-I/In-principle approval vide letter No.5-ORC463/2021-BHU dated 28.12.2021 in respect of diversion of 27.343 ha (Phulbani Division 7.722 ha + Ghumsur North Division 19.621 ha) of forest land for widening of existing 2 Lane to 2 lane with 1.5 mtr wide paved shoulder from Km 0/00 to Km 81/00 Km and from 93/00 Km to 119/00 Km of NH-157 on EPC mode in Kandhamal and Ganjam District in State of Odisha subject to fulfillment of 14 nos. of conditions prior to handing over of forest land by the State Forest Department and 20 nos. of conditions after handing over of forest land to the User Agency by the State Forest Department. The point wise compliances basing on the reports of the RCCF, Berhampur Circle pertaining to both Phulbani and Ghumsur (N) Division are as follows:-

2. A. Conditions which need to be complied prior to handing over of forest land by the State Forest Department.

Condition No. (i):- The user agency shall transfer online, the Net Present Value (NPV) of 27.343 ha forest land being diverted under this proposal, as per the Orders of Hon'ble Supreme Court of India dated 28.03.2008, 24.04.2008 and 09.05.2008 in Writ Petition (Civil) No. 202/1995 and the guidelines issued by this Ministry vide its letter No. 5-3/2007-FC dated 05.02.2009. The requisite funds shall be transferred through online portal in CAMPA account of the State concerned.

or

Compliance:- In compliance to the above, the RCCF, Berhampur Circle has reported that the user agency has already deposited Rs.2,30,06,621/- towards cost of NPV over 27.343 ha (Phulbani Division 7.722 ha + Ghumsur North Division 19.621 ha) forest land involved in this project as per the table given below. Regarding proof of deposit of the said amount the demand letter of both the DFO concerned alongwith proof of deposit of the said amount by the user agency through online portal in State CAMPA account vide challan dated 08.03.2022 and UTR No. UBIN0220679863 dated 04.03.2022 enclosed as **Annexure-A series :-**

Condition No.(ii):- The identified degraded revenue forest land of 40.00 ha for raising compensatory afforestation shall be transferred And mutated in the name of Forest Department and notified as RF/PF prior to Stage-II approval .

Compliance:- In compliance to the above, the RCCF, Berhampur Circle has reported that the identified degraded revenue forest land over 40 ha for raising of Compensatory Afforestation has already been transferred and mutated in favour of the state forest department as per RoR issued by the Tahasildar Harbhanga Tahasil dated 28.11.2022. For declaration of the above mutated CA land as PF proposal has been furnished to the State Govt. vide this office memo No.16405 dated 16.08.2023 which are enclosed as **Annexure-II Series.**

Condition No.(iii):- The land identified for the purpose of Compensatory Afforestation shall be clearly depicted on a Survey of India Topo sheet of 1:50,000 scale .

Compliance:- In compliance to the above, the RCCF, Berhampur Circle has reported that the land identified for the purpose of Compensatory Afforestation is over 60 ha (Revenue Forest land 40 ha in village Dharnagar under Harbhanga Tahasil of Boudh district & over 10 ha in Jagannath Prasad RF and over 10 ha in Tiliki RF under Ghumsur (N) Division has been clearly depicted on SoI topo sheet No.F45S10, F45S12 & E45A5 in 1:50,000 scale which are enclosed as **Annexure – III series.**

Condition No.(iv):- The Compensatory Afforestation shall be raised @ 1000 plants per ha in the identified degraded forest land.

Compliance:- In compliance to the above, the RCCF, Berhampur Circle has reported that earlier the CF (Nodal), O/o the PCCF, Odisha has furnished clarification to the IRO, Bhubaneswar, GoI, MoEF & CC vide letter No.20113 dated 25.11.2021 that total 32,000 nos. of seedling shall be planted over 60 ha of CA land identified as above against the requirement of 27,343 nos. of seedlings which are as follows.

Condition No.(v):- *The species to be planted in the CA scheme shall be of native species of the area avoiding Teak and exotic species.*

Compliance:- In compliance to the above, the RCCF, Berhampur Circle has reported that native species of the area shall be planted which has been mentioned in the CA scheme prepared earlier by the DFOs and technically approved by this office and has been furnished with the diversion proposal.

Condition No.(vi):- *The KML file of the area to be diverted and the CA area shall be uploaded on the e-Green watch portal with all requisite detail before issuing working permission towards linear projects or submitting compliance report for seeking Stage-II approval, as the case may be.*

Compliance:- In compliance to the above, the RCCF, Berhampur Circle has reported that the KML files of the area proposed to be diverted & CA area has already been uploaded on the e-green watch portal during submission of the proposal.

Condition No.(vii):- *The user agency shall transfer the cost of raising and maintaining the compensatory afforestation at the current wage rate in consultation with State Forest Department in the account of CAMPA of the concerned State through online portal. The Scheme may include appropriate provision for anticipated cost increases for works scheduled for subsequent years.*

Compliance:- In compliance to the above, the RCCF, Berhampur Circle has reported that the user agency has already transferred the total cost of CA through online portal in State CAMPA account amounting to Rs.1,35,45,700/- on dated 29.04.2022 and UTR No. UBINJ22119995765 pertaining to both Ghumsur (N) Division 20 ha and Boudh Division, over 40 ha as per the site specific CA scheme approved by this office vide this office memo No.3998 dated 02.03.2022 at the wage rate of 315/- per manday with 10 years maintenance cost,. Regarding proof of deposit amount the scheme approved by this office, the demand letter of the DFOs and deposit particulars made by the UA are enclosed as **Annexure-IV series**.

Condition No.(viii):- The Site Specific Wildlife Conservation Plan shall be prepared and duly approved by PCCF (WL) & CWLW, Odisha for implementation at the project cost. The site Specific Wildlife Conservation Plan shall include Elephant under passes at suitable location

Compliance:- In compliance to the above, the RCCF, Berhampur Circle has reported that the PCCF(Wild life) & Chief Wild Life Warden, Odisha, Bhubaneswar has approved the Site Specific Wildlife Conservation Plan with a total financial forecast of Rs.12,22,05,700/- pretending to the project impact area coming under three divisions namely Ghumsur (N), Phulbani, Boudh vide his Memo No.2333 dated 11.03.2022. Accordingly the user agency has deposited the total cost of Site Specific Wildlife Conservation Plan amounting to Rs.12,22,05,700/- only in Odisha State CAMPA account through NEFT/RTGS i.e. Union Bank of India, New Delhi A/c NO.150826131054505 dated 04.08.2022 vide challan generated 01.02.2022 and UTR No.UBINJ22216817844 dt.04.08.2022 as per the demand letters issued by the DFO, Ghumsur (N), Boudh, Phulbani Division which are enclosed as **Annexure V series**. Total site specific wild life conservation plan as per project impact area of the three divisions are as follows:-

Condition No.(ix):- All the funds received from the user agency under the project shall be transferred/ deposited in CAMPA account only through e-portal (<https://parivesh.nic.in>). Amount deposited through other mode will not be accepted as compliance of the Stage-I clearance.

Compliance:- In compliance to the above, the RCCF, Berhampur Circle has reported that the user agency has deposited all the compensatory levies in state CAMPA account through e-portal which has been confirmed by both the DFO, Phulbani & Ghumsur North Division by furnishing the 12 point CAMPA format duly authenticated by both of them which are enclosed as **Annexure-VI series**.

Condition No.(x):- *The cost of felling of trees shall be deposited by the user agency with the State Forest Department.*

Compliance:- In compliance to the above, the RCCF, Berhampur Circle has reported that the user agency has deposited the cost of felling of trees amounts to Rs.20,34,388/- in Phulbani RF & PRF area before the DM, OFDC Ltd., Boudh (C-KL) Division as per demand letter of the DM, Boudh (C-KL) Division and approved estimate for felling of trees issued by the GM, Berhampur(C) Zone vide RTGS No.P201220180795421 dated.20.07.2022. Further the user agency has also deposited the cost of felling of trees amounts to Rs.57,62,348/- in Gallery RF, Darapangia RF and Revenue Forest Land under Ghumsur (N) Division before the DM, OFDC Ltd. Bhanjanagar (C) Divn. as per demand letter issued by the DM, OFDC Ltd. Bhanjanagar (C) Divn. vide RTGS No.CNRBR52022-091990147884 dated 19.09.2022. Regarding proof of deposit of the above cost of felling of trees the demand letter of the DM, OFDC Ltd. concerned and the deposit particulars made by the UA are enclosed as **Annexure-VII series.**

Condition No.(xi):- *Wherever possible, maximum number of trees identified to be felled should be transplanted and shall ensure that any tree felling shall be done only when it is unavoidable and that too under strict supervision of the State Forest Department .*

Compliance: - In compliance to the above, the RCCF, Berhampur Circle has reported that no tree has been transplanted so far. The tree felling under both the division shall be carried out by the OFDC Ltd. organization under the respective division under the strict supervision of both the DFO Ghumsur (N) and Phulbani Division.

Condition No. (xii):- *The compliance report of the Stage-I approval shall be uploaded on e-portal (<https://parivesh.nic.in>)*

Compliance: - In compliance to the above, the RCCF, Berhampur Circle has reported that the compliance report of the stage-I approval has been uploaded in e-portal.

Condition No.(xiii):- *The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector.*

Compliance:- In compliance to the above, the RCCF, Berhampur Circle has reported that regarding diversion of 19.621 ha of forest land in this project under Ghumsur (N) Division FRA certificate to that effect has been issued by the Collector & Chairman DLC committee (FRA) Ganjam district vide his letter No.818 dt.03.10.2018. Similarly regarding diversion of 7.722 ha of forest land in this project under Phulbani Division FRA certificate to that effect has been issued by the Collector Kandhamal District, Phulbani vide his letter No.84 dt.16.01.2020. Both the FRA certificate issued by both the collectors have been enclosed as **Annexure VIII series.**

Condition No.(xiv):- *The boundary of the proposed forest land for diversion, shall be demarcated on ground at the project cost, by erecting four feet high reinforced cement concrete pillars, each inscribed with its serial number, distance from pillar to pillar and GPS co-ordinates,*

Compliance:- In compliance to the above, the RCCF, Berhampur Circle has reported that the boundary of the forest land proposed for diversion has already been demarcated on the ground at the project cost by erecting 4' high RCC pillars each inscribed with its Serial number, distance from pillar to pillar & GPS co-ordinates. In proof of such demarcation the detailed information regarding boundary pillar Serial number, distance from pillar to pillar & GPS co-ordinates with forward bearing & backward bearing etc. have been furnished by both the DFO Ghumsur (N) and Phulbani division which are enclosed as **Annexure-IX series.**

2. B. Conditions which need to be strictly complied on field after handing over of forest land to the user agency by the State Forest Department but the compliance in form of undertaking shall be submitted prior to Stage-II approval.

Condition No.(i):- *Legal status of forest land proposed for diversion shall remain unchanged.*

Compliance:- In compliance to the above, the RCCF, Berhampur Circle has reported that the user agency has furnished undertaking duly signed by both the DFO, Ghumsur (N) and Phulbani Forest Division to this effect which is enclosed as **Annexure-I.**

Condition No.(ii):- *Compensatory afforestation shall be raised over 60.00 ha degraded forest land identified in village Dharamnagar (40.00 ha revenue forest) under Boudh Forest Division and Jaganath Prasad RF (10 ha) & Tiliki RF (10 ha) under Ghumsur (North) Forest Division within three years from the date of Stage-II Clearance and maintained thereafter by the State Forest Department, at the cost of user agency. The species to be planted in the CA scheme shall be of native species of the area avoiding Teak and exotic species. At least 18 month old seedlings should be planted. The C.A. shall be raised @ 1000 plants per ha in the identified degraded forest land. Intensive monitoring of the plantation needs to be done and documented using Geo tagging so that the increase of canopy density and survival and growth of plantation can be evaluated at regular intervals.*

Compliance: - In compliance to the above, the RCCF, Berhampur Circle has reported that the user agency has furnished undertaking duly signed by both the DFO, Ghumsur (N) and Phulbani Forest Division to this effect which is enclosed as **Annexure-II.**

Condition No.(iii):- *At the time of payment of Net Present Value (NPV) at the then prevailing rate, the user agency shall furnish an undertaking to pay the additional amount of NPV, if so determined, as per the final decision of the Hon'ble Supreme Court of India.*

Compliance: - In compliance to the above, the RCCF, Berhampur Circle has reported that the user agency has furnished undertaking duly signed by the DFO, Ghumsur (N) and Phulbani Forest Division to this effect which is enclosed as **Annexure-III.**

Condition No.(iv):- *The user agency shall raise strip plantation on both sides and central verge of the road as per IRC norms*

Compliance: - In compliance to the above, the RCCF, Berhampur Circle has reported that the user agency has furnished undertaking duly signed by both the DFO, Ghumsur (N) and Phulbani Forest Division to this effect which is enclosed as **Annexure-IV**.

Condition No.(v):- *The user agency shall use fly ash for the road construction and for filling up of void created due to soil borrows which will be followed by compaction and spreading of top soil over it as per Fly Ash Notification No. S.O. 254 (E) dated 25.01.2016.*

Compliance: - In compliance to the above, the RCCF, Berhampur Circle has reported that the user agency has furnished undertaking duly signed by both the DFO, Ghumsur (N) and Phulbani Forest Division to this effect which is enclosed as **Annexure-V**.

Condition No.(vi):- *The user agency shall submit an undertaking to ensure that flanks of roads should be filled by transported soil and not with soil dug from the side of the roads.*

Compliance: - In compliance to the above, the RCCF, Berhampur Circle has reported that the user agency has furnished undertaking duly signed by both the DFO, Ghumsur (N) and Phulbani Forest Division to this effect which is enclosed as **Annexure-VI**.

Condition No.(vii):- *The designing of new culverts/bridges and redesigning the existing ones over the natural streams/ rivers/canals should be done in such a manner that it does not hamper the natural course of water, does not give rise to water-logging, so that it does not hamper movement of wild animals including fishes & amphibians migration..*

Compliance: - In compliance to the above, the RCCF, Berhampur Circle has reported that the user agency has furnished undertaking duly signed by both the DFO, Ghumsur (N) and Phulbani Forest Division to this effect which is enclosed as **Annexure-VII**.

Condition No.(viii):- *Speed regulating signage will be erected along the road at regular intervals in the Protected Areas/Forest Areas*

Compliance: - In compliance to the above, the RCCF, Berhampur Circle has reported that the user agency has furnished undertaking duly signed by both the DFO, Ghumsur (N) and Phulbani Forest Division to this effect which is enclosed as **Annexure-VIII**.

Condition No.(ix):- *The user agency shall obtain Environment Clearance as per the provisions of the Environmental (Protection) Act, 1986, if applicable.*

Compliance: - In compliance to the above, the RCCF, Berhampur Circle has reported that the user agency has furnished undertaking duly signed by both the DFO, Ghumsur (N) and Phulbani Forest Division to this effect which is enclosed as **Annexure-IX**.

Condition No.(x):- *No labour camp shall be established on the forest land and the user agency shall provide fuels preferably alternate fuels to the labourers and the staff working at the site so as to avoid any damage and pressure on the nearby forest areas.*

Compliance: - In compliance to the above, the RCCF, Berhampur Circle has reported that the user agency has furnished undertaking duly signed by both the DFO, Ghumsur (N) and Phulbani Forest Division to this effect which is enclosed as **Annexure-X**.

Condition No.(xi):- *No additional or new path will be constructed inside the forest area for any activity related to the project work.*

Compliance: - In compliance to the above, the RCCF, Berhampur Circle has reported that the user agency has furnished undertaking duly signed by both the DFO, Ghumsur (N) and Phulbani Forest Division to this effect which is enclosed as **Annexure-XI**.

Condition No.(xii):- *The user agency while executing works, shall not fell any tree or damage forest growth in the surrounding forest area in any manner.*

Compliance: - In compliance to the above, the RCCF, Berhampur Circle has reported that the user agency has furnished undertaking duly signed by both the DFO, Ghumsur (N) and Phulbani Forest Division to this effect which is enclosed as **Annexure-XII**.

Condition No.(xiii):- *The layout plan of the proposed forest land shall not be changed without the prior approval of Ministry of Environment, Forest & Climate Change.*

Compliance: - In compliance to the above, the RCCF, Berhampur Circle has reported that the user agency has furnished undertaking duly signed by both the DFO, Ghumsur (N) and Phulbani Forest Division to this effect which is enclosed as **Annexure-XIII**.

Condition No.(xiv):- *The forest land shall not be used for any purpose other than that specified in the proposal.*

Compliance: - In compliance to the above, the RCCF, Berhampur Circle has reported that the user agency has furnished undertaking duly signed by both the DFO, Ghumsur (N) and Phulbani Forest Division to this effect which is enclosed as **Annexure-XIV**.

Condition No.(xv):- *The forest land proposed to be diverted shall under no circumstances be transferred to any other user agency, department or person without the prior approval of Ministry of Environment, Forest & Climate Change.*

Compliance: - In compliance to the above, the RCCF, Berhampur Circle has reported that the user agency has furnished undertaking duly signed by both the DFO, Ghumsur (N) and Phulbani Forest Division to this effect which is enclosed as **Annexure-XV**.

Condition No.(xvi):- *No damage to the flora and fauna of the adjoining area shall be caused.*

Compliance: - In compliance to the above, the RCCF, Berhampur Circle has reported that the user agency has furnished undertaking duly signed by both the DFO, Ghumsur (N) and Phulbani Forest Division to this effect which is enclosed as **Annexure-XVI**.

Condition No.(xvii):- *The concerned Divisional Forest Officer, will monitor and take necessary mitigative measures to ensure that there is no adverse impact on the forests in the surrounding area,*

Compliance: - In compliance to the above, the RCCF, Berhampur Circle has reported that the user agency has furnished undertaking duly signed by both the DFO, Ghumsur (N) and Phulbani Forest Division to this effect which is enclosed as **Annexure-XVII**.

Condition No.(xviii):- *The user agency shall submit annual self monitoring report on compliance of stipulated conditions to the Nodal Officer (FCA) of the State and concerned Integrated Regional Office of this Ministry by the end of March every year.*

Compliance: - In compliance to the above, the RCCF, Berhampur Circle has reported that the user agency has furnished undertaking duly signed by both the DFO, Ghumsur (N) and Phulbani Forest Division to this effect which is enclosed as **Annexure-XVIII**.

Condition No.(xix):- *Any other conditions that the Ministry of Environment, Forests & Climate Change may impose from time to time in the interest of afforestation, conservation and management of flora and fauna in the area, shall be complied by the user agency.*

Compliance:- In compliance to the above, the RCCF, Berhampur Circle has reported that the user agency has furnished undertaking duly signed by both the DFO, Ghumsur (N) and Phulbani Forest Division to this effect which is enclosed as **Annexure-XIX**.

Condition No.(xx):- *The State Govt. and user agency shall ensure compliance to provisions of the all Acts, Rules, Regulations, Guidelines, NGT Order (s) & Hon'ble Court Order (s) pertaining to this project, if any, for the time being in force, as applicable to the project.*

Compliance: - In compliance to the above, the RCCF, Berhampur Circle has reported that the user agency has furnished undertaking duly signed by both the DFO, Ghumsur (N) and Phulbani Forest Division to this effect which is enclosed as **Annexure-XX**.

3. *Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as prescribed in Para 1.21 of Chapter 1 of the Handbook of comprehensive guidelines of Forest (Conservation) Act, 1980 as issued by this Ministry's letter No. 5-2/1027-FC dated 28.03.2019.*

Compliance: - In compliance to the above, the RCCF, Berhampur Circle has reported that the user agency has furnished undertaking as per the above stipulated condition duly signed by both the DFO, Ghumsur (N) and Phulbani Forest Division to this effect which is enclosed as **Annexure-3**.
